Crosswalks for Social Studies TEKS

The State Board of Education (SBOE) adopted revisions in 2022 to the social studies TEKS that reflect the requirements of Senate Bill 3 from the 87th Texas Legislature, 2nd Called Session, 2021. The revisions update the standards for Kindergarten–Grade 8 and five high school courses. The grade level/course crosswalks provide a summary (example below) of the TEKS revisions and show the differences between the 2018 TEKS and the 2022 TEKS that are to be implemented in the 2024-2025 school year. WORLD HISTORY STUDIES, CROSSWALK FROM 2018 TEKS to 2022 TEKS IMPLEMENTED IN 2024-2025 World History Studies, TEKS Revisions Implemented in 2024-2025 School Year The State Board of Education (SBOE) adopted revisions in 2022 to the social studies TEKS that align with legislative requirements passed in the 87th Legislature. The revisions update the standards for Kindergarten- Grade 8 and five high-school courses. The student is expected to: (D) evaluate a variety of historical and contemporary sources for validity, credibility, bias, and accuracy (F) formulate and communicate visually, or ally, or in writing a claim supported by evidence and reasoning for an intended audience and purpose Renumbered Standards for Implementation in the 2024-2025 School Year (31) Social studies skills. The student uses problem-solving and decision-making skills, working independently and with others. The student is expected to: (B) use problem-solving and decision-making processes to identify a problem, gather information, list and consider options, consider advantages and disadvantages, choose and implement a solution, and evaluate the effectiveness of the solution

This edition's timely topic focuses on Texas history and women's history in recognition of events throughout Texas' history and in honor of those Texan men and women who have helped shape the history of Texas.

Question: "Where can I find some resources to support the teaching of Texas history and women's history?"

<u>The Texas Women's Hall of Fame</u> housed at Texas Woman's University features the <u>biographies</u> and photographs of the more than 100 pioneering women who have left their mark on our great state.

<u>The Bullock Museum</u>, a division of the State Preservation Board, provides resources to gain content knowledge or to create activities for your students to take a deeper dive into Texas history. <u>The Texas Historical Commission</u> (THC) is the state agency for historic preservation and provides free, downloadable resources for K-12 students and teachers.

<u>The Portal to Texas History</u> is a digital gateway to rare, historical, and primary source materials from or about Texas created and maintained by the University of North Texas Libraries.

Civic Learning Week: A Conversation with U.S. Supreme Court Justices Amy Coney Barrett and Sonia Sotomayor

Now in its second year as a nationwide event, Civic Learning Week brings together students, educators, and policymakers to energize civic education across the nation. The week includes online and in-person events that focus on the civics knowledge and skills that can sustain and strengthen constitutional democracy and build civil discourse and understanding.

On Tuesday, March 12, at 12 noon (CT), U.S. Supreme Court Justices Sonia Sotomayor and Amy Coney Barrett will participate in a moderated conversation that will showcase their shared commitment to high-quality civic education and address student questions about the judicial system and civic engagement. The discussion will highlight civics education, knowledge, and skills, and why civics is essential to sustaining and strengthening constitutional democracy in the United States.



Apply for Assessment Educator Committees

Each year the Texas Education Agency (TEA) invites Texas educators to provide feedback on the development of state assessments (STAAR, STAAR Alternate 2, and TELPAS) through educator committees across all assessed grades and content areas. Developing high-quality, aligned questions relies on the expertise and experience of Texas educators. Participants collaborate with other educators from across the state to review, edit, and approve each potential question for state assessments. TEA is specifically looking for educators from your region!

The commitment is generally two to three days in Austin with all travel, accommodations, and substitute coverage paid for by TEA. All participants will earn Continuing Professional Education credits. Updated Innovative Course Application Timeline

To benefit both innovative course applicants and LEAs (local education agencies) who wish to implement innovative courses, the timeline for future innovative course application cycles has been updated. The updated timeline is designed to provide additional time for the following:

- Applicants to complete applications
- Applicants to receive local board approval
- Applicants to complete course pilots and analyze data
- Districts and open-enrollment charters to plan for innovative course implementation

Courses that are approved will be available for implementation beginning with the 2025-2026 school year.

The Texas Virtual School Network (TXVSN) Can Help Meet Students' Social Studies Course Needs



Need help meeting a student's social studies course needs?

The <u>Texas Virtual School Network (TXVSN</u>) can help meet students' needs through TEA-approved online courses. The TXVSN statewide course catalog provides schools and students access to high school, Advanced Placement, career and technical education, and dual credit courses for initial credit or credit recovery. The <u>course catalog</u> provides fifteen unique social studies courses to help students meet their learning goals and graduation requirements.

The TXVSN courses are aligned to the Texas Essential Knowledge and Skills (TEKS) and taught by Texas certified teachers trained in best practices in online instruction. Schools can use the TXVSN courses to create flexibility in a student's schedule, allow a student to accelerate their learning, or address local teacher shortages. Students enrolled in a TXVSN course can generate funding regardless of whether the student is physically present at school while participating in the course.
