# Program Requirements Selected



Documenting overall compliance for a program requirement may require several forms of documentation to be maintained locally and available upon request by TEA and/or an auditor.

# Program Requirements Selected



To ensure overall compliance with program requirements, LEAs should refer to the Program Guide and/or other program-related resources that reference the multiple forms of documentation required to be maintained locally.

# Program Requirements Selected



The documentation requested for submission during the random validation process may not include all forms of documentation that are required to be maintained locally.

**Documentation for virtual meetings is acceptable.**



Given the increased use of virtual meeting environments, participant rosters that include the meeting title, meeting date, and stakeholder names and roles would be acceptable substitutes for the more traditional sign-in sheets. This eliminates the need of a participant signature.

# ESSA Statutory Requirement – Title I, Part A PNP Equitable Services Amounts

## Title I, Part A Program

### Section 1117(a)(4)(A)

4. Expenditures.—

(A) Determination.—

i. In General.—Expenditures for educational services and other benefits to eligible private school children shall be equal to the proportion of funds allocated to participating school attendance areas based on the number of children from low-income families who attend private schools.

ii. Proportional Share.—The proportional share of funds shall be determined based on the total amount of funds received by the local educational agency under this part prior to any allowable expenditures or transfers by the local educational agency.



# ESSA Statutory Requirement – Title VIII PNP Equitable Services Amounts

## Title VIII Programs

### Section 8501(a)(4)(A-B)

#### 4. Expenditures.

##### In General.—

A. Expenditures for educational services and other benefits provided under this section for eligible private school children, their teachers, and other educational personnel serving those children shall be equal, taking into account the number and educational needs of the children to be served, to the expenditures for participating public school children.

B. Obligation of Funds.—Funds allocated to a local educational agency for educational services and other benefits to eligible private school children shall be obligated in the fiscal year for which the funds are received by the agency.

## Assurances Relating to Title I, Part A Program

- The size and scope of the equitable services to be provided to the eligible private school children, the proportion of funds that is allocated for such services, and how that proportion of funds is determined. [Page 19, #9(E)]
- The LEA assures it will keep documentation of program descriptions, allowable activities, and expenditures locally and make available upon TEA request for all applicable private non-profit requirements in Sections 1117 and 8501. TEA may request a description of services and use-of-funds documentation later through compliance reports or other TEA reports. [Pages 21, #22]

## Assurances Relating to Title VIII Programs

The LEA will comply with the uniform provisions for providing services to private schools as specified in [Title VIII, Part F, Subpart 1, Private Schools, Sections 8501-8504.](#)

# Documentation Required— LEAs PNP Equitable Services Amounts

## **Documentation Required**

## **Acceptable Documentation**

- Documentation LEA informed PNP officials of fiscal requirements that include equitable services amounts **for 1 participating private school campus** (i.e., agenda, meeting minutes, LEA program summaries, timeline of professional development travel and PNP purchase requests, calendar of program services with equitable services amounts, or other documentation meeting requirement); or
- Documentation LEA shared calculated equitable services amounts by program **for 1 participating PNP school campus** (i.e., LEA calculations by PNP campus and program level, calculation formulas per PNP campus, etc.); or
- Written procedures and documentation that provided verification/tracked LEA PNP purchases that include equitable services amounts **for 1 participating private school campus**

# PNP Equitable Services Amounts

## ***Documentation Required –***

Written documentation of LEA equitable services amounts



## ***Issues that may result in an “Improvement Needed” status***

- Auditable documentation requested was not submitted
- Documentation submitted does not reference equitable services amounts for participating program(s)
- Documentation submitted does not verify LEA tracked purchases per participating PNP school
