

Priority For Service (PFS)



Title I, Part C Program Requirement

Priority for Service (PFS)

The LEA gives service priority to migratory children who made a qualifying move within the previous 1-year period and who were (1) failing or most at risk of failing to meet the challenging State academic standards; or (2) have dropped out of school. [Sections 1301(2), 1304(d)]



Documentation Required

1.1 PFS Reports from TX-NGS

Acceptable Documentation

- Copies of two monthly PFS Reports redacting student identifiable information
- Reports showing "No students found" is acceptable.



Documentation Required - Priority For Service (PFS) Item 1.1

Copies of two monthly PFS Reports from the prior school year redacting student identifiable information

Reports showing "No students found" is acceptable.





- Auditable documentation requested was not submitted.
- Documentation submitted does not reference the PFS Criteria.
- Reports submitted were not run during the prior school year.

Plan

Acceptable Documentation

Copy of the district PFS Action Plan



Documentation Required – Priority For Service (PFS) Item 1.2

Copy of the district PFS Action Plan for the prior school year





- Auditable documentation requested was not submitted.

- Documentation submitted does not include detailed activities.
- Documentation submitted was not for activities that took place in the prior year.
