The Education and Training program has been a robust addition to Birdville's CTE course offerings for nearly 20 years. The district has hired numerous graduates from the program as both teachers and educational assistants. Recently, the district supported an Education & Training teacher at each of the three high schools. However, since the Covid pandemic, enrollment in the program has declined. The requests for these courses next year have fallen to 29 students in Instructional Practices and 12 students in Education & Training Practicum. The district maintains a strong pipeline, with 33 students signing up for the Principles of Education & Training class. As a result, the district plans to consolidate these courses and move them to one teacher, who will be located at the career and technology campus. Birdville ISD will utilize the Grow Your Own Grant to supplement funding and increase enrollment in this special program. Further, Birdville ISD is engaging in an memorandum of understanding (MOU) with Tarleton University to offer the Instructional Practices course as dual credit, with additional courses added over the next few years. The grant funds will enable us to honor the work of our teacher by providing a stipend to acknowledge her work both in the classroom and with the CTSO, TAFE.

This year will be a consolidation and rebuilding year, in which all new and existing students in the program will be moved to the centrally located career and technology campus. The Education and Training teacher, assisted by the CTE Coordinator who oversees the program, will administer the grant throughout the funding period. The coordinator works with the district's business office to distribute the funds in a correct and timely manner. The funds will be provided to not only the teacher, in the form of a stipend, but also to the transportation department, to defray the cost of transporting the students to the various campuses. Additionally, the coordinator will assist with the implementation of the provided curriculum, attend any training with the teacher, and provide any and all feedback required by the grant providers. The district CTE office supports the recruitment efforts for this program. Teachers are invited to promote directly to all grade 9 and 10 students every year, while grade 8 students tour the CTE campus to learn about the programs, and the Education and Training teacher visits each of the middle school campuses to meet directly with students taking the College and Careers course, to explain the pogram and answer questions. The CTE Coordinator is an experience administrator in the district, having worked as a teacher, academic dean, assistant principal, and CTE Coordinator, with over 20 years of experience.

The district will consolidate the program with one teacher, who started the program in 2002. She has a masters degree and over 20 years of teaching. Her students have found success in the teaching profession as well as received a variety of accolades from the TAFE, TASSP, and Educators Rising organizations.

Based on the previous success of this program, the district relies on the synergy created by multiple teachers, who can share the challenges of placing, monitoring, and advising students, as well as preparing them for community and CTSO events. Further, increasing the numbers of students participating will help the district meet future goals of placing teachers in classrooms.

This year, Birdville has 8 students advancing to the national contest. The funds will also support the transportation of students in both the practicum and instructional practices courses to be brought to one of the district's 20 elementary campuses for hands-on experiences. As the number of our high school students involved in this program increases, so does the number of cooperating teachers. This network of teachers and students has been a powerful magnet to increase future student participation. Additionally, the campuses have the opportunity to get to know potential teaching campuses while onboarding them into the teaching and the professional learning tenets of the district. This or course is crucial to ensuring that new teachers are prepared to face the demands of today's classroom to assist students to excel both academically and behaviorally.



The plan must include strategies to equitably recruit diverse individuals and identify individuals with potential criteria including a demonstrated track record of success and/or achievement, involvement in student organizations and/or school activities, strong evaluation ratings, and strong relationships with students.

For nearly two decades, the Education and Training program has been a significant part of Birdville's Career and Technical Education (CTE) offerings. The district has hired many program graduates as teachers and educational assistants. However, since the onset of the Covid pandemic, enrollment in the program has dropped. Next year, only 29 students have signed up for Instructional Practices and 12 for Education & Training Practicum. Despite this, there is still interest, with 33 students enrolling in the Principles of Education & Training class. To adapt, the district plans to consolidate these courses under one teacher, based at the career and technology campus. Birdville ISD will use the Grow Your Own Grant to boost funding and enrollment in this program. Additionally, Birdville ISD is partnering with Tarleton University to offer the Instructional Practices course as dual credit, with more courses planned in the coming years. The grant will also provide a stipend to recognize the teacher's efforts in the classroom and with TAFE, a CTSO. Furthermore, funds will support transporting students to elementary campuses for hands-on experiences and aid in recruiting efforts. As student participation grows, so does the network of cooperating teachers, which benefits both students and campuses. This cycle helps new teachers become better prepared to meet the challenges of today's classrooms and support student success academically and behaviorally.

2. Program Implementation Support: Describe the types of support that will be provided to Education and Training teacher stipend recipients to ensure successful implementation of the curriculum and program. The definition of successful programming should align with the major goals/objectives of the program.

This year marks a period of consolidation and rebuilding for our program. All new and existing students will be relocated to the centrally located career and technology campus. The Education and Training teacher, supported by the CTE Coordinator who oversees the program, will manage the grant throughout its duration. The coordinator will aid in implementing the curriculum provided, attend training sessions alongside the teacher, and furnish necessary feedback as required by the grant providers. The district's CTE office actively supports recruitment efforts for the program. Teachers engage directly with all 9th and 10th-grade students annually, while 8th graders tour the CTE campus to familiarize themselves with the programs. Additionally, the Education and Training teacher visits each middle school campus to meet students enrolled in the College and Careers course, explaining the program and addressing any inquiries. The program will be consolidated under one teacher, who initiated it in 2002. With a master's degree and over two decades of teaching experience, she has facilitated numerous successes among her students, who have received accolades from organizations such as TAFE, TASSP, and Educators Rising.
