Clint Independent School District is innovating and recognizes the need to connect students to a rich and comprehensive Grow Your Own program that is aimed at providing a pipeline for high school students to become certified to enter a full-time teaching profession. Clint ISD has a population that is 68% atrisk, 41% emergent bilingual, 94% Hispanic, 87% economically disadvantaged. Students are college ready in reading and math at 49%. Our GYO program will address teacher shortages by minimizing the financial, recruitment, and preparation challenges facing our current educator workforce.

The grant will allow high school students the opportunity to enroll in an apprenticeship starting at age 16 and earn dual-credit by taking a sequence of Education and Training courses through our local EI Paso Community College. Additionally, students will have the opportunity to attain the industry-based certification, Educational Aide I certificate. By doing this, we will continue to strengthen professional pathways so current high school students can become and remain teachers here at Clint ISD.

Through this grant, Clint ISD aims to expand our existing high-quality education and training program to 1) increase the number of CTE completers; 2) increase in participation and performance of taking and passing dual credit courses; and 3) increase in number of non-traditional students enrolled in the Education and Training program of study.

The goal of the Miner Teacher Residency is to prepare the highest-quality teachers who are Day 1-ready to meet the needs of culturally, linguistically and economically diverse learners and to provide rigorous, high-quality learning experiences for all students. Teacher residents are placed in our partnering elementary and middle school classrooms alongside selected and trained Mentor Teachers. This program allows teacher residents a full year of hands-on clinical preparation. Through this grant, our district goal is to collaborate with UTEP and simulate the alignment of the Miner Teacher Residency to our Education and Training (GYO) initiative.

Recruitment - Support in selecting the Education and Training program will begin in the 8th grade level as students complete the College and Career Readiness course. Recruitment of Hispanic, at-risk, and non-traditional students, as males, who have expressed interest in the education field through their high school endorsement. Public Service, will be a focus for recruitment.

Counselor Guidance - High school counselors will provide student guidance on dual-credit courses and the coherent sequence aligned to the Education and Training program of study.

Career Guidance - High school counselors will provide information as early as junior year of potential community colleges and universities.

Internships - Opportunity for internships through work-based learning. High school students assist teachers at neighboring elementary or middle schools through the practicum course. The interns might tutor younger students, assist teachers in creating lesson plans, help with preparation materials, and mentor incoming interns.

Mentorship - Clint ISD teachers will nurture the student's interest in becoming a teacher through mentoring and providing support in transiting from high school to college/university and finally the teaching profession.

Building Awareness - The department of Human Resources will provide seniors an in depth presentation on the process to apply for a position as a substitute, paraprofessional, and a teacher.

LEA's approach is to 1) provide a high-quality education and training program for high school students, particularly Hispanic, at-risk, and non-traditional to be exposed to the teaching profession through work-based learning experiences within our community 2) support students who see teaching as a desirable and attainable career option; 3) address teacher shortages by increasing the number of new hires from the student cohorts who complete the GYO/Education and Training program here at Clint ISD.

D. Performance and Evaluation Measures

Student Success Measure:

All in coming cohort classes will have 15-20 students. The program will retain 90% of their students. Students and parents will sign a contract prior to any work-based learning and/or internship. Student academic performance will be monitored once every grading period (3wk, 6wk, 9wk) and provide intervention as needed.

Ninety percent of the students will enroll in two dual credit courses per school year with an 85% success passing rate.

The rate of students participating in the internship during their senior year is 95% and 90% of those seniors will attain their industry-based certification, the Educational Aide I certificate.

Data will be pulled from our Student Information System (SIS) - Skyward. Additional data talks will be conducted at the campus team meetings. Data shared will be documented in the meeting minutes.




