Hamshire-Fannett ISD is a small, rural school in West Jefferson County, Texas. The district lies within the boundaries of Education Service Center 5 in Beaumont. The district is one of the lowest paid in the region. Therefore, being rural and having low pay pose significant barriers in recruiting and hiring teachers. The district can often retain teachers because of the family-like culture in the district. In recent years, many of the newer, uncertified teachers have left before finishing the certification process. In partnering with Lamar University, Region 5 ESC, and USPREP, the district believes having access to teacher residents, effectively training host teachers, and exceptionally preparing residents will serve as a way of recruiting and hiring well-prepared teachers that will stay with the district long-term.
