Focus Area 1-Education Service Center Region 19 (ESC R19) in collaboration with its Shared Services Agreement (SSA) member districts would highly benefit from funding for a summer bridge program for middle and high school students known as iBuild El Paso Summer Program. ESC R19 and its ,SSA rural districts, plan on collaborating with larger urban districts such as Socorro ISD, Ysleta ISD, and Tornillo ISD to share resources and create opportunities for students throughout the entire region. As per TEA district classifications, three of our four SSA member districts are classified as rural: Anthony ISD, Ft. Hancock ISD, and Sierra Blanca ISD. None of these three SSA rural districts have been able to offer architecture & construction CTE programs of study for students without the funding from this grant. Through this strategic partnership that includes ESC R19, districts, community partners, and Institutions of Higher Education (IHE) partners, we can ensure increased opportunities for students. The iBuild El Paso Summer Program is based on the latest Workforce Solutions Borderplex 2022 Target Occupations List. Construction is a "Hot Jobs" area as over 10 occupations are identified for growth and high-wage including Construction Managers, Civil Engineers, Property Real Estate & Community Associate Managers, Security & Fire Alarm Installers, Construction & Building Inspectors, Plumbers, Cement Masons, and various other employment sectors where architecture & construction can prove to be a rewarding filed of study for students seeking lucrative career prospects in the hometown. High school students will take a course at EPCC OSHT 1305 OSHA Regulations- Construction Industry, a workforce course for dual credit leading to several Associate of Applied Science areas to include a certificate in Renewable Energy. Middle school students will be taking Principles of Architecture / Construction Course.

Focus Area 2-The overall mission of the iBuild El Paso Summer Program is to create exploration opportunities for middle school students and meaningful hands-on opportunities for high school students during the summer term in the area of architecture & construction via partnerships with other districts, El Paso Community College (EPCC), and industry partnerships such as Jordan Foster Construction and MNK Architects, Inc. A cohort of seventh and eight grade students will be invited to learn live at a construction site with the help of Occupational Safety and Health Administration (OSHA) trainers employed by Jordan Foster Construction. High school students will also participate in an internship opportunity with our industry partners where they will make connections to their OSHT 1305 class. The 2022 iBuild El Paso Summer Program will help make connections for students within HVAC and Electrical occupations to the importance of Architecture degrees leading to post-secondary studies in Civil Engineering and Construction Management.

Goals, Objectives, and Strategies

Focus Areas 1 & 2- The major goals and objectives of the proposed program is to increase student interested and participation in architecture & construction as a target occupation in the El Paso region. The 2022 iBuild El Paso Summer Program is expected to be able to fund a cohort of 40-45 middle school and 40-45 high school students with expanding opportunities and cohorts as the program moves forward. Being able to engage young women in architecture & construction is of special importance with a goal of having equal participation of about 50% female and 50% male in the Summer Bridge. Nationwide, gender inequity persists in architecture careers, particularly after graduation. According to recent news, female and minority architects and designers earn lower salaries than their peers and are less likely to hold positions of leadership; mothers in particular, lose out on career and salary advancements; and firms have been slow to follow best practices regarding equity and worker well-being. Women are underrepresented in architecture, not only at the top of the field, but at all levels of practice. In recent years, only 31% of full- or part-time faculty members in architecture have been women. Even as women participation increases, they've mostly done so at lower rungs of both academia and the profession. We have a lot of work to do in educating young girls for both interest and empowerment to aspire and pursue longevity and leadership in this field. Construction paints an even bleaker environment for women. Just 9.1% of America's construction workers are women. However, as per The National Association of Women in Construction, women earn on average 95.7% of what their male counterparts make compared with the average 82% women earn as compared to their male counterparts across industries, indicating the potential for better salary prospects for women in the industry.

Focus Area 2- The iBuild El Paso Summer Program will deploy different activities and objectives for middle school and high school students according to their trajectory through the Work-Based Learning Framework (WBL) and continuum. The pillars for WBL success and performance measures will be addressed tied to student outcomes as per the following: Engagement with local development board and employers; Local Development Board (WSB) was consulted for advise and data regarding industry and employer alignment for this project; WSB provides letter of support to continue to inform program improvement and deployment of relevant regional career information for both educators and students; Jordan Foster Construction and MNK Architects, Inc. engage as key industry partners for the iBuild El Paso Summer Bridge Program. WBL opportunities aligned to regional labor market information and opportunities; iBuild El Paso Summer Bridge Program aligned to 2022 Target Occupations List; Local Development Board (WSB) provides continuous reports to include the 2022 Target Occupations List used to examine and determine the selection of architecture & construction as an area of need for a summer bridge program and increased CTE opportunities for students. Focus Area 1- CTE workforce dual credit will be awarded that is aligned with EPCC with a focus on OSHA 30 Hour Construction Certification for students through OSHT 1305 OSHA regulations; construction industry summer course; certification found in accountability list of approved certifications as well as support for the architecture & construction career cluster/-Student selection and enrollment in architecture & construction programs of study will be monitored and tracked/-Participating districts commit to availability of architecture & construction programs of study for students of districts where such programs are unavailable/-Short evaluations for students, educators, and participating employers to evaluate what worked and did not work for program improvement/- Monitor and tracking of student cohorts into postsecondary education for success in architecture & construction programs/- Monitoring of cohort in mathematics courses, EOC testing, and college entrance exams such as TSIA as iBuild El Paso Summer Bridge Program will include reinforcement of core mathematics concepts/- Monitoring of cohort in English courses, EOC testing, and college entrance exams such as TSIA as iBuild El Paso Summer Bridge Program will include reinforcement of core reading & writing concepts.

Focus Area 1-ESC R19 has consultants that can deliver both professional development for teachers and other educators as well as teach lessons and deliver coursework for students. With many years of experience in the classroom, ESC R19 consultants have been trained on Geometry in Construction, mathematics for basic engineering courses, computer science, and many other areas directly related to academic skills as related to architecture and construction programs. The proposed budget will allow us to be able to fund their work with supplies for the program and any materials that they may need to deploy the program to students. Curriculum and lesson plans from this program will be implemented throughout the iBuild El Paso Summer Bridge Program for middle school students to introduce construction contextual skills as well as to introduce and reinforce geometry concepts for success in future high school mathematics courses. Additionally, we intend to use the proposed budget to help defray the costs of college courses by helping to support payment for an instructor in the summer and open courses to be taught in the summer specifically for this project. We intend to help students with college textbook costs as well as the associated costs of OSHA training and certification. Focus Area 2- The budget intends to subsidize costs of student travel through grant funds as well as established relationships. As the fiscal agent for all the Head Start program in El Paso, ESC R19 does not use most of its Head Start buses during the summer and would be willing to use the buses for Summer iBuild El Paso Summer Program transportation. This would allow us to keep transportation costs low and be able to serve more students who may be traveling from districts outside of the city limits. It is additionally important for us to be able to help subsidize some of the costs that our business & industry partners may have to incur. We want to ensure that students are not only able to have transportation to their summer courses, but also to their WBL sites. Materials, supplies, and uniforms are also going to be required at their WBL sites, and the budget is intended to be able to help business & industry partners provide this for students. Focus Area 1 & 2-ESC R19 is willing to provide in-kind support through coordination and availability of consultants for the Program. In addition, we want to ensure that this program is known throughout our community and that we showcase the commitment to education by our business and industry partners. For this reason, ESC R19 is committed to support with inkind marketing efforts. We will be using our in-house media services department to take pictures and footage of the program, promote on the ESC R19 website, and through our social media channels. Additionally, we would like to have an honorary celebration at the end of the 2020 Summer Bridge Program to recognize and thank our partners and celebrate distinguished students.

ESC R19 has experience coordinating, working, and running other summer programs in the past such as the ESC R19 Annual Summer TSIA Bootcamp for Migrant Students now in its fifth year of operation since inception in 2015. Middle school and high school students throughout Region 19 come to the Service Center every summer to engage in a 2-week intense Summer Camp opportunity to prepare for the TSIA exam. A diagnostic tool is used called Shmoop to pre-test and prepare. Students are then grouped by levels and provided with targeted interventions for success. At the end of the Camp, middle school students are tested in Reading, while high school students are tested in all areas. This past summer, only four migrant students did not meet the college readiness benchmarks of the reading exam. This is great news for students who are in need of targeted supports in language and are a testament to the commitment of the Service Center to student success. Enrichment activities are also provided for students, such as forensic science, biology activities, and art classes taught by EPCC instructors. ESC R19 works with both grant funds and district funds to coordinate and host the Camp. ESC R19 is accustomed to making adjustments and accommodations within the budget by being resourceful and using the generous in-kind support from its partners.

ESC R19 intends in growing this Program each summer to offer more EPCC courses for students and provide different WBL opportunities for students. With a growing program, in-kind relationships and adjustments for Program improvement are vital to its sustainability. Aside from the already successful TSIA Bootcamp for Migrant Students, ESC R19 intends on having iBuild El Paso Summer Program as a signature CTE support program for students and the community. Region 19 is committed to supporting this valuable opportunity to meet the needs of a growing job sector of the regional economy. ESC R19 and its partners are further committed to make adjustments to this program based on local labor market demand.

The iBuild El Paso Summer Program is intended to focus on the architecture & construction career cluster. Within this career cluster, students of both middle school and high school, middle school students in particular, will be exposed to the interconnectedness of the programs of study and regional job opportunities within this career cluster. Middle school students will be taking the Principles of Construction course this summer taught by our mathematics consultant who is a certified mathematics and computer science teacher with a strong background in engineering. If we are able to continue the Program into the future, next Summer 2023, we would like to extend middle school students the opportunity to take Principles of Architecture as well.

High school students will be engaged in EPCC college courses during the summer. Summer 2022 is intended for students to take Building Maintenance Technology I under the construction management and inspection program of study. In preparation for the Summer Program, ESC R19 will work with EPCC and construction teachers at partner districts to articulate the content of the course with EPCC course OSHT 1305 OSHA Regulations-Construction Industry and develop course crosswalks to line up EPCC course objectives and high school TEKS so that students are able to obtain both high school and college credit. ESC R19 has experience working in crosswalk alignment having worked on HVAC and sheet metal program of study courses with a local technical college. Summer 2022 for high school students would be geared at expanding further crosswalk articulation and alignment to the architectural design program of study course in computer aided drafting for architecture articulated to EPCC course DFTG 1309 Basic-Computer Aided Design. The EPCC course discussed are housed under the Advanced Technology Center at EPCC offering cutting edge workforce readiness courses, certificates, and degrees, in areas from advanced manufacturing to HVAC, welding, and renewal energy technology. The application materials include a copy of the Dual Credit Agreement between Anthony ISD and EPCC. A copy of this agreement exists and is employed by all districts applying through this grant application, allowing for a smooth and seamless process when transcribing courses between entities and on student transcripts.
