MISSION. The Arlington Independent School District (AISD), located between Dallas and Fort Worth, is the 13th largest school district in Texas and serves 59,453 students from PK-12 (TEA, Snapshot 2020). The AISD mission is to empower and engage all students to be contributing, responsible citizens striving for their maximum potential through relevant, innovative, and rigorous learning experiences. Through the Career & Technical Education (CTE) Department, AISD offers an enhanced educational system that prepares students for the future. The CTE Department oversees curriculum development and implementation, instructional resources, student identification, & staff development for the CTE program.

NEEDS. Based on AISD's Needs Assessment Summary and an evaluation of students' completion of courses within programs of study, AISD determined that over the past few years there has been a decrease in Junior High (JH) Career Investigations classes and a decline in the number of students enrolling in CTE programs overall. Students and junior high teachers have expressed the need for real world/hands-on experiences so students can better understand their career and pathway options.

2022-23 AISD CTE SUMMER PROGRAM- Learn about career opportunities & post-secondary education.

AISD promotes the development, implementation, and adoption of programs of study aligned with state identified high skill, highwage, in-demand occupations, or industries. Students have the opportunity to explore pathways during junior high to determine which endorsement/program of study they want to explore in high school and in their post-secondary options. The 2022-23 Summer Program directly connects to AISD's mission of creating relevant learning experiences for students and grant FOCUS AREA 1 to increase awareness, enthusiasm, and enrollment in these CTE programs of study.

The grant-funded summer program will help address the needs by providing JH students with opportunities and experiences to make informed decisions, better understand career/education pathways, & help close gaps related to offering CTE courses and the Career Investigations class. The CTE Department will host a 4-day Career Exploration Career Camp for incoming 7th & 8th grade students, to support the exploration of various career opportunities and help them align interests with available pathways. CTE and the Guidance/Counseling Dept will collaborate to create lessons that guide informed decision-making.

Goals, Objectives, and Strategies (Focus Area 1)

GOAL. The major goal of the 2022-23 AISD CTE Summer Camp is to implement a high-quality CTE Summer Program for 7th & 8th grade students, and create opportunities & experiences that help them better understand approved statewide CTE Programs of Study/9 Career Clusters. They will gain knowledge of career opportunities & skills needed for pathways in order to make informed decisions, and enroll in CTE Career Investigations and other CTE programs of study.

OBJECTIVES. By 5/30/2023, all AISD 7th & 8th grade students (7,962 students per AISD, 10/31/2022) will receive information regarding the 2022-23 Summer Camp opportunity.

By 9/30/2023, 200 7th and 8th grade students will increase their knowledge of CTE Programs of Study, 9 Career Clusters, and post-secondary career options by participating in the 4-day 2023-23 AISD CTE Summer Camp.

ACTIVITIES/STRATEGIES. During the 4-day camp, 200 Junior High students will rotate through 9 TEA-approved Career Cluster stations. Rotations will be facilitated by 20 certified teachers (10 students per station) within the pathway. Two guidance counselors will facilitate sessions to provide academic guidance and counseling about available options. Guidance counselors will also provide support as-needed within stations. Students will participate in hands-on, meaningful units designed create opportunities that enhance their understanding of the various programs, ask questions, and feel more confident in determining their skills and interests. Summer Camp will wrap-up with a culminating activity to understand and take action on the next step in creating their 8th grade and high school academic plan.

OTHER. To provide equitable access to all students, and reduce barriers for attending:

- * AISD will provide transportation to/from the AISD Career & Technical Center from each student's home campus.
- Lunch will be provided through the Summer Feeding Program, funded through local/federal funds.
- * AISD will disseminate registration information by 5/30/2023. Title 1 schools will conduct in-person information booths.
- * Camp is available for 200 students through online registration. Student registration demographics (i.e., # of students per campus, # of students overall) will be evaluated and effort made to provide equitable access throughout the district.

Consistent with the purpose of Focus Area 1, AISD will collect data & report on the following mandatory performance and evaluation measures: 1) Student information as part of the fall, 2022-23 PEIMS collection, to determine students-served demographics: 2) Number of students enrolled in the AISD Summer CTE program; 3) Number of students completing the AISD Summer CTE program; and 4) Report PEIMS-related data (In the Fall PEIMS Submission).

Additionally, AISD will use project evaluation, formative & summative data, to determine when and how to improve future programming. The CTE/Counseling Departments will collaborate to create student pre- and post-survey instruments, to determine student's level of understanding regarding CTE Programs of Study and post-secondary career options. A pre- and post-survey instrument will be created to evaluate participating teacher/counselor about their experience implementing the program and insight gained from working with the participating camp students.

Upon completion of each rotation station, students will complete reflection-exercises to process information learned. During the culmination activity, students will share what they learned through the camp experience, and how the CTE Programs of Study/Career Clusters may align with their own skills and interests.

The 2022-23 Summer Camp data will reviewed and evaluated by CTE/Counseling Departments, and AISD administrative leadership to determine possible adjustments to district course planning, enrollment projections, and future CTE summer bridge programs and activities.

To fully implement the 2022-2023 Summer CTE grant and meet the needs and goals of the program, AISD requests supplemental funding in the amount of \$49,989. Two hundred 7/8th grade students from across the Arlington ISD will attend a 4-day summer program designed to increase enthusiasm, foster innovation, and prepare them for college/career in CTE Programs of Study. Twenty certified teachers and two guidance counselors will implement the program with support from the CTE Department. Students will have transportation provided through grant-funding, to/from their home campus/ AISD Career & Technical Center, and will participate in hands-on activities.

Arlington ISD actively seeks additional funding streams and sustainability for programs. We will maximize local funding, grants, and partnership investments to increase the capacity and impact CTE programs. AISD is fully committed to providing programs that lead to increased student success, and will identify additional philanthropic investors to support programs over time. No funds are allocated to similar summer programs. To meet future needs of students, assessments will be made based on feedback from students, staff, administrators, and partners for each program element, with adjustments made as necessary. At the end of the program, a final evaluation will be made based on feedback from stakeholders to assess effectiveness for future programmatic and financial needs.

6300 Supplies/consumable instructional materials & resources for the delivery of instruction, using industry-aligned activities for 9 CTE Career Clusters. To include items such as: brochures for marketing, supplies for activities, t-shirts for students (\$14,100).

Program Requirements

1a. Needs Assessment (Focus Area 1)

Based on AISD's Needs Assessment Summary & evaluation of students' completion of courses within programs of study, AISD determined that there has been a decrease in the junior high school Career Investigations class and a decline in the number of students enrolling in CTE programs overall. Students and junior high teachers have expressed the need for real world/hands-on experiences so students can better understand their career and pathway options.

CAREER INVESTIGATIONS CLASS. There has been a decrease in enrollment in the Career Investigations class for 8th graders due to scheduling conflicts. Students also do not have the background knowledge to make informed decisions about the CTE Programs of Study and Career Clusters offered within the district. AISD tracks Career Cluster enrollment data and student count. The CTE Department leadership team reviewed and evaluated the past 5 years to determine the trends in enrollment. The past 3 years has seen the greatest drop in number of students who have opted-out of the Career Investigations elective course and choose other options. While supporting student choice in building their own schedules, students who opt-out do not receive information about the different CTE Programs of Study and make endorsement decisions without the most crucial information – a true understanding of their skills and options.

CTE PROGRAM OF STUDY ENROLLMENT. Reviewing and evaluating CTE course enrollment data over the past 5 years, there has been a decline in the number of students who enroll in CTE Programs of Study, with the greatest decline in the past 2 years. There may be a number of factors involved in the drop – including students receiving instruction virtually during COVID, and the general lack of exposure to their high school programs and postsecondary career options. Student enrollment has declined in each program, and especially in three Programs of Study: 1) Arts, Audio/Video Technology, & Communications; 2) Health Science, and 3) Law & Public Service.

Through this grant-funded summer program, 200 7th and 8th grade students will receive the hands-on knowledge they need to better understand their options and the benefits of pursing a CTE Program of Study. Students will engage with hands-on activities and manipulatives designed to build interest and understanding about their many options.
