OVERVIEW ANS NEEDS AT THE DISTRICT: The Donna ISD (DISD) Career and Technical Education (CTE) program MISSION is dedicated to empowering all students to explore, identify, select and pursue a career pathway and gain technical and high-level academic skills. This mission is hard to achieve when DISD, located near the border of Mexico, faces statistics such as the following (SPECIFIED NEEDS LIST): • Donna ISD's county (Hidalgo) has, according to the US Census (2020), 42% of individuals 16 years and older are unemployed. In an already impoverished area, this number is a heavy burden for the local society;

• The county is considered one of the five poorest counties in Texas (Texas Tribune, 2019); and

• 79% of students are at-risk and need remedial assistance (state's average – 49.2% - TAPR); and

• 94.6% of students living in poverty and struggling with basic needs (state's average – 60.3% - TAPR).

That said, Donna ISD is in dire need of assistance with a grant such as the Summer CTE. Therefore, Donna ISD will utilize FOCUS AREA 1's Summer CTE Bridge Program to target 8th graders getting ready for high school and 11th graders getting ready for their last year of high school and the beginning of their post-secondary education.

OVERVIEW AND NEEDS: As described above, the intense poverty of the area touches nearly everyone in the community. With nearly 95% of the students in Donna suffering the consequences of poverty, the infrastructure of basic safety nets is not available, e.g., food security, health care, and transportation are challenges for many families. Part of the MISSION of DISD is to help end this cycle of poverty through education and career planning. Donna ISD's county (Hidalgo) according to the US Census (2020), has

• 42% of individuals 16 years and older are unemployed. In an already impoverished area, this number is a heavy burden for the local society;

The county is considered one of the five poorest counties in Texas (Texas Tribune, 2019); and

• 79% of students are at-risk and need remedial assistance (state's average – 49.2% - TAPR); and

FOCUS AREA 2 is designed to further meet this dire need through the Summer CTE grant.

FOCUS AREA 2: DISD will offer a one-week, paid, community-based internship for both cohorts of students in Focus Area 1. Middle school students in the agriculture program from all four district middle schools will be bused to Laurie P. Andrews PAWS Center in Edinburg (30 minutes away). Here they will shadow the vet techs, learn how to take care of animals, and help keep the kennels clean. High school students from both Donna high schools will explore the health science field through on-site work at a local nursing home and by shadowing local doctors in clinics. Students will engage with nursing home residents, practice taking vital signs, and shadow the staff. Students will be bused to these locations, too, but all are within Donna city limits. The district researched the cost of the staffing, supplies and materials, curriculum, and software needed to reach those goals. Based on the courses that will be available and program needs, the district developed the following budget: 1) Payroll (\$18,000) - This amount does not exceed 75% of the requested grant funds. Payroll cost include for a bus driver and teachers that will provide instruction in the identified CTE courses, and Benefits for all professional and support staff (extra-duty pay) members paid through this grant; 2) Professional and contract services (\$16,107) - Grant funds will be used to fund training for CTE teachers' skills in integration of activities into curriculum to ensure goals and objectives of this summer programming are met; and 3) Supplies and Materials (\$11,446) - Grant funds will be utilized to purchase instructional supplies and resources that are needed for the delivery of instruction. Payroll costs has been budgeted to cover the cost of work-based training for students. Donna ISD is fully prepared to provide a Summer Bridge Program (FOCUS AREA 1) for twenty (20) 8th grade students transitioning to 9th grade and for twenty (20) 11th grade students beginning their last year of high school and starting their transition into life after high school. During this Summer CTE Bridge Program, all 40 students will be provided the opportunity to take part in a Health Science Theory course designed to expose them to local job opportunities. Middle school students will take part in

* Principles of Agriculture, Food, and Natural Resources (can lead to careers such as veterinarians, wildlife biologists, agricultural engineers, food science technicians, landscaping supervisors, and soil and plant scientists);

High school students will take part in

* Health Science Theory (can lead to careers such as exercise physiologists, athletic trainers, phlebotomists, radiologic technologists, dental assistants, physicians, pharmacy technicians and nurses).

The courses will be taught at the high school by highly qualified staff. Donna ISD administrators believe providing these CTE courses during a crucial transition year will help these students to a quicker start in their high school careers with eventual benefits to complete coursework and obtain certifications by the time they graduate and be on a path toward an associate's degree if they so choose.

3. Focus Area 2: Applicants must specify business and industry partners who will be involved in the program. Additionally, specify the work-based learning model(s) which will be utilized and the number of students who will be engaged and supported.

DISD's FOCUS AREA 2 program will offer a 1-week paid internship program which is designed to follow the courses from Focus Area 1. A total of forty (40) students will get paid for 6 hours a day for four days, as summer school is a four-day a week program in Donna. Grant funds would be used to compensate on an hourly basis student based on their attendance and performance. This Summer CTE grant will allow Donna ISD to offer its economically disadvantaged and at-risk students opportunities not typically afforded to them and at the same time earn pay for their time and efforts. DISD staff also will be visiting the job/internship sites to ensure the work-based learning models are appropriate and meeting the goals and objectives of both the grant and the district.

Middle school students in the AG program will be placed at the Laurie P. Andrews PAWS Center in Edinburg. High school students in the health sciences course of study will be placed at local nursing homes and clinics. Both locations have a preexisting relationship with Donna. According to the Center for Career Development at the University of Connecticut, the experiential learning model of an internship provides eight (8) benefits to an education: 1) Gain valuable work experience, 2) Explore a career path, 3) Give yourself an edge in the job market, 4) Develop and refine skills, 5) Receive financial compensation, 6) Network with professionals in the field, 7) Gain confidence, and 8) Transition into a job (Gehr, 2021). All of these benefits will help the students of DISD.
