#### **Summary of Program**

Comal ISD - Graduate Every Student Ready for Military, Career, and/or College.

The mission of Comal ISD's Advanced Academics is to work collaboratively with students, parents, community members, teachers, and administrators to design, guide, and supervise academically advanced programs that promote rigor, depth, and complexity. Advanced Academics ensures that all students in the district have access to a wide selection of challenging courses to enhance and broaden opportunities for future education and career options.

Comal ISD has an open enrollment policy for ALL AP Courses and encourages all academically prepared students to enroll in available AP courses to enhance their academic experience. These courses offer a high degree of rigor designed to prepare students for success in higher academic pursuits. Choosing to enroll in an AP course in Comal ISD is a mutual decision made by the student, parent and school. Each of these individuals is an important participant in this decision.

### **TEA Program Requirements**

1. Identify and describe the explicit need for grant funds to support an AP Computer Science Principles (AP CSP) course. How will this grant build capacity for the LEA? How will the LEA prioritize marginalized students in receiving access to the AP CSP course offering?

The capaccity for the LEA will be built by providing ongoing professional learning for all AP CSP teachers and support to mentor and coach teachers.

Currently, the LEA offers Fundamentals of CS at the 8th grade level. The Program of Study built out by the LEA begins with the fundamentals course and matriculates through five courses ending with Computer Science 2. Recruitment into this POS begins at the middle school level and continues through the high school level. To reach marginalized students, the campuses will promote the course through AVID courses and individual counseling. Middle and high school counselors, along with CS instructors, will assist in providing guidance for student interest.

Current CS students will speak to students about the POS and course opportunity as part of the recruitment process.

The LEA currently has 8 teachers that teach AP CSP. Teachers will be added as needed based on student interest and course registration.

The LEA splits the cost of the AP exam with students to further assist marginalized students and provide access in receiving potential college credit with a passing exam score.

2. Describe how the LEA will select teachers to receive professional development to teach an AP CSP course. How will the LEA select teachers and ensure teacher commitment? How will the LEA ensure teachers have all the tools necessary to teach the AP CSP course successfully? Include how many teachers the LEA needs to provide the AP CSP course.

The LEA has hired one teacher with a CS background. This teacher has the capacity to serve as the support mechanism for the teachers who have recently become certified to teach AP CSP.

All AP teachers in the district are required to attend summer AP Institutes. The LEA recommends that our AP teachers attend one every three years, but teachers are welcome to attend yearly. These trainings help to prepare teachers with content knowledge and instructional practices in project based learning skills. The goal is that the teacher becomes equipped to facilitate a learning environment for all students.

The College Board mentoring program will also be utilized as a support network for teachers, if grant is awarded.

The LEA is researching a professional development provider that offers support, especially for teachers who are new to the course. Experienced AP CSP teachers are an excellent resource so our goal will be to secure a provider that offers support through email, phone calls, virtual meetings, possible webinars, support videos, and just in time guidance.

Once a professional development provider is secured, the LEA will ensure that all teachers have access to learning materials and other support mechanisms.

3. The LEA will identify and select a professional development provider. Describe the nature of the LEA/provider relationship. Which vendor will be the professional development provider for the LEA? When and how will this training occur?

Our LEA has not selected a professional development provider as of yet. However, we will determine a provider during the planning year. A license for curriculum will also be purchased for the year.

The LEA is considering UTeach Computer Science as the professional development provider. UTeach Computer Science is a College Board endorsed professional development provider. They offer in person and online training for teachers that lasts approx. 35 hours. The LEA is in close proximity to the in person training, which is held at UT Austin. The online training provides opportunity to teachers who may not be able to attend in person. The training allows teachers to become familiar with the teacher materials and curriculum, collaboratively work on project based instructional strategies, and learn about the College Board Requirements for AP implementation.

The training cost for each teacher varies from \$1,000 - \$1,500, plus travel costs.

4. Describe the course curriculum for classroom instruction. List any curriculum, technology, and/or equipment required for the course.

The LEA will select a comprehensive curriculum that includes a project based foundation. It will be important that the curriculum is endorsed by the College Board and will support students toward the goal of producing a positive outcome on the AP CSP exam.

The curriculum/support should include:

Comprehensive curriculum and teacher materials, including pacing guides and lesson plans

On demand support for teachers with experienced teachers offering the support

Virtual Workshops throughout the year

Access to a professional online learning community

All AP CSP teachers teach the course in a computer lab, accessible to all students.

5. Describe how students will be supported in selecting and succeeding in the AP CSP course. How does this course support the student's program of study or graduation plan? The LEA must include a plan for ensuring that students take and pass the AP CSP exam.

The AP CSP course will receive weighted rank, as part of the LEA GPA rank policy. The course currently supports CTE credit.

Student study sessions and AP tutorials will be available to students as they prepare for the AP Exam. Teachers will utilize formative assessments to determine individualized student needs/quidance and to help improve student understanding.

The AP CSP course is the 2nd course in a clearly defined and articulated program of study in the LEA.

The LEA strogly recommends that students enrolled in an AP course, take the AP exam at the end of the course.

Currently, the district boasts a 68% passing rate, higher than the state and global passing rates of 55.6% and 63.5%.

Evaluation will be conducted on a yearly basis by school adminstration and counseling staffs, in conjunction with the AP CSP teacher to ensure student success. The LEA will also review student performance data in relation to course enrollment. The goals of the LEA are to:
Increase the number of students enrolling in the AP CSP course, including students in special populations and other non-traditionally enrolled students
Increase the number of students opting to take the AP CSP exam
Increase the number of students earning a 3,4, or 5 on the AP exam

The LEA will choose a curriculum provider that offers support, specific to the above goals.

7. Describe how the LEA plans to implement and sustain the AP CSP course at each campus and how the course will continued to be offered beyond the grant.

This grant will provide initial support to start professional learning work between the LEA and the chosen professional development provider.

Since Fundamentals of CS is offered to 8th graders at all 7 middle schools in the LEA, recruitment of cohorts of students will begin there. Students will be allowed to initiate the POS at any grade level at the high school campuses. The LEA will also ensure that campus leadership and administration are well versed on the course and POS available to all students.

The AP CSP course will be discussed during parent and student recruitment events, in conjunction with information about all other AP courses available in the LEA.

The course will continued to be funded after grant expiration through budget funds.
