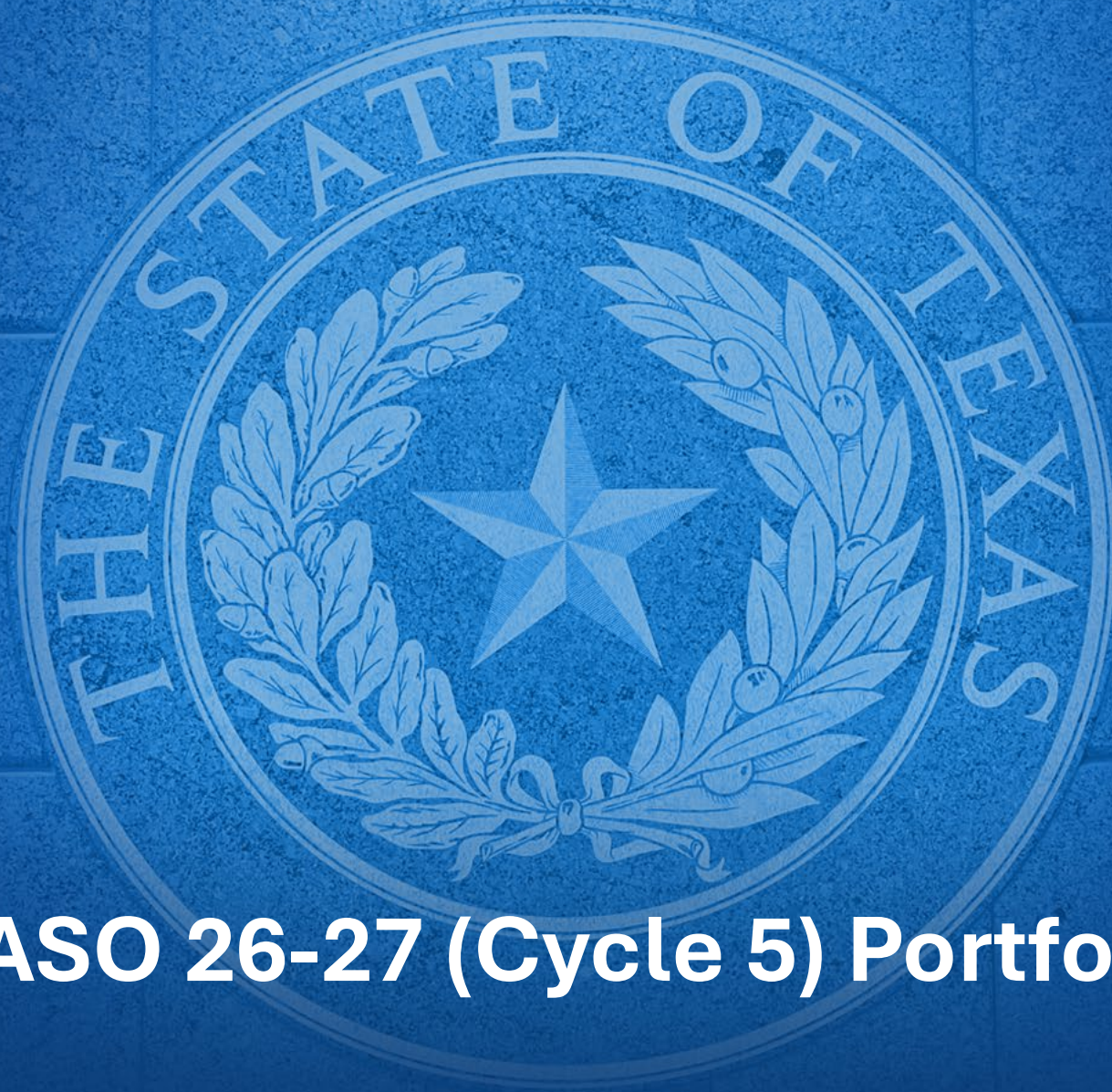

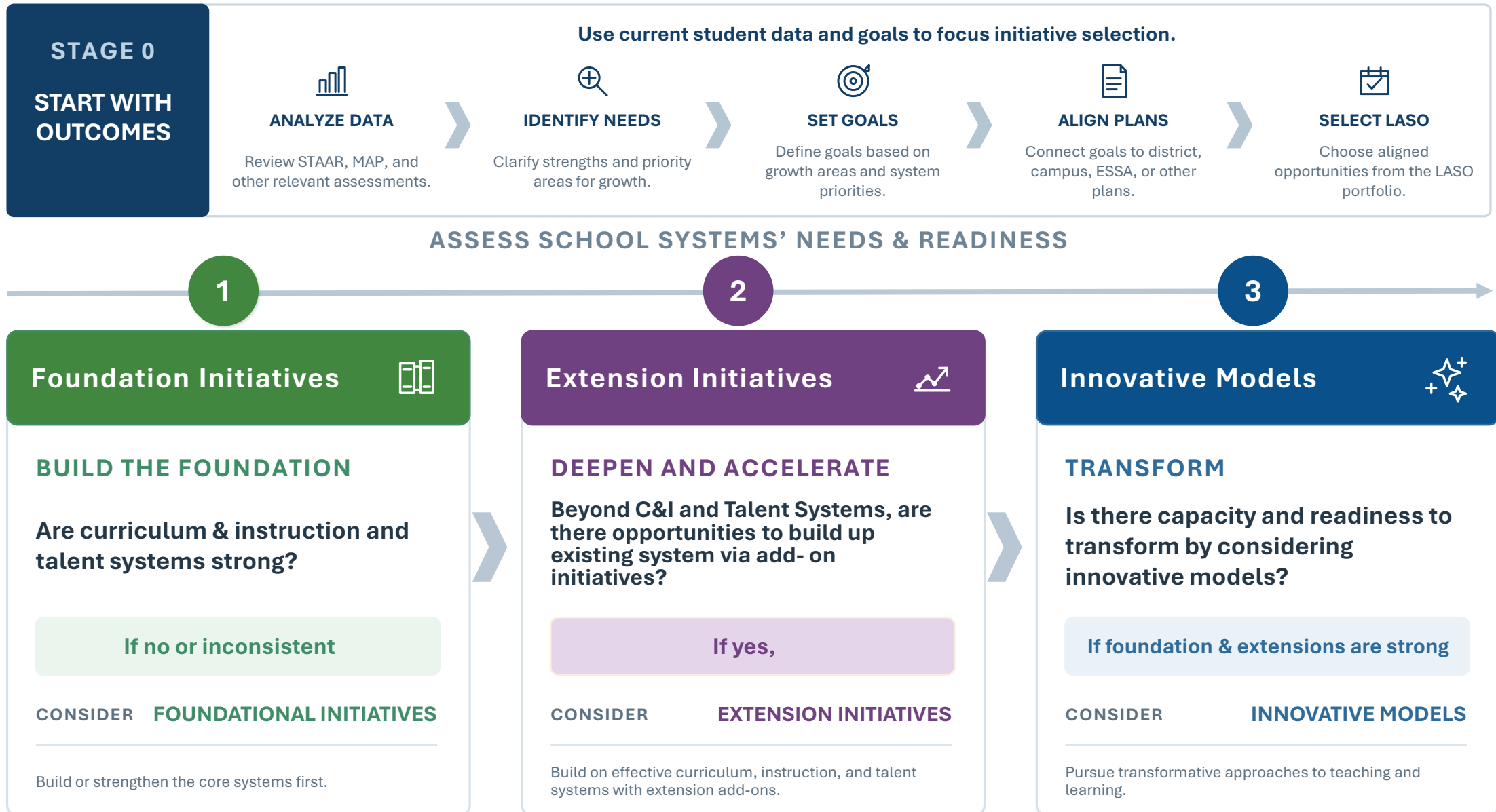

Multiple Initiative Co-existence Considerations

LIFT + SAF

- **Verify campus readiness** by confirming the campus can meet the expectations, staffing requirements, and implementation demands of both programs with quality.

LIFT + MSC for SI/ELIT

- **Align training, coaching, and performance expectations** across teams so campuses receive consistent guidance and support.
- **Use MSC for SI and ELIT products as supplemental supports** that reinforce, rather than duplicate or replace, LIFT implementation.

LIFT + BLG

- **Sequence implementation** by completing Year 1 of SFI/LIFT before launching BLG, reducing competing implementation demands.

ADSY + LIFT

- **Complete** Year 1 of SFI/LIFT before applying for ADSY PEP to establish foundational systems and implementation practices.

ADSY + SAF + BLG

- **Clarify ownership** by defining which campus leaders own key implementation activities and outcomes across the programs.
- **Align milestones and supports** across all programs to coordinate timelines, reduce competing priorities, and create one integrated implementation plan.
- **Assess district and campus capacity** to confirm that staffing, time, and resources are sufficient to implement all programs successfully.

Application Walkthrough

School systems must submit LASO Cycle 5 applications by **December 1 at 5:00pm CT**



TEA will email unique application links to school system superintendents on September 23 (if needed, school systems can complete a [Request for Application Link Form](#) (will be available on the LASO website on September 23).



A PDF of the application will be posted on the [LASO 26-27 \(Cycle 5\) website](#); however, school systems must submit the application through Qualtrics using the unique application link.



Only the last application submitted by December 1, 2026 5:00 pm CT **and** signed by the superintendent will be considered for funding.

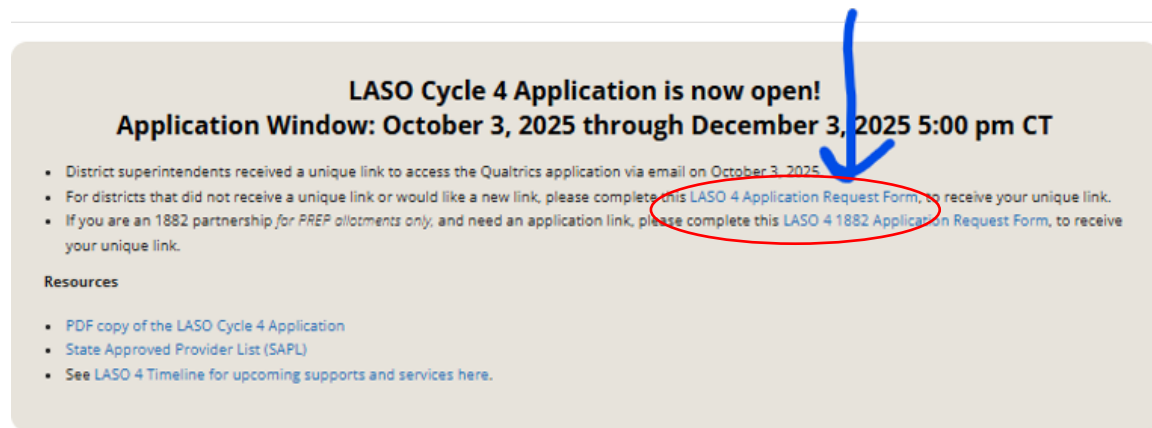

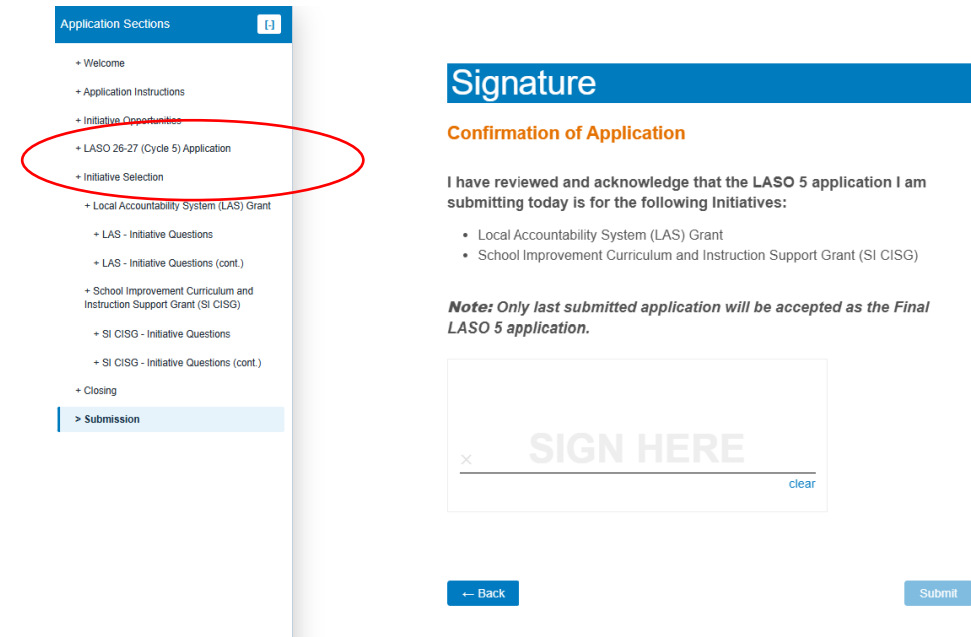

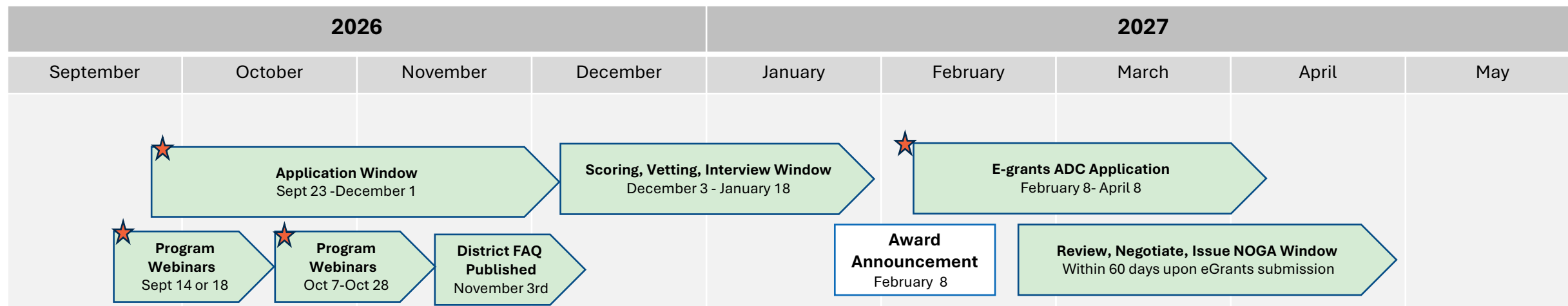
Change Requests and Declines in LASO

- LASO is an informal discretionary competitive grant process
 - Declines and change requests are not advisable in typical competitive process
 - If declines are requested, they will be considered on a case-by-case basis for the school systems and could raise the school system's federal grant risk level in the coming year

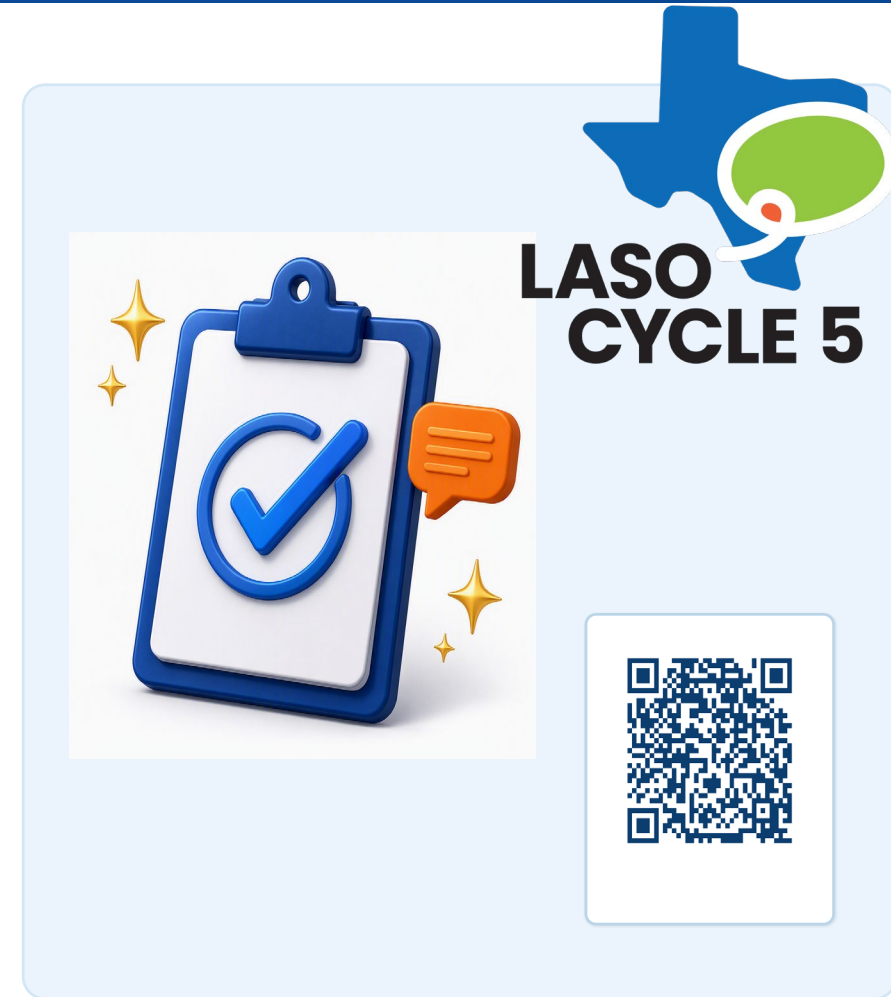
