Introduction:

The Texas Records Exchange (TREx) is a web-based application designed to exchange electronic student records and transcripts. To allow records and transcripts from prior school years to be transmitted, the TREx Data Standards do not remove data elements and codes when they are no longer required. The changes typically align with changes made in the Texas Education Data Standards (TEDS) and the Minimum Standards for the Academic Achievement Record. Obsolete elements and codes are marked with a strikethrough and a note indicating the last school year they were valid.
