
### Snapshot:TEA Charter School Program Grantees Cohorts 2 & 3

In 2020, the Texas Education Agency (TEA) was awarded a five-year, \$100 million grant from the U.S. Department of Education under the Expanding Opportunity Through Quality Charter Schools Program (CSP). With this grant, TEA offers competitive subgrants to provide financial assistance for the planning, program design, and initial implementation of charter schools that support the growth of high-quality charter schools in Texas, especially those focused on improving academic outcomes for educationally disadvantaged students. These subgrants assist eligible applicants in opening and preparing for the operation of newly authorized charter schools and replicating/expanding high-quality charter schools. The information in this datasheet provides a picture of the third cohort of grantees in the first year of their grant period and an update on the second cohort of grantees in the second year of their grant period. Note that percentages displayed are an average across campuses. This approach was adopted to uphold the integrity of school-level treatment within the analysis. Averaging student demographics across campuses allows for a more nuanced understanding of the overall student body composition within each school, thereby ensuring that variations across individual campuses are appropriately reflected.



#### Cohort 3 Race/Ethnicity 2023-241




**Outer Ring: CSP Campuses**



#### Cohort 3 Other Demographics 2023–24<sup>1</sup>




<sup>&</sup>quot;Nearby" campuses are those among the 29 closest regular instructional, non-charter campuses to each designated CSP campus and have either an exact or partial grade-span match. A total of 124 nearby campuses were identified, some of which are nearby more than one CSP campus. Nearby distance ranges from 0.19 to 4.85 miles with an average of 2.16 miles.


#### Cohort 3 Prior Year STAAR Performance<sup>2</sup>

#### Cohort 3 Campus Locale Type<sup>4</sup>




<sup>\*\*</sup> Campus Ns for CSP grantee campuses are 13 (Student N = 2,298) for attendance and disciplinary action rate, 5 for Kindergarten readiness (Student N = 80), and 11 (Student N = 1,943) for grade level retention. Campus Ns for nearby campuses are 124 for attendance (Student N = 76,078) and disciplinary action rate (Student N = 76,079), 124 for Kindergarten readiness (Student N = 6,284), and 120 for grade level retention (Student N = 68,383).

<sup>††</sup> Grade-level retention was determined by comparing each student's prior year (SY 2022–23) fall snapshot grade level to the fall snapshot grade level for SY 2023–24. Students who did not advance at least one grade level were marked as retained. Pre-K students are not included in the calculations for grade-level retention. Percentages reported are averages of school-level rates for CSP and nearby campuses separately.



#### Cohort 2 Other Demographics in 2023–24<sup>1</sup>






Cohort 2 Attrition Rate 2022–23 6,##




Statewide Attrition Rate 2022–236

- § § The number of nearby campuses for Cohort 2 CSP campuses (N=237) increased from the Cohort 1-2 (2022–23) Snapshot (N=145) due to the addition of 6 Cohort 2 CSP campuses that began serving students in the 2023–24 school year.
- ## The 2022–23 annual attrition rate is the rate from fall 2022–23 to fall 2023–24.
- \*\*\* Campus Ns for CSP grantee campuses are 16 (Student N = 2,160) for attendance and disciplinary action rate, 10 for Kindergarten readiness (Student N = 451), and 16 (Student N = 1,787) for grade level retention. Campus Ns for nearby campuses are 237 for attendance (Student N = 130,441) and disciplinary action rate (Student N = 130,443), 171 for Kindergarten readiness (Student N = 12,519), and 234 for grade level retention (Student N = 118,640).
