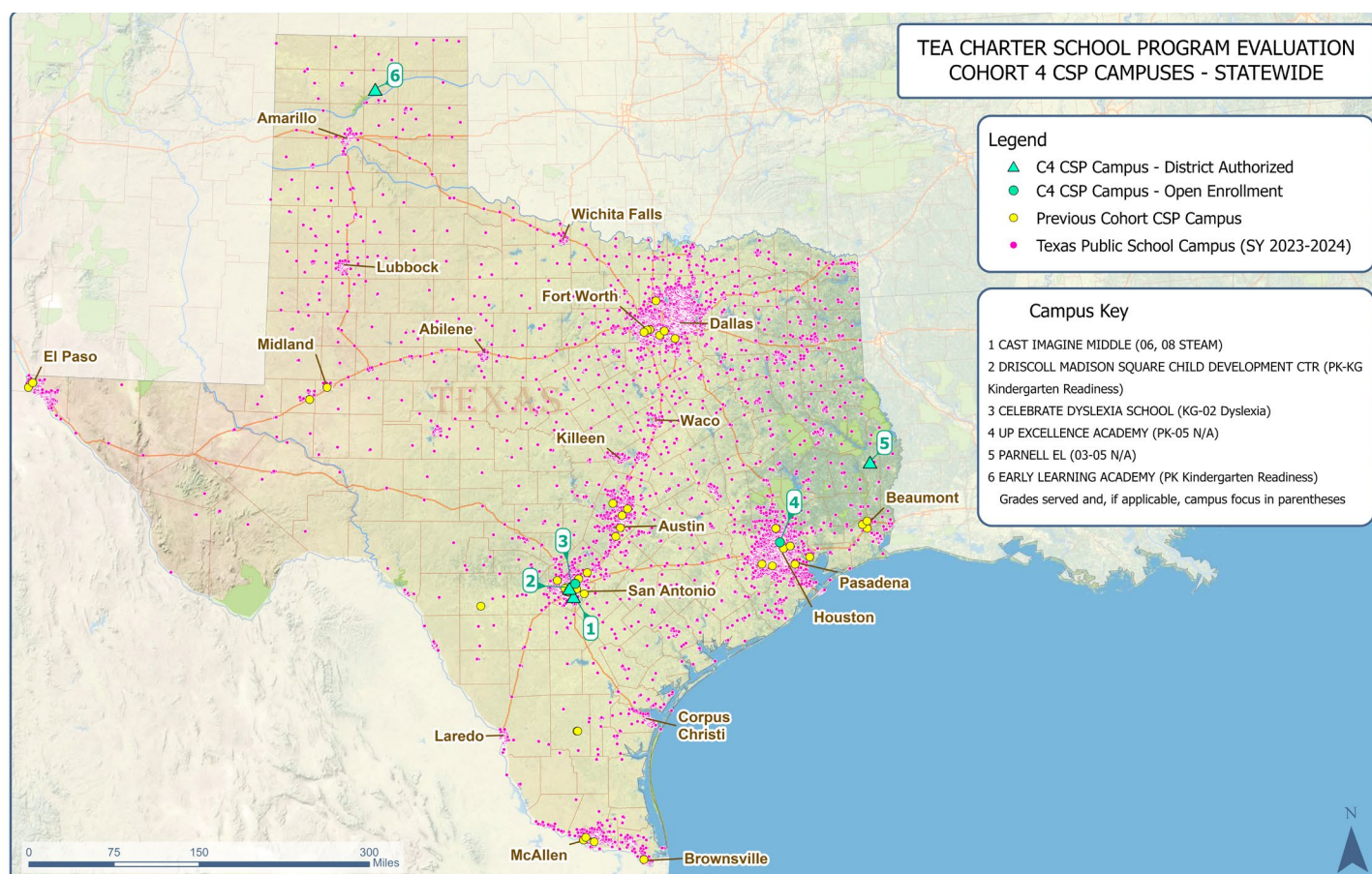


SNAPSHOT: TEA Charter School Program Grantees Cohorts 3 & 4

In 2020, the Texas Education Agency (TEA) was awarded a five-year, \$90 million grant from the U.S. Department of Education under the Expanding Opportunity Through Quality Charter Schools Program (CSP). With this grant, TEA offers non-competitive and competitive subgrants to provide financial assistance for the planning, program design, and initial implementation of charter schools that support the growth of high-quality charter schools in Texas, especially those focused on improving academic outcomes for educationally disadvantaged students. These subgrants assist eligible applicants in opening and preparing for the operation of newly authorized charter schools and replicating/expanding high-quality charter schools. The information in this datasheet provides a picture of the fourth cohort of grantees in the first year of their grant period and an update on the third cohort of grantees in the second year of their grant period. Note that percentages displayed are an average across campuses. This approach was adopted to uphold the integrity of school-level treatment within the analysis. Averaging student demographics across campuses allows for a more nuanced understanding of the overall student body composition within each school, thereby ensuring that variations across individual campuses are appropriately reflected.

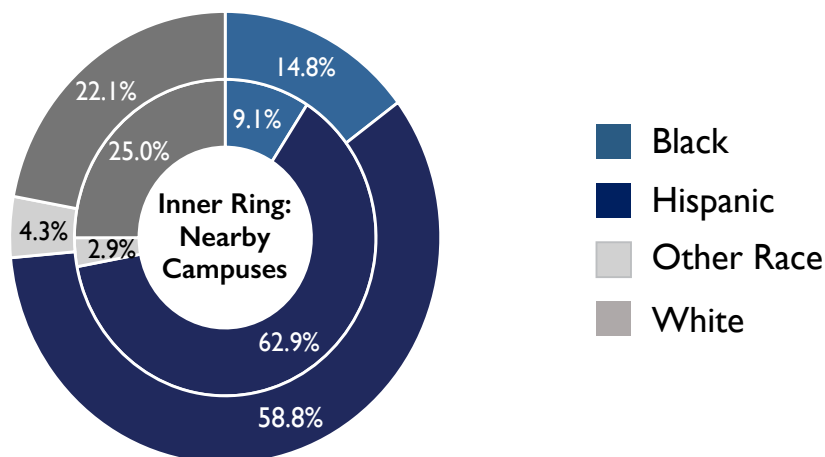

Cohort 4 Race/Ethnicity 2024–25¹

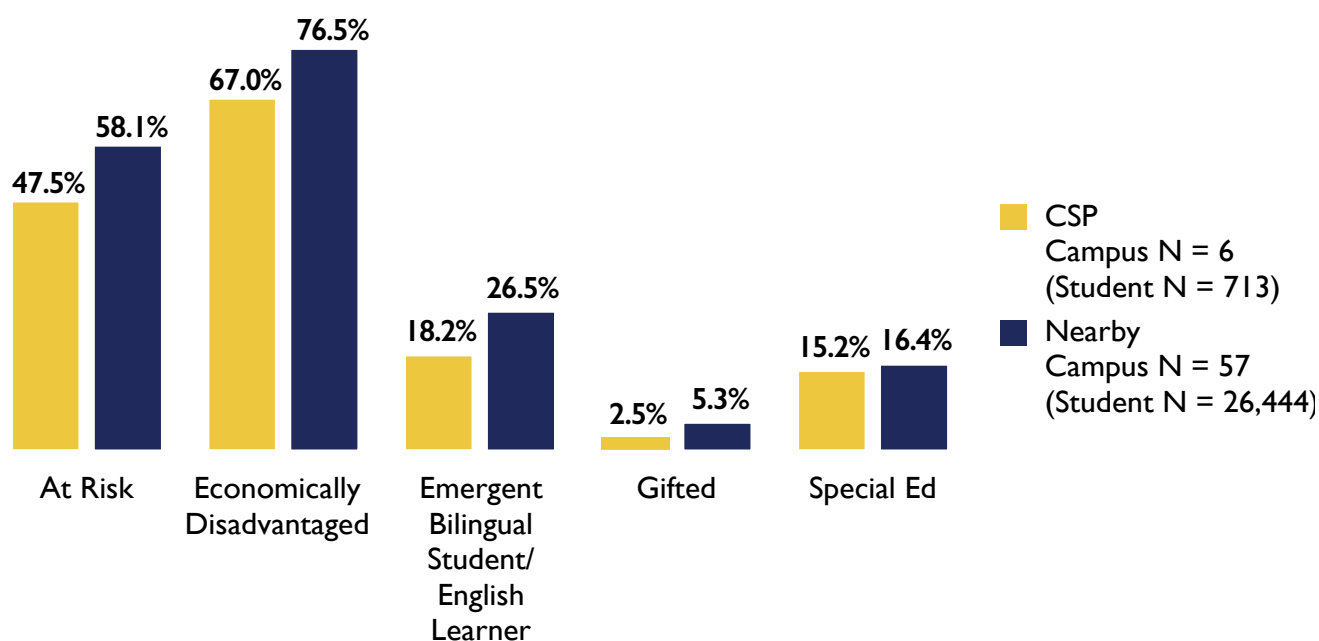


Outer Ring: CSP Campuses

CSP Campus N = 6 (Student N = 713)

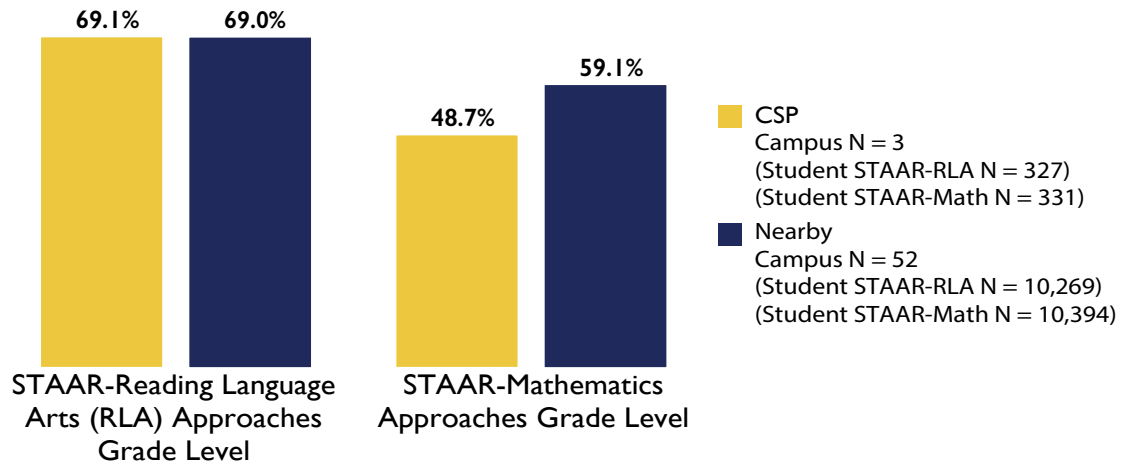

Cohort 4 Other Demographics 2024–25¹

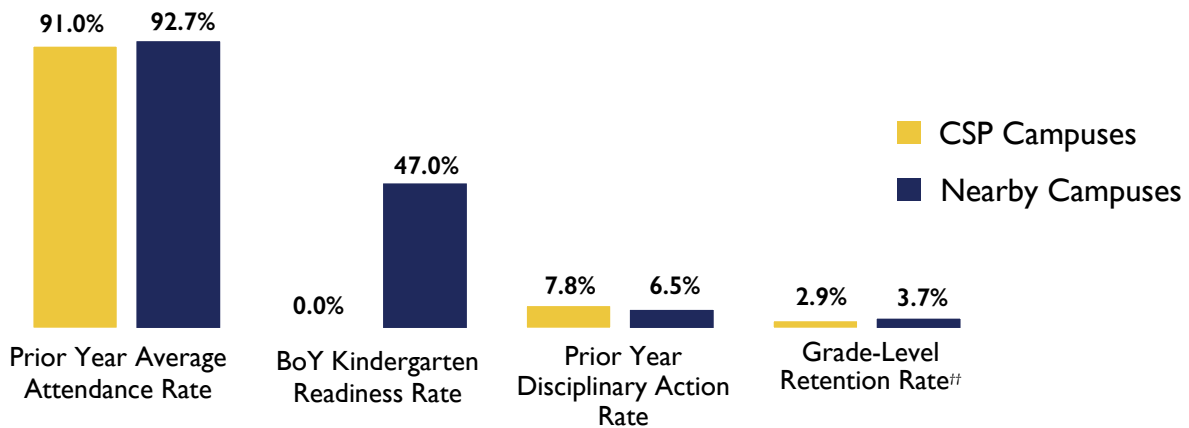


[#] “Nearby” campuses are those among the 29 closest regular instructional, non-charter campuses to each designated CSP campus and have either an exact or partial grade-span match. A total of 61 nearby campuses were identified, some of which are nearby more than one CSP campus. Nearby distance ranges from 0.39 to 30.81 miles with an average of 8.41 miles.

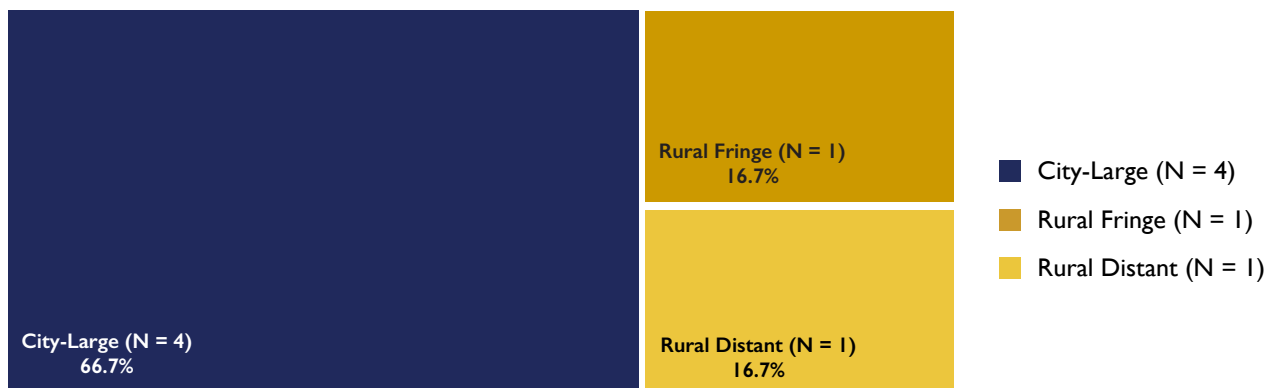
Cohort 4 Prior Year STAAR Performance²

Cohort 4 Campus Locale Type⁴



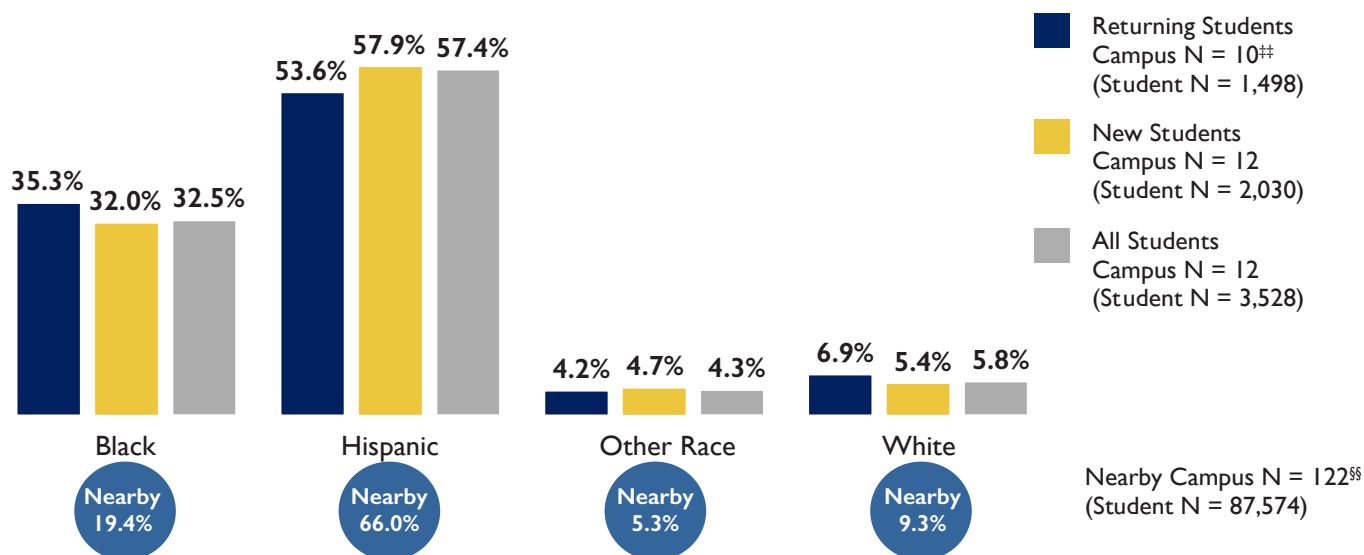
^{**} Campus Ns for CSP grantee campuses are 6 (Student N = 581) for attendance and disciplinary action rate, 5 for Kindergarten readiness (Student N = 6), and 4 (Student N = 548) for grade level retention. Campus Ns for nearby campuses are 57 for attendance and disciplinary action rate (Student N = 23,155), 37 for Kindergarten readiness (Student N = 2,439), and 53 for grade level retention (Student N = 20,328).

^{††} Grade-level retention was determined by comparing each student's prior year (SY 2023–24) fall grade level to the fall grade level for SY 2024–25. Students who did not advance at least one grade level were marked as retained. Pre-K students are not included in the calculations for grade-level retention. Percentages reported are averages of school-level rates for CSP and nearby campuses separately.

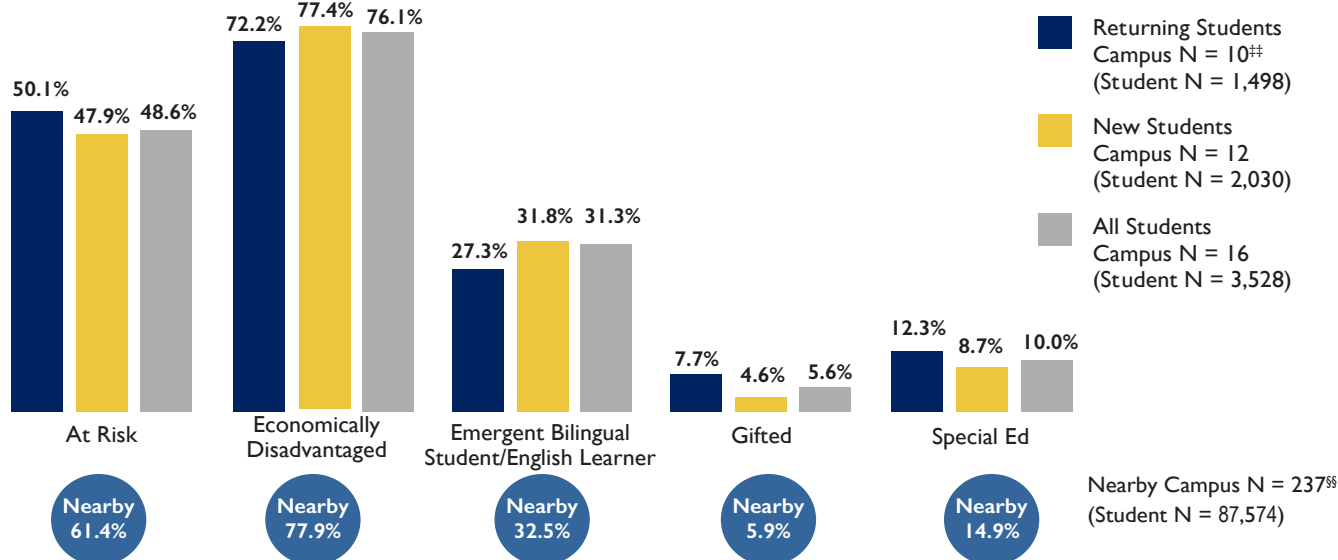

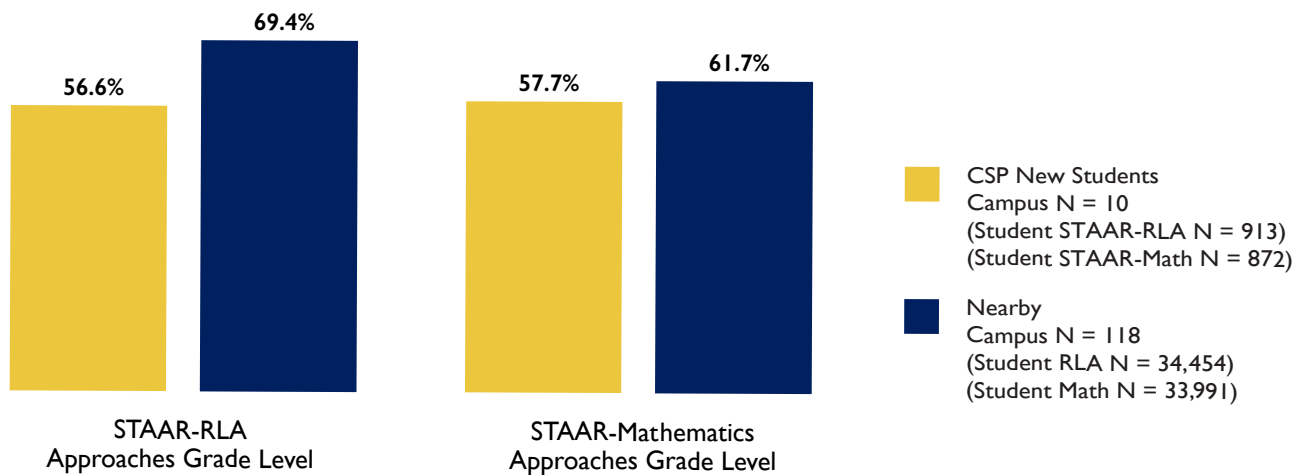

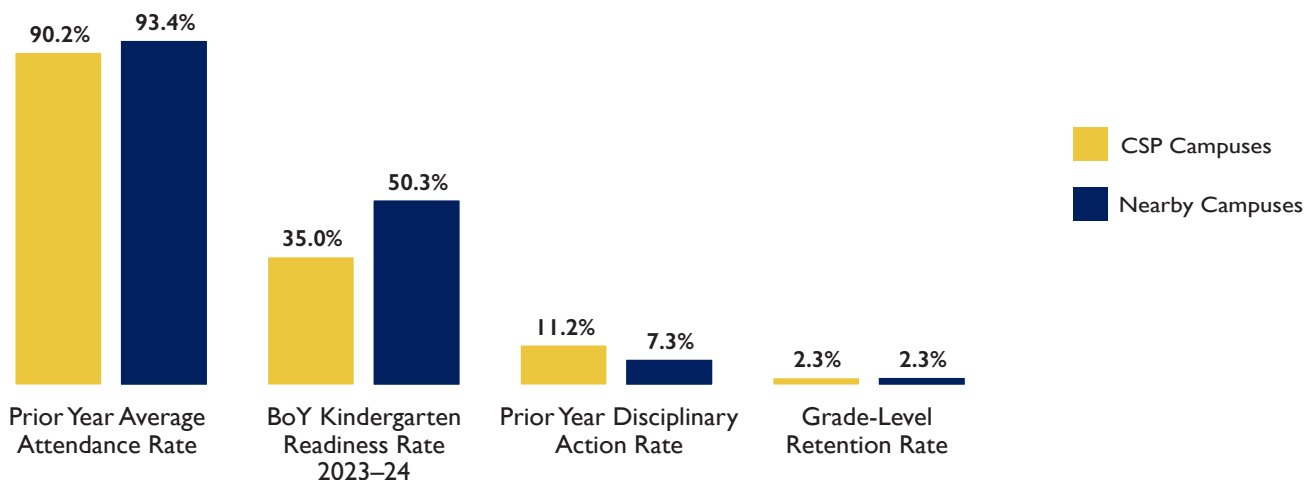
Prior Year STAAR & Baseline Indicators: New Students

Two Cohort 3 CSP campuses that were not yet open in the 2023–24 school year began serving students in the 2024–25 school year, while three Cohort 3 campuses that served students in the 2023–24 school year ended their charters prior to the 2024–25 school year. Therefore, the campus N for new students is 12 while the campus N for returning students is 10.

§ § The number of nearby campuses for Cohort 3 CSP campuses (N = 122) increased from the Cohort 2-3 (2023–24) Snapshot (N = 124) due to the addition of two Cohort 3 CSP campuses that began serving students in the 2024–25 school year and the removal of three campuses that ended their charters prior to the 2024–25 school year.

The 2023–24 annual attrition rate is the rate from fall 2023–24 to fall 2024–25.

*** Campus Ns for CSP grantee campuses are 12 (Student N = 1,490) for attendance and disciplinary action rate, 7 for Kindergarten readiness (Student N = 236), and 12 (Student N = 1,228) for grade level retention. Campus Ns for nearby campuses are 123 for attendance and disciplinary action rate (Student N = 79,056), 93 for Kindergarten readiness (Student N = 6,008), and 119 for grade level retention (Student N = 71,519).
