

# Advanced Placement Examination Results in Texas and the United States, 2023-24

This report presents Advanced Placement (AP) examination participation and performance data for students in Texas and the United States in public and nonpublic schools combined. AP examination results are used by colleges and universities to make class placement decisions and to award college credit to incoming students who meet qualifying standards on the examinations.

Results presented in this report were obtained from summary reports released annually by the College Board. ## **Advanced Placement Results for Texas and the United States**

- In the 2023-24 school year, a total of 381,057 students in all grades in Texas public and nonpublic schools took 713,059 Advanced Placement (AP) examinations (Table 1). Texas ranked second in the nation in both number of AP examinees and number of AP examinations taken (Table 2 on page 3).
- Between 2022-23 and 2023-24, the number of AP examinations taken increased by 12.3 percent in Texas, compared to 10.3 percent in the United States as a whole (Table 1). The percentage of examinations with scores in the 3-5 range increased by 3.4 percentage points in Texas and by 4.8 percentage points in the United States.
