Project Evaluation and Modification

Our goal is to increase the over-all industry-based certifications our health science students earn by 20% which will require more students to attempt the certification opportunities we currently offer, and it also requires us to add new health science programs of study in which we can offer new industry-based certifications for our students to earn. We will use project evaluation data to determine when and how to modify our programs by focusing on the number of industry-based certifications successfully earned by our health science students in 2019-2020. We will review the number of students who attempted the industry-based certifications we currently offer in our existing health science programs of study including Certified Patient Care Technician (CPCT), Certified Phlebotomy Technician (CPT), Certified EKG Technician (CET), Certified Pharmacy Technician (CPhT), and Emergency Medical Technician (EMT) in 2019-2020 and compare that to the number of students who attempted those certifications in the prior year. We will then perform the same analysis considering the number of students who successfully earned the above listed industry-based certifications that we currently offer verses the number of failed attempts. This will indicate to us what specific health science programs of study are being successful in certifying students and which programs need improvement. By tracking the quarterly benchmark data throughout the grant period, we will be able to target areas of weakness in our curriculum and, or instruction and make the necessary modifications to improve student certification outcomes.

Project evaluation data of students accepting employment with our business partners will also be collected on a yearly basis as well as data of students benefiting from the Future Generations program with Medical City North Hills Hospital and receiving free tuition, books and scrubs to complete their Registered Nursing Degree. All collected benchmark data and feedback from the certification programs, business partners and program evaluators will be evaluated quarterly for progress and necessary adjustments will be determined by the CTE Administrative Staff. Any necessary delivery methods will be adjusted in a timely manner using the Birdville ISD Continuous Improvement Model for curriculum and instruction. If our benchmarks do not show progress towards meeting our summative SMART goal of increasing the industry-based certifications that are earned by our health students by 20% in 2019-2020, we will use the evaluation data collected to modify our certification programs for sustainability by determining the manner and method of instruction that is successful.

We are seeking this grant to ensure students in our district will have more opportunities to obtain industry-based certifications, and we are requesting funding to pay for more of our students to receive industry certifications in Health Science Technology which is a state identified high skill, high-wage, in-demand industry. We chose the Health Science Technology pathway based on data from our district and the Texas Workforce Commission, as well as hiring trends provided by our local chamber of commerce and our community business partners. We seek to provide expanded opportunities for more of our students to earn industry-based certifications in one of our school district's most popular programs of study, Health Science Technology, which includes our Nursing/Clinical Rotations program of study, together with Pharmacology, Phlebotomy, Electrocardiography (EKG) and our Emergency Medical Technician practicums. Health Science Technology is also one of our regions highest demand and growing areas of employment. In our Health Science programs of study, students learn academic and technical skills, received hands-on experience, and earn several industrybased certifications. This leads our students to greater post-secondary success in careers in the health care industry careers such as registered nursing, which is an occupation that is number one on the State of Texas High Demand List, with an annual average salary of \$69,891.00. The Texas Workforce Commission projects the annual state growth rate for registered nurses to increase by 10,815 openings in the coming years. Additionally, the number one associate degree occupation, ranked by 2012 employment with 2013 average wages, in Tarrant County is registered nursing. Registered nursing is also one of the top ten fastest growing occupations for the years 2012 through 2022 in Tarrant County with 18.7% of occupations in Tarrant County in 2012 being professional occupations; the growth of the health care industry is a major driving factor behind this sector. There are many other related jobs in the health care industry that our students will be qualified for after completing one or more of the health science programs of study we currently offer in Birdville ISD. For example, an EKG Technician earns \$19.97 per hour in Texas, which is 19% above the national average; a Certified Pharmacy Technician earns \$15.18 per hour which meets the national average; an Emergency Medical Technician in the Dallas-Fort Worth area can start out earning \$30,689.00 per year; and a Certified Phlebotomy Technician can start out earning up to \$37,839.00 in the Dallas-Fort Worth area immediately upon graduating high school. Providing students with greater opportunities to receive industry-based certifications, acquire technical skills and make professional industry connections will prepare them to be more marketable and highly successful upon leaving high school.

We currently offer the following industry-based certifications which are approved by TEA and listed on the 2018-2019 and/or 2019-2020 Final List of Industry-Based Certifications of the A-F Accountability System:

- Certified Patient Care Technician (CPCT)
- Certified Phlebotomy Technician (CPT)

Certified EKG Technician (CET)

- Certified Pharmacy Technician (CPhT)
- Certified Emergency Medical Technician (EMT)

The industry-based health science certifications we currently offer (as listed above) are stackable credentials that can lead to future success in the ever-growing field of health science, thereby furthering our students' ability to obtain gainful careers in the health care industry. In addition, these industry-based certifications are transferable to postsecondary programs in conjunction with our ongoing community partnerships with Tarrant County Community College and Medical City North Hills Hospital for the Future Generations Project, as well as our ongoing partnership with the North Richland Hills Fire Department for our Firefighter/EMT Academy. In 2019-2020, if we are awarded this grant, we propose to add to the current industry-based certifications we now offer in order to further increase our students' opportunities for success in the health science career field. After reviewing local hiring trends as reported by the N.E. Tarrant Chamber of Commerce, analyzing our regional labor market and considering the TEA approved programs of study available, we determined the most appropriate certification to add at this time is Medical Coding & Billing Specialist (MCBS) and to do this we plan to add a new health science program of study, Health Informatics, which leads students to employment as a Medical Records and Health Information Technician. In Texas, a Medical Records & Health Information Technician earns an average salary of \$41,510.00 according to the U.S. Department of Labor, Bureau of Labor Statistics. In addition, Texas has the 2nd highest employment level of this occupation in the nation, with the Dallas-Fort Worth metropolitan area having one of the highest employment rates for Medical Records & Health Information Technicians in Texas, as well as nationwide.

Our Health Science Technology program currently has 969 students enrolled in our various health science courses, practicums and extended practicums including Clinical Rotations I & II, Electrocardiogram & Phlebotomy, Pharmacology, and Emergency Medical Technician. Every health science student will benefit from this grant funding. We have limited resources available to allocate to all of our health science programs, so we are forced to limit our health science enrollment, despite receiving a high number of student course requests each year, especially for our Nursing/Clinical Rotations program of study. This is due to the high costs per student associated with the multiple industry-based certifications we offer for our health science students. On average we are forced to turn away over 250 students who request to take various courses in our Health Science Technology pathway because we do not have the resources to allow more students to enroll in our programs. We propose to use the funding received from this grant to add resources to our health science programs of study to allow for more students to enroll in our programs and thus earn more industry-based certifications. In the 2019-2020 school year, we propose to double the number of students in our Nursing/Clinical Rotations program of study who will earn Certified Patient Care Technician (CPCT) certifications while working in internships at Medical City North Hills Hospital. In order to enter the program, students must be background checked, TB- tested, immunized and drug screened. Medical City North Hills has agreed to cover the expense of this for pre-screened candidates. Birdville ISD Career & Technology Education Department will pay for the students' certification exams, their transportation to and from the hospital for their internship, and the required liability insurance for each participant. These certifications obtained in our health science programs of study, and the work experience students obtain through the hospital partnership will prepare them to enter the industry at Medical City North Hills Hospital and benefit from a joint venture called the Future Generations Project. The Future Generations Project provides students employment as a Certified Patient Care Technician (CPCT) with the hospital while pursuing a Registered Nursing Degree at Tarrant County Community College after successfully completing the Clinical Rotations II Program in partnership with Birdville ISD Career & Technology Health Science Department. Once hired, Medical City Healthcare will pay for college tuition, fees, books, and uniforms up front in exchange for a 2-year commitment to work full-time as a registered nurse. In this program of study, our health science students also have the opportunity to earn a Certified EKG Technician (CET) certification and a Certified Phlebotomy Technician (CPT) certification in our Electrocardiogram and Phlebotomy Technician Health Science Practicum program of study.

In addition, our health science students benefit from another partnership the Birdville ISD Career & Technology Education Department has with Tarrant County Community College in the Emergency Medical Service Program together with the North Richland Hills Fire Department. Students are able to obtain a Certified Emergency Technician (EMT) certification in our Emergency Medical Technician program of study. In our EMT program of study, students receive rigorous academic training and career focused instruction, together with real-world, hands-on experience as they participate in 911 emergency ambulance ride outs. After successful completion of our EMT program of study, students are immediately eligible for employment as an Emergency Medical Technician.

Another opportunity for students to benefit from earning an industry-based certification is in our Pharmacology program of study. Our Pharmacology students are able to seek employment as a Certified Pharmacy Technician (CPhT) when they complete our Pharmacology program, during which they have the opportunity to participate in work-based learning through our partnerships with local pharmacies including Glenview Pharmacy, CVS Pharmacy and Walgreens Pharmacy.

In addition to the opportunities for industry-based certification we currently offer in our Health Science Technology Pathway, we are seeking to add more industry-based certifications through the funds we receive from this grant including Medical Coding and Billing Specialist (MCBS) which will be offered in a new program of study we also hope to add, Health Informatics. By adding to the number of industry-based certifications we are already offering, we will enhance our overall Health Science Technology Program and benefit more students as they obtain credentials which will lead them to highwage, in- demand employment opportunities.

Industry-based certification exams are offered at no-cost to the students of Birdville ISD.

The process for paying for exams for students is done according to our school district purchasing guidelines. Health Science teachers submit the number of students they have who will be sitting for a certification exam and our CTE coordinator verifies that the certification being sought is a legitimate industry-based certification and the exam is being offered by a reputable certification exam provider. The CTE purchasing administrative assistant creates a purchase order request for the number of student exams needed and the purchase order is submitted for approval to the CTE director. Once approved, the district issues a purchase order and it is sent directly to the exam vendor as payment for the student certification exams.

All certification exams and the corresponding fees associated with technical skill training, transportation to/from internships and work-based learning, uniforms, equipment and supplies are fully paid for by the Birdville ISD Career & Technology Education Department because many students we serve in our district are unable to pay for the high costs associated with industry-based certification. In addition, by paying for the certification exams for the students, we create a huge incentive for students to participate in our capstone programs of study which lead to industry-based certifications; and this results in more students leaving high school with industry recognized credentials which will, no doubt, lead to increased employment opportunities in high-paying careers, as well as post-secondary degrees in the high-demand area of health science technology.

9. **FOCUS AREA 2 APPLICANTS:** Explain efforts that have already been made to ensure success during the grant period.

The Birdville ISD Career & Technology Education Department has a well established CTE program designed to ensure students have opportunities to earn industry-based certifications through our state-of-the-art CTE facilities and industry standard equipment. In order to ensure success during the 2019-2020 grant period, we have consulted our industry partners to make certain we have the latest technology and equipment that is currently being used in the health care industry. We recently added all new EKG and phebotomy training equipment. In addition, our health science teachers are all CTE certified and have the necessary work experience and health science industry-based credentials and degrees. In addition our health science teachers have received professional development and training regarding our existing health science program areas, and for the new health science program of study and certification we plan to add with the funds received from this grant including Medical Coding and Billing Specialist (MCBS) which will be offered in our new Health Informatics program of study.

In addition, we have purchased up-to-date industry recognized curriculum and materials for our health science courses and we have increased our health science students' access to technology in the classroom. We have added a virtual reality lab where our health science students can experience 3D anatomy and physiology lessons, as well as virtual demonstrations of medical procedures.

Birdville ISD CTE already has industry partnerships in place with Medical City North Hills Hospital, Glenview Pharmacy, CVS Pharmacy, Walgreens Pharmacy, and with the Tarrant County College Emergency Medical Progam which will support the growth we are seeking through this grant of our existing health science programs of study which lead to industry-based certifications including Certified Patient Care Technician (CPCT), Certified EKG Technician (CET), Certified Phlebotomy Technician (CPT), Certified Pharmacy Technician (CPhT), and Certified Emergency Medical Technician (EMT). Our existing industry partnerships are ready and willing to support the new Health Informatics program of study we propose to add with this grant which will allow students to earn the Medical Coding & Billing Specialist (MCBS) certification.

10. **FOCUS AREA 2 APPLICANTS:** Explain how the applicant organization will ensure that students are prepared for the industry-based certification exams.

We will ensure that our students are prepared for industry-based certification exams by continuing to offer rigorous instruction and technical skill training and support in the classroom, together with hands-on learning experiences. We have a state-of-the-art career and technology center called Birdville Center of Technology & Advanced Learning which is dedicated to CTE and student success. We offer the latest industry standard equipment on which students are able to learn and prepare for industry-based certification exams. Our CTE instructors are industry certified and provide students with industry recognized curriculum designed for certification test preparation using state adopted textbooks and online learning opportunities. In addition, our students receive real-world experience while working in internships with our community partners including Medical City North Hills Hospital for our Nursing/Clinical Rotations students; Glen View Pharmacy, CVS and Walgreens for our Pharmacology students; and with the Emergency Medical Services Program at Tarrant County Community College and the North Richland Hills Fire Department for our Emergency Medical Technician students, as well as students in our Firefighter/EMT Academy.

Through our community partnerships, students have many opportunities to learn skills to prepare them for industry-based certification exams. For example, in our Nursing/Clinical Rotations program, students gain first-hand industry experience at Medical City North Hills Hospital which is essential for student success on certification exams.

The industry experiences that will be made available to all students are as follows:

- Respond to patient calls & requests
- Tidy patient's rooms
- Transport patients
- Draw/Collect & label laboratory specimens
- Assist patients with personal hygiene tasks
- Serve meals & safely feed patients
- Monitor vital signs
- Read basic EKG rhythms

Students are also able to work side by side with a CPCT on inpatient care units as follows:

- Medical/Surgical Units- 5th & 6th floor
- Out Patient Surgery Unit

- Progressive Care Unit (PCU)- 3rd floor
- EKG & Phlebotomy Observational Role

11. **FOCUS AREA 2 APPLICANTS:** Identify strategic partnerships already in place that provide an advantage in implementing the proposed project.

We have several strategic partnerships already in place that will provide us an advantage as we seek to increase the number of participants in our health science programs, increase the number of industry-based certifications offered, and increase the percentage of successful completers sitting for all health science certification exams and taking advantage of the postsecondary educational reimbursement opportunities available through our community partners. Birdville ISD CTE has maintained a strategic partnership with Medical City North Hills Hospital for the past 40 years designed to provide workbased learning opportunities for our students interested in a career in health science, and to prepare our students with the technical skills and industry-based certifications necessary to fill the high paying, in-demand employment opportunities that are available at the hospital. Medical City North Hills Hospital and Birdville ISD CTE have expanded our strategic partnership to include Tarrant County College in a student success initiative called the Future Generations Project. The Future Generations Project provides students employment as a Certified Patient Care Technician (CPCT) with the hospital while working on a Registered Nursing Degree after successfully completing the Nursing/Clinical Rotations II Program at Birdville ISD. Once hired, Medical City Healthcare will pay for college tuition, fees, books, and uniforms up front in exchange for a 2-year commitment by the student to work full-time as a Registered Nurse at Medical City North Hills Hospital. We have another strategic partnership with Tarrant County College in their Emergency Medical Service Program and through this partnership students are able to earn a Certified Emergency Technician (EMT) certification. Tarrant County College Emergency Medical Services program is recognized as the leading program of its kind in the state, preparing students for careers as Emergency Medical Technicians and Paramedics. The Birdville ISD program began partnership with Tarrant County College ten years ago. It was through the vision of TCC and Birdville ISD CTE that Birdville ISD was one of two districts to begin the Health Science Emergency Medical Services Program. Since that time the Birdville program has been used as a model for other school districts. One of the top benefits for students is that this partnership provides a rigorous course of study leading to an industry-based certification. Finally, Birdville ISD maintains strategic partnerships with Tarrant County Workforce Solutions, InterLink, and the N.E. Tarrant County Chamber of Commerce to determine state and local employment opportunities and to monitor industry growth and hiring trends in our city, county and region.
