# **TEM** Review and Adoption 101

#### **TEKS Adoption**


TEA presents the recommendations from the workgroups to the SBOE.

#### IM Review (June–August)

TEA convenes state review panel meetings to determine alignment to the TEKS, TPG, and/or ELPS.

#### District Adoption (Fall/Spring)

Districts determine which materials meet the needs of their students.



#### **TEKS Revisions**

SBOE directs TEA to convene workgroups to review TEKS and propose revisions.

#### Proclamation (April)

The SBOE issues a call for instructional materials aligned to the newly revised TEKS.

#### IM Adoption (November)

TEA presents SRP reports and comments and errors received from the public.

#### Implementation (August)

Classroom teachers begin teaching the new TEKS using the new instructional materials.



## **Review and Adoption 101—TEKS**

- Workgroups meet several times over the course of 7–12 months.
- The SBOE meets five times each year.
- The TEKS are part of the Texas Administrative Code (TAC).
- The SBOE amends the TAC over the course of three meetings.
  - Discussion
  - First Reading and Filing Authorization
  - Second Reading and Final Adoption



# **Review and Adoption 101—Proclamations**

- Proclamations are typically issued in April.
- They are named for the year in which materials will be implemented.
- Each proclamation includes the following:
  - Subject areas and courses or grades scheduled for review
  - Schedule of adoption procedures
  - Requirements for publisher participation
  - Accessibility requirements



## Review and Adoption 101—SRP Evaluation

- State review panels include the following:
  - Members that represent the diverse demographics of the state
  - A majority of members with content expertise and experience
  - Academic experts
  - Educators, parents, business and industry representatives, and employers
- They evaluate products to
  - identify the extent to which the materials address the standards (TEKS, TPG, and/or ELPS),
  - record errors, and
  - provide feedback.



# Review and Adoption 101—Public Evaluation

- All materials under consideration are available for public review.
- For all subjects except prekindergarten, the samples are available for public review on the TEA website or in person at TEA and each of the 20 education service centers (ESCs).
- Prekindergarten samples must be viewed in person at TEA or one of the 20 ESCs.
- Members of the public can provide feedback in writing or in person.



## Review and Adoption 101—SBOE Adoption

- The SBOE adopts materials by a majority vote that meet the following criteria:
  - Meet at least 50% of the TEKS or TPG
  - Conform to established physical specifications
  - Follow the applicable Web Content Accessibility Guidelines (WCAG) and technical specifications of the Federal Rehabilitation Act, Section 508
  - Are free from factual errors
  - Have been reviewed by academic experts
  - Are suitable for the subject area and grade level



## Review and Adoption 101—District Adoption

- Adopted publishers are required to provide samples to districts upon request but can require districts to return them.
- Districts review instructional materials following established district policies.
- Textbook selection committees present recommendations to the local school board or governing body.
- Each school board or governing body selects instructional materials in an open meeting.





- Local budget and technology staff confirm necessary resources
- Local board or governing body selects instructional materials and certifies that the district has materials that cover 100% of the TEKS for all courses. in the foundation curriculum except physical education
- IM coordinator orders materials in **EMAT**

# **SBOE-Adopted Materials are Thoroughly Vetted**

- The majority of each panel of reviewers must have content expertise and/or experience.
- A student expectation is only considered addressed if each breakout of each student expectation is covered twice—once in the student text narrative and once in an activity.
- Results are carefully documented and available to the public.



# SBOE-Adopted Materials are Thoroughly Vetted

- TEA provides information about the specific student expectations not covered in each adopted instructional material that meets less than 100% of the TEKS.
- Products under consideration are made available for public review and comment for several months.



### **SBOE-Adopted Materials are Accessible**

- Each adopted publisher of electronic instructional materials must provide evidence that its materials passed an accessibility audit.
- Each adopted publisher of print materials must provide NIMAS files to facilitate the production of braille, large-print, and audio materials.
- The state pays for the production of accessible adopted materials.



### **SBOE-Adopted Materials have a Fixed Price**

- Adopted publishers sign an eight-year, fixed-price contract.
- The fixed prices apply to the entire package and to each component in the package.
- All contracted prices are legally required to be the same as or lower than any other price offered to any other state.



# **SBOE-Adopted Materials are Easy to Order**

- Adopted materials are available to order through EMAT.
- Orders placed through EMAT go directly to the publisher.
- Publishers are paid as soon as orders are marked as shipped in EMAT.
- Everything ordered through EMAT is listed on the district's inventory.



# **SBOE-Adopted Materials are Subject to Enforcement**

- The Texas Education Code, §31.151, authorizes the SBOE to impose penalties upon publishers for the following reasons:
  - Offering instructional material in Texas at a higher price than that offered to any other state, public school, or school district in the U.S.
  - Failing to automatically reduce the price of instructional materials to the extent the price is reduced elsewhere
  - Failing to provide free items in Texas to the same extent provided elsewhere
  - Selling materials of inferior quality or that contain factual errors



# **SBOE-Adopted Materials are Subject to Enforcement**

- The Texas Education Code, §31.151, authorizes the SBOE to impose penalties upon publishers for the following reasons:
  - Attempting to restrict trade or competition
  - Not providing districts with an accurate shipping date for backordered materials
  - Failing to deliver instructional materials ordered by July 1 at least 10 business days before the opening day of school








### Orders Placed Directly with Publishers

When you order non-adopted materials, your district is responsible for the following:

- Vetting the materials to determine the extent to which they address the TEKS, TPG, and/or ELPS
- Ensuring students with print disabilities have the materials in accessible formats
- Negotiating prices and contract terms
- Requesting an allotment disbursement
- Paying the publisher
- Resolving ordering, pricing, and quality issues
