Determining Poverty Levels for SAA

Basis of Eligibility

The most common Basis of Eligibility that LEAs can use to determine eligibility for Title I-A services at a campus are:

- 1. <u>**Residing**</u>: The total known number of students in each attendance area who are eligible to attend the campus, including students enrolled at private schools and facilities other than public schools.
- 2. <u>Enrollment</u>: The total number of students enrolled at the campus.
- **3.** <u>**Direct Certification**</u>: The percentage of identified students approved as eligible for free meals who are not subject to verification (i.e. in Community Eligibility Program (CEP) schools, "directly certified" children.)



Determining Eligible Campuses

Criteria to determine eligible campuses to be served

1. Multiple Attendance Areas

- A. Title I eligible campus must meet at least one -
 - I. Low-income above 35 percent
 - II. Low-income above district's low-income average

2. Single Attendance Areas

- A. Definition of Single Attendance, must meet at least one -
 - I. LEA enrollment less than 1,000 students
 - II. Active campuses with enrollment and do not have any grade level duplication
- B. All campuses are Title I eligible and may be served



Determining Campus Status

Campus Selection Statuses

1. The standard campus statuses are:

- A. Schoolwide (SW)
 - I. Campus has 40 % or more in low-income student data.
 - II. Campus can be SW based on other Basis of Eligibility Selections.
- B. Targeted Assistance (TA)
 - I. Any campus that is Title IA eligible.
- C. Not Served (NS)
- D. Skipped (Skip)
 - I. Campus is not served with Title IA funds but should be served based on low-income percentage and campuses in need or being served.



Types of Schoolwide Campuses

To be a schoolwide campus the campus may use one of the following criteria:

- **Schoolwide (SW)** Low-income percentage is at least 40% or higher
- <u>SW Previous Year</u> Campus is Title I eligible based on criteria and was Schoolwide previously (SW Previous Year). LEA must indicate the year and percentage on the other field for that campus if using this as the Basis of Eligibility.
- Feeder Pattern Feeder Pattern can be used if the grade span campus that feeds into the campus is a SW campus. LEA will enter the low-income percentage of the Feeder campus for this campus instead of their actual lowincome percentage and indicate the campus number(s) on the other field they are using for the feeder pattern.
- One-Year Transition can only be used if the campus was schoolwide previous but is no longer a Title I eligible campus. Check to make sure they did not use this basis in the previous year.



Campus Selection Statuses

SW Previous Year

- A. Campus must still be a Title I eligible campus.
- B. Indicate the percentage and school year when the campus was at 40% or higher.
- C. Can continue to use SWP each year after as long as campus is still Title I eligible.

<u>Feeder Pattern</u> –

- A. Can be a one-to-one campus in which the lower grade span is SW and feeds into the campus above.
- B. Can be a campus that is SWP Yr and using feeder pattern.
- **C.** Multiple campuses must use the combined data to determine if the campus can be Schoolwide using feeder pattern.



Schoolwide Campuses

One-Year Transition

- 1. Campus must have been a served campus in previous year
- 2. Either Schoolwide or Targeted Assistance
- 3. Can only be used for one year. The following year the campus would need to be Not Served.

NOTE: All campuses of a LEA that is a Single Attendance Area are Title I eligible

Campus can apply for Ed-Flex if the campus qualifies.



Schoolwide Campuses

To be a schoolwide campus the campus may use one of the following criteria:

- Ed-Flex can be used if an LEA's low-income percentage are low and the campuses cannot be Schoolwide on their own. The Ed-Flex schedule (WV4004) must be completed and the LEA must document the process to approve the campus to be schoolwide. The LEA must retain all documentation. If an LEA has used the Ed-Flex Waiver in previous years, it is not necessary to complete the WV4004 schedule. This is only needed if they wish to add a new campus not previously approved or a significant change in grade spans.
- NOTE: The campus must be Title I Eligible to continue to use the Ed-Flex Waiver for Schoolwide each year.



Ed-Flex - WV4004 Schedule

When the WV4004 must be completed:

- 1. The first year that the campus has requested the waiver.
- 2. If the campus has changed campus number or grade span.

If no longer Title I eligible, LEA can:

- 1. Use the One-Year Transition
- 2. After the One-Year Transition has been used, the LEA can request a Programmatic Waiver for Title I eligibility.
- 3. If approved, the LEA must complete the WV4004 for that year.



Determining Campus Status

Skip is used for one or two reasons:

- 1. Campus is above 75% (most in need) and LEA has determined to not serve using Title IA funds.
 - A. LEAs can choose not serve a campus (Skip) but must comply with status of comparable services with other funding sources.
- 2. A campus with a lower low-income percentage and the same grade span is served.
 - A. The campus with the higher low-income percentage that will not be served must be indicated as a Skip.
 - **B.** Follow the same assurance as those above 75%.



Consolidated Funds

- 1. Each campus that has a campus status as "Schoolwide," must select the type of consolidated funds the campus will implement. This is a campus consolidation and not a district consolidation of funds only.
 - **A. Title I A Only**: Campus does not consolidate Title I, Part A, funds with any other federal, state, or local funds.
 - **B. Federal Funds Only:** Only federal funds are combined on this campus. For example, Title I, Part A; Title II, Part A; and Title IV, Part A, are consolidated.
 - **C. Federal/State/Local Funds:** Campus consolidates federal, state, and local funds.

- 1. For any campus that is either served as Schoolwide, Targeted Assistance, or Skipped, the LEA must check the specific assurance checkbox at the bottom of the schedule:
- 2. When selected, each checkbox provides the specific assurance that the LEA is accepting.





Determining Allocations for Campuses

Statute requires all campuses above 75% to be served. Most in Need of these services

- 1. LEAs can choose not serve a campus (Skip) but must comply with status of comparable services with other funding sources.
- 2. LEAs have the option to rank high schools above 50% below the campuses of greatest need (above 75%).
- 3. Per Pupil Amounts need to be either equal or in descending order based on the low-income percentage.
- 4. LEAs can continue the PPA in descending order or by grade spans for served campuses under 75%.
- 5. Single Attendance Areas are exempt from this rule.

NOTE: Documentation is maintained at the local level to assure compliance.
