### **Summary of Program**

1. Describe how the LEA will support campus(es) in carrying out school support and improvement activities, including how the LEA will develop a web-based improvement plan for the eligible campuses selected for this grant.

Crandall ISD will support Barbara Walker and Hollis T. Dietz Elementary Schools to implement school support, and improvement plans monitored by Plan4Learning 806 Technologies and E3 Alliance through site-based Campus Improvement Plans directly linked to the needs of each campus. In year two of Plan4Learning Campus Improvement Plan implementation, dramatically improved accountability for each campus and the district is evident. E3 Alliance provided staff development in the first year with a coaching model in the second year. Both the web-based program and E3Alliance are familiar entities with our district. The campus administrators have embraced the ease of Plan4Learning, which has drastically changed the way Campus Improvement Plans drive instruction. With the user-friendly system of Plan4Learning, the district began to meet as committees to develop, analyze, and evaluate strategies over the year. The diverse, site-based teams have assigned roles and responsibilities, increasing stakeholder input and ownership in meeting the goals. The committees set goals based on the needs assessment to identify priority areas through reviewing data sources and determining responsibility, expected results, and measurement criteria. The Targeted Improvement Plans were instrumental in creating the objectives and strategies as needed on Barbara Walker and Hollis T. Dietz Elementary Campuses.

With the SIG grant, building teacher capacity with coaching and mentoring through E3 Alliance RAISEup Texas will lead to a higher mastery of the goals. The formative and summative reviews provided by E3 Alliance RAISEup Texas and documented in Plan4Learning will allow feedback on what is working and what needs to be changed to meet the desired goals. The E3 Alliance, RAISEup Texas professional development and coaching, will promote productive and instructional-based conversations in the Professional Learning Communities (PLCs). Teachers will learn how to discuss the stages of implementation, effectiveness, and evaluation of the quality of instruction delivered in the classrooms; thus, the objectives and strategies in Campus Improvement Plans and Targeted Improvement Plans will blend seamlessly. The Plan4Learning format suggests four formative reviews with stakeholders to enable critical analysis of these set goals. This plan ties funding to goals to address ESSA, State Compensatory, and Federal Funding needs. Reviewing the funding process will ensure that the funds will supplement existing program services and activities. This comprehensive process allows a sequenced format to identify needs accurately, execute well-planned implementation strategies, stress communication with all stakeholders, measures fidelity in funding allocations, and assess student performance to increase achievement on each campus ultimately. Crandall ISD, Plan4Learning, and E3 Alliance will support campuses in carrying out school support and improvement activities to improve student achievement on the Barbara Walker and Hollis T. Dietz Elementary Campuses.

2. Describe how the LEA will monitor schools receiving the ESF-Focused Support Grant, including how the LEA will: (a) Monitor a web-based improvement plans upon submission and during implementation, and (b) Implement additional action following unsuccessful implementation of such plan after the first year of the grant cycle.

The District, Campus, and E3 Alliance will examine the Targeted Improvement Plan components to determine essential actions, review rationale, and desired outcomes for the focused areas. The additional support from the ESF- Focused Support Grant will incorporate multiple professional developments and coaching sessions with E3Alliance RAISEup Texas to foster constant improvement on both campuses. Crandall ISD has been working with E3Alliance RAISEup Texas to implement the Instructional Playbook and leadership coaching sessions with our principals. This relationship with E3Alliance has been extremely valuable to strengthen our teams throughout the district. Thus, the combination of E3Alliance RAISEup Texas and Plan4Learning Systems will maintain quarterly checkins. Teams will evaluate progress, access actions, identify barriers, measure progress, determine necessary adjustments, modify plans, and prioritize future needs as needed to be successful. With the addition of direct coaching, targeted observations, and campus leadership coaching, campuses will be closely monitored to ensure compliance. It will be critical to analyze the essential actions, desired outcomes, responsibility, district actions, and E3 Alliance support each step of the way. The Plan4Learning Web-Based program will assist with the formative and summative reviews of the progress. A web-based improvement plan allows real-time collaboration with all stakeholders and ensures that all involved work with the most current action plans. The 90-day reviews will allow goals to be analyzed, modified, or discontinued regularly. Evidentiary supports in meeting agendas, notes with teams, follow-up/action items, and additions to campus systems will be collected and shared. The systematic review with Plan4Learning on the Campus Improvement Plans and the Targeted Improvement Plans interweaves a strategic focus on academic achievement. When struggling to move the needle of success, E3Alliance RAISEup Texas will carry us through a problem-solving model to examine the system established to see if we need to evaluate, adjust, refocus and redesign our plan to meet the academic goals of Crandall ISD. In Crandall ISD, we will not need to overcome the implementation of another new program or contracted personnel to implement our targeted plan to increase academic achievement due to our prior experience with E3Alliance RAISEup Texas and Plan4Learning. A combined and supported effort from the Superintendent to the level of the teacher will ensure positive strives with this first year of the grant cycle.

## Goals, Objectives, and Strategies, Performance and Evaluation

1. Describe how the LEA will modify, as appropriate, practices and policies to provide operational flexibility to the awarded campus, that enables full and effective implementation of the Effective Schools Framework Essential Actions aligned webbased Improvement Plan.

Crandall ISD will work with E3 Alliance to implement an ESF- Focused Support Grant with monitoring through the Plan4Learning improvement plan to implement necessary actions to improve academic success at Barbara Walker and Hollis T. Dietz Elementary Schools. With the assistance of E3 Alliance, a clear path toward collective efforts and changes in practice will ultimately lead the campuses through E3 Alliance's Theory of Change based on focused support and clear objectives to achieve a high culture of academic performance. Data-driven decisions will commit the team to problemsolve, change, design solutions, and sustain a high-performance culture. In this process, the three prioritized focus areas will address the essential actions, desired outcomes within 90 days, barriers to overcome, and district or E3 Alliance actions for implementing a successful action plan. The committee will examine milestones, timelines, resources, evidence, and progress toward milestones in the Action Plan stage. Every 90 days, the committees at Barbara Walker and Hollis T. Dietz will reflect on achievement and discuss milestones or adjustments to improve achievement in the next cycle. Setting a priority to change ineffective processes and processes that hinder student success, the desire to achieve academic outcomes will drive a high-performance culture on each campus. Staff will continue being supported, encouraged, and empowered to make changes by scheduling regular conversations allowing feedback and modifications, creating a culture of improvement. Between the 90 day cycles, professional learning communities will convene weekly to identify data insights, build common agenda, forge collaboration, change practices, build capacity, and change needed systems to achieve educational milestones in alignment with improvement initiatives. With the Effective Schools Framework Actions and E3 Alliance guidance, Crandall ISD will meet and exceed the expected outcomes designated in the Target Improvement Plans for Barbara Walker and Hollis T. Dietz Elementary Schools.

#### **Budget Narrative**

1. Crandall ISD will strategically plan and access the needs and goals of Hollis T. Dietz and Barbara Walker Elementary to streamline funding and staffing to consistently focus on achievement. With a lens of instructional fidelity, budget planning will align with the areas identified through students' and staff's needs assessment and priorities. Focus at the district level will allow for the coordination of funding to increase program effectiveness while maximizing all available programs and resources, thus eliminating duplication or fragmenting programs. The SIG grant will provide funding through object code 6200 to strategically partner with E3 Alliance RAISEup Texas. We will contract with E3Alliance RAISEup Texas for six inperson coaching visits, two professional learning sessions, five virtual coaching sessions, and eight deep-dive virtual sessions for Dietz and Walker Elementary Campuses. This partnership will strategically focus on improving leadership, culture, and highly effective instruction aligned to the ESF Priority Levers. The collaboration with E3 Alliance would be our second year with them; thus, the established relationship will remain constant for our staff. Coaching, professional learning support, instructional models, developing mentor teachers, and data-driven decisions will be targeted areas designed and implemented in strategic planning to engage district and campus-based leaders with E3 Alliance RAISEup Texas facilitators.

Building capacity will be a focus with master teacher stipends addressed with personnel, 6100 object code. This focus will target campus teacher leaders allowing a model to be developed and utilized within the district, again increasing the capacity of all of our teachers to lead the instructional growth in teachers, administrators, and students to attain student success. This stipend allows the district to maintain and move forward with a district-wide implementation plan in the future as a sustainable model. On both campuses, teacher leaders are currently attending local training sessions called Aspiring Leadership Academy, strengthening their ability to mentor and coach fellow teachers. The Aspiring Leadership Academy, funded with local funds, will be an excellent source for teacher leaders on both campuses to recruit for the coaching sessions with E3Alliance RAISEup Texas. The coaching and assistance provided by the E3 alliance, RAISEup Texas facilitators, will increase teacher leaders' capacity and retention in the district. The coordination of federal, state, local, and grant funds will streamline purchases to directly tie to the Plan4Learning Campus Improvement Plans and Targeted Instructional Plans; thus, maximizing funding potential on these campuses. The power of coordinating campus and district spending to support strategies for effective instruction will benefit the district for years to come with sustainable leadership capacity and highly trained teachers. The key to improvement will lie in building human capital to increase achievement in our students. In object code 6300, local and federal funds should cover any needs to support this coordinated effort between E3Alliance RAISEup Texas and the campuses. This two-year grant will allow the district to plan for similar supports providing district-wide, prioritizing district spending to align with teachers leading the work beyond grant dollars.

2. Describe how the LEA will align other Federal, State, and local resources to carry out the activities supported with funds received under this grant.

Crandall ISD will utilize the funds received from Federal, State, and local resources to implement our strategic plan documented in Plan4Learning and aligned with Targeted Instructional Plans to improve not only the Hollis T. Dietz and Barbara Walker Elementary Campuses but all campuses throughout the district. The coordination with E3Alliance RAISEup Texas will prep and coach, our leaders and campus staff to remain consistent in following the strategies outlined in the plans. This grant will supplement the after-school tutorials, Saturday Schools, and Summer Bridge Programs with a laser highlighting the areas needing improvement. E3 Alliance and the ESF-Focused Support Grant will allow Crandall ISD to carry out the activities as structured by these programs to remain focused on the ultimate goal of improving achievement. In After School Tutorials, Saturday Schools, and Summer Bridge Programs, faculty and staff will be knowledgable of the focus on TEKS alignment in the curriculum and assessment to support data-driven instruction ultimately. Therefore, all education provided through Federal, State, and local resources will reach the desired outcomes due to the direct tie to the essential actions in the Targeted Improvement Plans.

Crandall ISD local funds have contracted with E3Alliance to improve Instructional Leadership and Tier One Instruction by implementing Instructional Playbooks on all campuses. In year two with E3Alliance, the instructional leaders feel empowered to work with the Instructional Playbooks, which aligned with the Targeted Instructional Plans and Campus Improvement Plans in Plan4Learning, to streamline their educational goals. After collaborating with E3Alliance in the past two years, Crandall ISD would intertwine the SIG Grant with other programs funded by federal, state, and local funds to strategically focus student learning goals through collaboration, communication, and consistency. These resources will be intertwined together to show each staff member how the unification of sources streamlines efforts to achieve success. This targeted approach through a trusted and valued partner will support a practical framework not only on Hollis T. Dietz and Barbara Elementary Campuses but throughout the district. As a district, we will streamline our funding and training efforts based on the vetted system provided by E3Alliance RAISEup Texas to improve our teaching and leadership capacity to push the needle in student growth across the district.
