AISD Mission. The Arlington Independent School District (AISD), located between Dallas and Fort Worth, is the 13th largest school district in Texas and serves 59,453 students from PK-12 (TEA, Snapshot 2020). AISD operates 78 campuses, with a goal to graduate students exceptionally prepared for college, career, and citizenship.

CTE in AISD. Through the Career & Technical Education (CTE) Department, AISD offers an enhanced educational system that prepares students for the future. The CTE Department oversees curriculum development and implementation, instructional resources, student identification, and staff development for the CTE program. AISD offers 12 different career pathways for students 9-12 – including two programs which are the grant project emphasis: Hospitality/Tourism and Fashion Design.

Need. In a changing, global marketplace, employers need individuals with technical knowledge/skills who are prepared for in-demand, high-skill, and high-wage careers. CTE programs offer a sequence of courses that provide coherent & rigorous content, are aligned with challenging academic standards & relevant technical knowledge/skills for further education/careers in current/emerging professions (TEA, 2021). AISD will offer students two unique CTE summer learning programs: Hospitality/Tourism and Fashion Design. These summer programs directly connect to AISD ' s mission of creating relevant learning experiences for students and connect with grant

FOCUS AREA 1 to increase awareness, enthusiasm, and enrollment in these CTE programs of study.

1. Hospitality & Tourism Mission: Learn about career opportunities & post- secondary education. In summer 2022, 2 teachers & 6 high school students will attend/participate in a Texas Hotel and Lodging (THLA) 3-day High School Hotel Summer Camp to learn about Lodging & Resort Management career paths & related post-secondary education. The 2022 High School Hotel Summer Camp will be held in Dallas & students experience sessions about the Hotel Industry, (e.g., Career Options, Customer Service, Communication, Goal Setting, & Job Search Strategies). Registration includes hotel accommodations, meals, camp materials, curriculum, and trainers. Students who attend the Hotel Summer Camp experience will share their knowledge in a Showcase Event for AISD students, staff, & community partners.

2. Design/Multimedia Arts: Fashion Design Mission: Learn about career opportunities & post-secondary education. Summer 2022, 7 high school students & 2 teachers will travel to the Fashion Institute Design and Marketing (FIDM) 2 Days of Fashion event, providing students with a unique college experience related to the fashion design industry. During the 2-day event held in Los Angeles CA, students will participate in hands-on workshops, attend presentations/guest speaker panels, meet industry professionals, & tour the campus. Students who attend the 2 Days of Fashion experience will share their knowledge in a Showcase Event for AISD students, staff, & community partners.

To fully implement the 2021-2022 Summer Career and Technical Education grant and meet the needs and goals of the program, Arlington ISD will require supplemental funding in the amount of \$23,042. AISDs goal is to increase enthusiasm, foster innovation, and prepare students for college/career in the 1) Lodging/Resort Management & Travel, Tourism & Attractions; & 2) Design & Multimedia Arts: Fashion Design programs of study. The district will offer students in these two programs the opportunity to attend specific off-campus summer experiences that enhance and supplement their academic learning.

In AISD Summer Program 1 (Hospitality & Tourism) six students will attend the Texas Hotel & Lodging High School Hotel Summer Camp in Dallas, chaperoned by two teachers. Students will arrive at the appointed time to a designated campus, and then ride by AISD transportation to the conference in Dallas, stay 2 days/3 nights, and then return by AISD transportation to the AISD campus. At the beginning of the 2022-2023 school year (prior to grant end date 9/30/2022), students will plan and participate in a Showcase Event for their parents & community.

Staffing: Extra duty pay + fringe for teachers, for each day of travel (\$840).

Supplies: Showcase Event includes invitations, signage/banners, brochures for promoting programs/courses, supplies for activities, portfolio, & video (\$1600).

Travel (In-state): Registration for 6 students and 2 teachers, & AISD transportation (\$4700). Registration includes lodging and meals.

Total Expenses Summer Program 1: \$840 + \$1600 + \$4700 = \$7,140

In AISD Summer Program 2 (Fashion Design), seven students will attend the Fashion Institute Design and Marketing (FIDM) 2 Days of Fashion Event, chaperoned by two teachers. Students will arrive at the appointed day/time to a designated campus, and ride by AISD transportation to the airport and travel by plane to Los Angeles, CA. At the beginning of the 2022-2023 school year (prior to grant end date 9/30/2022), students will plan and participate in a Showcase Event for their parents & community.

Staffing: Extra duty pay + fringe for teachers, for each day of travel (\$1120).

Supplies: Showcase Event includes invitations, signage/banners, brochures for promoting programs/courses, supplies for activities, portfolio, & video (\$1600).

Travel (Out-of-state): Registration, air travel and luggage, hotel, meals, and ground transportation for 7 students and 2 teachers (\$12,350).

Total Expenses Summer Program 2: \$1120 + \$1600 + \$12,350 = \$15,070

Total direct costs: \$7,140 + \$15,070 = \$22,210

Arlington ISD actively seeks additional funding streams and sustainability for programs. We will maximize local funding, grants, and partnership investments to increase the capacity and impact CTE programs. AISD is fully committed to providing programs that lead to increased student success, and will identify additional philanthropic investors to support programs over time. Currently, no funds are allocated to similar summer programs. To meet future needs of students, assessments will be made based on feedback from students, staff, administrators, and partners for each program element, with adjustments made as necessary. At the end of the program, a final evaluation will be made based on feedback from stakeholders to assess effectiveness for future programmatic and financial needs.

One of the grant program objectives is to increase enthusiasm for the Hospitality & Tourism career pathway by having the six students who attend Summer Program 1 create a portfolio and share it creating a portfolio and sharing it at a showcase event with other AISD students, staff, and community partners. This objective will be measured by the course enrollment in the Hospitality and Tourism pathway as well as an increase in the number of students entering the industry after high school.

During the 2021-22 school year, AISD had 932 students enrolled in courses in the Hospitality & Tourism career pathway (PEIMS, 2022). These courses include Principles of Human Services (CC1250), Travel and Tourism Management (CC1253), and Hospitality Services (CC4253).

Summer Program 2- Design and Multimedia Arts: Fashion Design aligns with the Fashion Design program of study. One of the grant program objectives is to increase enthusiasm for the Fashion Design career pathway by having the seven students who attend Summer Program 2 create a portfolio and share it at a showcase event with other AISD students, staff, and community partners. This objective will be measured by the course enrollment in the Fashion Design pathway as well as an increase in the number of students entering the industry after high school.

During the 2021-22 school year, AISD had 427 students enrolled in courses in the Fashion Design career pathway (PEIMS, 2022). These courses include Fashion Design I (CC1256) and Fashion Design II (CC4257).
