Jubilee Academies will grow the Career and Technical Education (CTE) programs, and work-based learning opportunities in collaboration with business industry partners. The Jubilee CTE Program provides work-based learning opportunities for students, and offers end of program industry certifications along with recognized postsecondary credentials. Jubilee Academies needs to enhance and develop more robust work-based opportunities. Due to COVID limitations in the workforce, the number of work-based learning opportunities have been extremely restricted. By enhancing the current CTE programs partnerships, Jubilee Academies will increase student interest and enrollment to enhance program alignment, internships, practicums and job shadow opportunities, it is expected that there will be: (1) increased access and opportunity for all students to participate in career awareness and exploration activities in early grades (2) Increase access and opportunity for all students to participate in high-quality capstone work based learning experiences aligned to regional labor market conditions (3) Encourage deeper connections between business and education by developing an intermediary network (4) Students will develop and demonstrate employable skills as defined by the Employability Skills Rubric.

Currently Jubilee Academies has 10 students enrolled in Animation and Graphic Design Practicum courses. The summer program will help increase enrollment in this specific programs of study.

Enrollment in the 2022 summer CTE work-based learning program will increase by 50% compared to the regular 2021-22 academic year and 25% of the participants in the CTE summer project based learning program will test in an industry-based certification recognized by TEA. Jubilee Academies will provide work-based learning opportunities and aligned curriculum with the programs of study requirements, while expanding opportunities for CTE concentrators to participate in accelerated learning opportunities. All students will have an opportunity to earn an industry certification with the programs of study that meet the needs of high-skill, high-wage, and in-demand occupations. During the summer program, high school students will collaborate with industry partners from The Arts, Audio Visual and Technology clusters focused on project-based learning projects utilized in local businesses. Through partnership with local industry-based providers, like The Alamo Arts Academy, students will create marketing materials using industry-aligned software programs and provide students with a global awareness of post-secondary opportunities within the industry-based field of study provided during this summer program.

Students will have access to industry aligned software to assist in skills attainment to successfully develop marketing materials. Performance measurement will be defined and scored by the industry-based partner using a capstone product at the conclusion of the summer program. Also, measures using the TEA data from the Employability Rubric will be analyzed. Additionally, students will also have access to test prep material focused on industry-based credentials recognized by the TEA. Industry - based certification completion rate will be monitored using Jubilee Academies College, Career and Military readiness Tracking Tool increasing CCMR Accountability. Summer enrollment targets will be measured based on completion of the summer CTE program in the grant funded areas of study.

The CTE summer program will require funds for staffing position (teacher) to support increased work-based learning opportunities. Supplies and materials purchased will increase access and opportunities for students to participate in the capstone experience. Additionally, travel expenses will support transportation needs to and from the business industry facilities. Lastly, the budget does include capital outlay items, poster printers, to increase skill set and student engagement. During the 2022 summer program, Jubilee Academies will be using stacked funding sources to include Perkins funding, , ESSER III funding, and State Comp Education funds. In the future, Jubilee Academies plans to continue to grow the CTE programs and create a more robust summer program by increasing student interest and success.

Through this model, Jubilee Academies will provide increased access for all students to participate in high quality capstone work-based learning experiences that are aligned to regional labor market needs.
