It is mutually understood and agreed by and between the undersigned contracting parties of the above numbered contract to amend said contract effective September 1, 2016 as follows:

TEA shall continue to receive Services in connection with the Contract Project during the period beginning September 1, 2016 through August 31, 2018 at the fees, terms, and conditions as specified in the Original Contract with no changes, except as addressed below:

Texas Government Code §572.069. CERTAIN EMPLOYMENT FOR FORMER STATE OFFICER OR EMPLOYEE RESTRICTED. A former state officer or employee of a state agency who during the period of state service or employment participated on behalf of a state agency in a procurement or contract negotiation involving a person may not accept employment from that person before the second anniversary of the date the officer's or employee's service or employment with the state agency ceased.

**Additional Terms.** The parties mutually agree that the original agreement is further amended as follows:

1. In General Provisions, **Paragraph I, Public Information**, the following paragraph is appended to the end of the provision:


The parties expect that this Contract will not require the creation or exchange of information that is not excepted from disclosure under the Texas Public Information Act; however, if and only to the extent that this Contract does require the creation or exchange of such information, Contractor agrees to make all such information available to TEA for no additional charge in a format that is accessible by the public. Unless otherwise specified elsewhere in this Contract, the required format for the information will be an electronic flat file that can be (and, upon request from TEA, will be) delivered by Contractor and received by TEA through the parties' normal contact email addresses.

2. In General Provisions, **Paragraph L, Excluded Parties List System**, the referenced web addresses have been updated to <http://www.whitehouse.gov/briefing-room/presidential-actions/executive-orders> and <http://www.sam.gov>, respectively.
3. In General Provisions, **Paragraph O, Audit**, the section number of the Texas Government Code is changed from Section 2262.003 to 2262.154.

All other terms and conditions of the original contract remain the same and are incorporated herein as if specifically written.

It is agreed and accepted by a person authorized to bind Contractor that all terms and conditions of this amendment are effective commencing on the above date.
