It is mutually understood and agreed by and between the undersigned contracting parties of the above numbered Contract to amend said Contract effective September 1, 2017 as follows:

ARTICLE II. PERIOD OF CONTRACT

TEA is exercising the option to renew Contract from September 1, 2017 to August 31, 2018, first renewal.

ARTICLE III. PURPOSE OF CONTRACT

Contractor will continue to provide support to home-based secondary migrant students by aligning Portable Assisted Study Sequences (PASS) courses and course work to the Texas Essential Knowledge and Skills (TEKS) along with any new course development, revised Description of Services/Budget, Appendix One, attached and incorporated by reference.

ARTICLE V. GENERAL AND SPECIAL PROVISIONS OF CONTRACT


Updated Contract Terms and Conditions are attached and incorporated herein.

Special Provisions C, Lobbying (required if utilizing federal funds & over \$100,000)

Texas Government Code §2252.901 prohibits the agency into entering into an employment contract, a professional services contract, or a consulting services contract with a former or retired TEA employee before the first anniversary of their last date of regular employment. If TEA enters into a "professional services" contract with a corporation, firm, or other business entity that employs a former or retired employee during the first year of the past employee's departure from the agency, the former or retired employee is restricted from performing services on projects that the employee worked on while employed at TEA.

Effective January 1, 2017, the mileage reimbursement rate is 53.5¢. The Comptroller's website for travel rules and regulations - textravel: <https://fmx.cpa.state.tx.us/fmx/travel/textravel/index.php>. Receipts must be made available for programmatic or financial audit, by TEA and by others authorized by law or regulation to make such an audit, for a period of not less than seven (7) years. All other terms and conditions of the original contract and amendments remain the same and are incorporated herein as if specifically written. It is agreed and accepted by a person authorized to bind Contractor that all Terms and Conditions of this Amendment are effective commencing on the above date.
