### Discussion of Educator Testing Contract and Request for Proposal

#### **DISCUSSION**

**SUMMARY:** This item provides an update to the State Board for Educator Certification (SBEC) on activities completed by staff to date as relates to the request for proposal (RFP) for the next four-year educator testing contract.

BACKGROUND INFORMATION AND SIGNIFICANT ISSUES: At the December 9, 2016 SBEC meeting, the TEA provided the Board with an update on the educator certification testing program. ETS is the main testing vendor for the Texas certification program, and the most recent testing contract ended on August 31, 2016. The agency has been able to utilize both one-year contract extensions to maintain test administration activities and continue priority test development work through August 31, 2018, while also anticipating the award of the next four-year testing contract in spring of 2018.

Following issuance of the contract award, TEA staff will present a discussion item at the May 18, 2018 meeting to provide the Board with additional information and key activities planned over the next four years that align with the Board's certificate structure redesign framework and the agency's strategic priority to recruit, support, and retain teachers and principals.

The focus of those activities will center around:

- stronger educator preparation for candidates that aligns with SBEC-adopted educator standards.
- rigorous and relevant examinations that better prepare candidates for the first day in their roles, and
- proactive steps by agency staff, educator preparation programs, and local education agencies to support certification candidates throughout the process and align efforts to retain certified educators and administrators in their key roles.

Attachment I includes a timeline of activities completed to date as relates to the RFP for the next four-year educator testing contract. It should be noted that all dates except the completion date may vary slightly as conditions require. Attachment II provides a visual graphic of the roles and responsibilities of the SBEC, TEA staff, EPPs, the commissioner, and contracted vendor(s) in ensuring the educator certification testing program and all components critical to its success are established, executed, and evaluated in a timely manner.


