Data Spotlight: Outcomes-Based Measures for 2020-2021 Designation

Aggregate Metrics of Success for ECHS Students in Texas

INTRODUCTION

Annually, The Texas Education Agency (TEA) provides to Early College High School (ECHS) program leaders data relating to the outcomes-based measures (OBM) of students at their campus. The OBM data indicators are defined in the state's [2020-21 ECHS Blueprint](#).

This Data Spotlight provides state aggregates of each OBM data indicator so that ECHS leaders may compare their students' success to the state average as they strive for continuous improvement in implementing effective school models. The data set was pulled in the spring of 2020 and contains all students who were coded as ECHS in PEIMS. This data set was used for the 2020-21 designation year and schools received campus-based reports for programmatic improvement purposes.

ECHS DATA SET

A total of 176 ECHS campuses are included in the data set used for 2020-21 designation. ECHS campuses are classified according to their maturity level. Campuses in operation for four or fewer years are considered Provisional and must meet OBM for Provisional ECHS. Campuses who have graduated their first 9th grade cohort and are in their 5th or greater year of operation are Designated and must meet Designated OBM. For the purposes of this report, all ECHS campuses serving students (Provisional and Designated) are included in the Enrollment data set which aligns with the Access Domain.

The subset of ECHS in operation for 5+ years have been included in the evaluations for OBM metrics relating to the Attainment and Achievement domains.

4 or Fewer Years (Provisional) = 39 campuses; 8,395 students in grades 9-12

5+ Years (Designated) = 137 campuses; 56,548 students in grades 9-12



ACCESS OBM

Provisional campuses must meet one Access OBM data indicator: 1) ECHS are proportionate to or over-represents at-risk incoming 9th graders.

Designated campuses must meet two Access OBM data indicators: 1) ECHS are proportionate to or over-represents at-risk incoming 9th graders, 2) ECHS are proportionate to or over-represents economically disadvantaged students.

ATTAINMENT OBM

Provisional campuses must meet state targets on three (3) Attainment OBM data indicators: 1) College English, 2) College Math, and 3) 15 college credits. Note: This requirement changed in the [2020-21 ECHS Blueprint](#). Moving forward, Provisional campuses must meet state targets for the following: 1) persistence, 2) 9 college credits by the end of 10th grade, and 3) 15 college credits.

Designated campuses must meet state targets on at least five (5) Attainment OBM data indicators.

New OBM data indicators were introduced in the [2020-21 ECHS Blueprint](#). Benchmark data used to set the OBM targets has been provided in the table below and should be considered preliminary.

ACHIEVEMENT OBM

Provisional campuses must meet state targets on at least three (3) Achievement OBM data indicators:

Designated campuses must meet state targets on at least four (4) Attainment OBM data indicators.

New OBM data indicators were introduced in the [2020-21 ECHS Blueprint](#). Benchmark data used to set the OBM targets has been provided in the table below and should be considered preliminary. Note: Texas has changed the TSI Assessment and college readiness OBM for Writing and all 3 subjects will no longer be calculated moving forward.

POSTSECONDARY CREDENTIAL

The statewide average for postsecondary completion (Associate, Level 1, and Level 2 credentials) for those enrolled in a Designated ECHS is 40.3%. 71 ECHS campuses met or exceed this state average. The table below includes ECHS whose rate meets or exceeds 75%.
