Each speaker will be allowed three minutes to speak, and each speaker will be allowed to speak only once. Speakers may not yield their time to another speaker. CAC members are restricted by the Open Meetings Act from providing detailed responses to comments not related to topics on the notice. Members of the public may also submit comments to the CAC in writing.

1. TEA will present information to the CAC about significant disproportionality.
2. TEA will present the draft corrective action plan resulting from OSEP's findings, and the CAC will advise TEA in developing its corrective action plans to address findings identified in the January 11, 2018, federal monitoring report.


3. CAC will determine meeting dates for the rest of the calendar year.
