What's New in Performance Reporting

A–F Development

This week we have received several questions about how English learners in their third or fourth year of monitored status will be included in the Closing the Gaps domain. The third and fourth year monitored status for English learners is not available in TSDS PEIMS for 2018. For 2018 accountability, Performance Reporting will build a proxy that identifies students who are in their third or fourth year of monitoring based on when they were reported in their first and second year of monitoring in TSDS PEIMS in prior years.

For 2019 accountability, TSDS PEIMS codes will be available to identify student in their third or fourth year of monitoring.

Agency staff and members of the local accountability system pilot program continue to work together to develop a framework for the new system. Subcommittees have started meeting to discuss possible options for indicators in specific areas identified by the pilot program participants in January. The next work session for the 20 districts and charters in the pilot program will be in February. One representative from each district or charter will attend this work session.

Assessment Scoring and Reporting Update

December 2017 STAAR EOC preliminary statewide reports are now available here.

To ensure that state and federal reporting of assessment data is delivered error-free, accurate and consistent records must be maintained for all students who take the STAAR. The window for resolving data problems for the December 2017 STAAR EOC administration closes on January 26, 2018, and all changes submitted by this deadline will be reflected in the final region and state reports, which will be posted in February.

Districts may continue to resolve student data problems for up to one year after each test administration. Districts that resolve problems after the January 26, 2018, deadline will receive updated STAAR Report Cards and data files, but changes will not be reflected in statewide reports.

This Week's FAQ

What is an alternative education campus (AEC)? How do campuses register to be evaluated under alternative education accountability (AEA) provisions?

Alternative education campuses (AECs) are those that serve students at risk of dropping out of school as defined in Texas Education Code §29.081(d). To be eligible to be evaluated under AEA provisions, an AEC must meet the criteria outlined on pages 70–71 in "<u>Chapter 6 – Other Accountability System Processes</u>" of the <u>2017 Accountability Manual</u>.

Alternative education accountability registration for 2018 accountability opens on March 26, 2018, and closes on April 6, 2018. Eligible districts and campuses can file an AEA Campus Registration Form using the TEASE Accountability website. Filing an AEA Campus Registration Form is required for each AEC that wishes to be evaluated by AEA provisions in 2018 and is not on the list of pre-registered AECs. Eligible

AECs rated under AEA provisions in 2017 are pre-registered. A charter district or campus that was evaluated under AEA provisions in 2017 and does not wish to be evaluated under AEA provisions in 2018 should file an AEA Campus Rescission Form using the TEASE Accountability website.
