#### **A-F Development**

# **Industry Certification Reporting Reminder**

As reported in the November 17 bulletin, the Texas Student Data System (TSDS) PEIMS application will be updated today to allow the reporting of the completion of first, second, and third postsecondary industry certifications or licensures for 2017 students who graduated on the minimum, recommended, or distinguished achievement high school programs. If you have completed your Fall PEIMS First Submission, you may submit the additional data in the Fall PEIMS Resubmission due January 18, 2018. If you have not completed your Fall PEIMS First Submission, you can load this data for all graduates starting December 2, 2017.

## This Week's FAQ

How are STAAR results for grade 5 and 8 re-testers included in accountability calculations?

For students in grades 5 and 8, accountability calculation will include test results for reading and mathematics from the first administration and the first re-test administration of all STAAR test versions.

The STAAR reading and mathematics test results from the first (April) and second (May) administrations are processed in two steps. First, the best test result from both administrations is identified. If both test results have the same performance level, the most recent test result is used for calculation. Second, the accountability subset rules determine whether the test result is included in the performance index. Grades 5 and 8 results from the summer testing administration (June) are not used in accountability ratings.
