College Admissions Testing Participation Results for Graduating Seniors in Texas Public Schools, Class of 2011

This report presents SAT and ACT examination participation data for graduating seniors in Texas public schools. College admissions examination results are used by colleges and universities to make admissions decisions, to place students in appropriate freshman courses, and to award scholarships to students. In Texas, moreover, public school results are used in determining eligibility for student exemptions from Texas Success Initiative assessment requirements and to acknowledge districts and campuses through the public school accountability system for high levels of performance.

Under the Gold Performance Acknowledgment (GPA) system, which was in effect through 2011, the SAT/ACT indicator had two components: (1) the percentage of non-special education graduates tested; and (2) the percentage of graduating examinees receiving SAT critical reading and mathematics combined scores of at least 1110 or ACT composite scores of at least 24 (Texas Education Agency [TEA], 2011; Texas Education Code §39.0721, 2007).

Results presented in this report are based only on the most recent examinations taken by students identified by the College Board and ACT, Inc., as expecting to graduate in the reporting year. For additional information about SAT and ACT examinations and results reported by the TEA Division of Research and Analysis, including definitions of terms and explanations of calculations, please see College Admissions Testing General Information, Class of 2011 (TEA, 2014a) and College Admissions Testing Glossary of Terms, Class of 2011 (TEA, 2014b). SAT and ACT performance results for Texas public schools are presented in the report College Admissions Testing Performance Results for Graduating Seniors in Texas Public Schools, Class of 2011 (TEA, 2014d). Results for Texas public and nonpublic schools combined are presented in the report College Admissions Testing of Graduating Seniors in Texas and the United States, Class of 2011 (TEA, 2014c).

Participation Results for Texas Public Schools: SAT and ACT Combined

- A total of 182,281 Texas public high school graduates in the class of 2011 took the SAT, the ACT, or both examinations, an increase of 22,593 graduates from the previous class (Table 1). The overall participation rate for the class of 2011 (68.9%) was 6.3 percentage points higher than the rate for the class of 2010 (62.6%) (Table 1 on this page and Figure 1 on page 4).
- Among graduates in the class of 2011, Asians had the highest participation rate, at 96.2 percent, followed by multiracial students (76.9%), African Americans (76.0%), Whites (74.9%), Pacific Islanders (69.8%), American Indians (65.7%), and Hispanics (59.0%) (Table 2).



Participation Results for Texas Public Schools: SAT

- A total of 147,960 graduates in the class of 2011 took the SAT examination (Table 5). The participation rate for the class of 2011 (56.0%) was 7.7 percentage points higher than the rate for the class of 2010 (48.3%).
- Among graduates in the class of 2011, Asians had the highest SAT participation rate, at 89.7 percent, followed by multiracial students (66.8%), African Americans (63.0%), Whites (62.1%), Pacific Islanders (60.2%), American Indians (54.2%), and Hispanics (45.3%) (Table 6).



Participation Results for Texas Public Schools: ACT

- A total of 91,943 graduates in the class of 2011 took the ACT examination (Table 8). The participation rate for the class of 2011 (34.8%) was 2.1 percentage points higher than the rate for the class of 2010 (32.7%).
- Among graduates in the class of 2011, Asians had the highest ACT participation rate, at 41.1 percent, followed by Whites (39.4%), African Americans (38.0%), multiracial students (36.5%), American Indians (32.2%), Pacific Islanders (30.5%), and Hispanics (29.2%) (Table 9 on page 10).




Figure 3 Graduating Seniors and ACT Examinees, by Race/Ethnicity, Texas Public Schools, Class of 2011
