## **INTRODUCTION**

The Texas Education Agency (TEA) would like to extend appreciation to Brazosport ISD for their efforts, attention, and time committed to the completion of the review process.

The TEA has developed a monitoring approach that reviews compliance-based indicators while also looking for best practices. In commitment to the approach, the cyclical monitoring report will provide the results of the LEA's compliance review related to the Individuals with Disabilities Education Act (IDEA) and federal and state statutes, a summary of data related to Results-Driven Accountability (RDA), State Performance Plan (SPP), Significant Disproportionality (SD), and dyslexia program evaluation will recommend targeted technical assistance and support for LEAs related to special education, and highlight best practices of LEAs that demonstrate success.

## **CYCLICAL MONITORING**

The TEA conducts cyclical reviews of all LEAs statewide over six years. The purpose of cyclical monitoring is to support positive outcomes for students with disabilities and to determine compliance with special education regulations and dyslexia program regulations.

LEAs are required to submit artifacts and/or sources of evidence for compliance and promising practices review in the following areas:

- Child Find/Evaluation/FAPE
- IEP Development
- IEP Content
- IEP Implementation
- State Assessment
- Properly Constituted ARD Committees
- Transition

## 2020–2021 CYCLICAL REVIEW COMPLIANCE SUMMARY

On December 18, 2020, the TEA conducted a policy review of Brazosport ISD. On February 25, 2021, the TEA conducted a comprehensive desk review of Brazosport ISD. The total number of files

reviewed for the Brazosport ISD comprehensive desk review was 24. The review found overall that 24 files out of 24 files were compliant. An overview of the policy review and student file review for Brazosport ISD are organized in the chart below by indicating the number of compliant findings within the reviewed file submissions related to the compliance area. ## 2020–2021 DYSLEXIA COMPLIANCE SUMMARY

The dyslexia monitoring process focuses on three-core elements: early identification and intervention, program of instruction, and parent notification. The TEA Department of Review and Support: Dyslexia Monitoring reviewed Brazosport ISD artifacts using a program evaluation protocol which is aligned to Senate Bill 2075 of the 86<sup>th</sup> Legislature, Texas Education Code (TEC) 38.003 (c-1), and 19 Texas Administrative Code (TAC) Chapter 74.28. The 2020-2021 school year results for Brazosport ISD are in the table below.

## 2020-2021 COVID-19 IMPACT NARRATIVE

In the 2020-2021 academic year, Local Education Agencies (LEAs) were provided an opportunity to complete a COVID-19 impact narrative form documenting the practices incorporated to support Child Find and FAPE for students being served by special education programs during the COVID-19 pandemic.

# 2020-2021 CYCLICAL REVIEW PARENT, TEACHER, ADMINISTRATOR INTERVIEWS/SURVEY

## **Staff and Family Surveys**

March 31, 2021, the TEA Review and Support team received 60 surveys during the comprehensive desk review. The Review and Support surveys focused on the following review areas:

- 55% of respondents feel they receive sufficient communication from their school such as weekly updates/emails/newsletters to stay connected.
- Majority of respondents reported that the best way their school/district provides information (trainings, online trainings, support groups and other available resources) concerning special education services are through email, social media, and the school website.
- Majority of respondents reported feeling comfortable attending special education information sessions or trainings if offered at the school campus.
- All respondents reported having a clear understanding of special education services and supports.
- Majority of respondents reported wanting to learn more about Child Find and Evaluation, Tiered Interventions using Evidenced-Based research (TIER) and Texas Sensory Support Network (TxSSN).
- Respondents reported the following trainings as most effective:
  - Positive Behavioral Supports
  - Using accommodations and modifications
  - English Language Proficiency Standards (ELPS)

- Majority of respondent somewhat agreed that there are frequent opportunities to collaborate and plan with related service providers.
- Respondents noted that they have endured the following obstacles during their students' special education programming and services:
  - Assuring students receive accommodations and/or modifications as outlined in the IEP.
  - Knowledge of available services and programming
- Over 80% of respondents reported that they either agree or strongly agree that they understand the importance of including the student's interests/life goals in the transition process.
- 70% of respondents reported that during COVID school closures/remote learning they were aware of an Emergency Contingency Plan effective for students' progress.
- During the COVID school closures/remote learning students with moderate to severe disabilities were supported through:
  - Teachers providing supports needed for students to be successful.
  - Teachers making regular contact with students and parents to meet emotional and academic needs.
  - Teachers modifying work.
- During COVID school closures/remote learning, respondents reported the following professional development needs to specifically address the needs of students with disabilities:
  - How to teach virtually
  - How to use virtual platforms
  - How to engage students and assess levels of engagement
- During COVID school closures/remote learning, respondents reported the following strategies used by the district for remote learning did not work well for students with disabilities:
  - Shared device per family
  - Online submission of assignments
  - Drive through packet pick up and drop off.
- 50% of respondents reported that during COVID school closures/remote learning, school staff worked with parents/guardians in addressing severe behavior and work refusal.
- Over 90% of respondents reported that for the 2020-2021 school year they opted for an inperson learning model.
- 33% of respondents reported that they found remote learning to be somewhat effective.

This survey was approved by the Texas Education Agency's data governance board. Participation in this survey was both voluntary and anonymous. No data was collected identifying a name so that individual responses cannot be linked to any respondent. Participants were given the option to stop the survey at any time.

#### There were 22 interview participants.

The Review and Support interviews focused on the following review areas:

- Communication and collaboration
- Implementation of Special Education Services
- Monitoring effectiveness

Brazosport ISD programming options focus on the coteach model w/the understanding that campuses will choose the LRE. When discussing the continuum of special education programs offered on campuses, the general education teachers were most enthusiastic about the co-teach setting. Principals communicated that data reports provided by district staff are helpful with the planning process for academic interventions and specialized instruction.

#### **Communication and Collaboration**

Master Schedule planning enables a collaborative planning period for Co-Teachers. PLC time also provides additional time in the workday to plan with grade level/subject area general education teachers. Overall, the general education teachers feel the Special Education staff are supportive and had positive comments regarding special education programming in Brazosport ISD. The general education teachers reported the training provided by the district and at campus level has been useful and informative.

#### Implementation of Special Education Services

All general education teachers understand the process to print the BOY bundles from Esped software. Teachers indicated they liked the way the data was delivered, they appreciated being given ample notification of upcoming ARD meetings, giving them time to prepare IEP documents and gather work samples. Many teachers indicated several of their students were active in extracurricular activities. Sentiment was shared by a parent who discussed the inclusivity of students with disabilities has boosted her son's confidence and provided "why" for him getting out of bed every day. There is a shared sense of caring about the day-to-day aspects of work and students with disabilities.

#### **Monitoring Effectiveness**

Collaboration between special education and general education teachers help to ensure implementation of the IEP with fidelity, and that student needs are being addressed. Consistent feedback that indicates Brazosport ISD teachers are student focused, LRE is data driven, and collaborative teaching models are utilized resulting in continued student progress and academic achievements. Many accolades were given to individual case managers, but the consensus is that Brazosport ISD truly puts students first; working in hand in hand with teachers, administrators, and parents to ensure students receive the academic, social-emotional, and behavioral supports they need to be successful.

#### **Strengths**

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following strengths for Brazosport ISD:

• IEP meeting notices are sent well in advance of the IEP. This allows ample time to change the meeting date (if needed) and still meet annual timelines.

• The ARD committee addresses state assessment and necessary accommodations for state testing in the IEP.

#### **Considerations**

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following considerations for Brazosport ISD:

• In addition to the use of behavior data in IEP development, ARD committees continuously evaluate implementation of student behavior goals, and problem solve implementation challenges to minimize student disciplinary removals.

## FINDINGS OF NONCOMPLIANCE

A finding is made when noncompliance is identified with the Review and Support report findings, SPP notification, and/or individualized education program (IEP) requirements. Noncompliance that is systemic in nature must be included in a comprehensive corrective action plan (CAP) with action steps to address each of the noncompliance findings. *When noncompliance has been identified as part of this cyclical review, Brazosport ISD will receive formal notification of noncompliance in addition to this report.* 

The TEA Department of Review and Support will further advise the LEA on the corrective action process, if applicable.

The TEA follows procedures for the correction of noncompliance consistent with federal guidelines (OSEP Memo 09-02.)

Before the TEA can report that noncompliance has been corrected, it must first verify the LEA:

- Has corrected each individual case of noncompliance (Prong 1); and
- Is correctly implementing the specific regulatory requirements (i.e., subsequently achieved 100% compliance) (Prong 2).

The TEA is required to monitor the completion of a corrective action plan if any noncompliance is

discovered. The corrective action plan must be designed to correct any and all areas of noncompliance *as soon as possible, but in no case later than one year from the date of notification.* 

## **Corrective Action Plan (CAP)**

The LEA will develop a CAP to address any items identified as noncompliance in this summary report. An approved form for the CAP can be accessed on the Review and Support website or in the resources located in Ascend Texas.

The LEA must submit the CAP in Ascend within 30 school days from the date of this report and/or formal notification of noncompliance. The TEA will review the CAP submitted by the LEA for approval. If the TEA determines that a revision(s) is necessary, the LEA will be required to revise and resubmit. The Review and Support team will contact the LEA to provide notification when the CAP has been approved.

## **Individual Correction**

The educational agency has **60 school days** from the date of this summary report to correct all identified findings of noncompliance for individual students, unless noted otherwise in the report.

## **2020–2021 DYSLEXIA PROGRAM EVALUATION FINDINGS**

As a result of the program evaluation review, the TEA Department of Review and Support: Dyslexia Monitoring has identified the following strengths, considerations, and technical assistance recommendations for Brazosport ISD.

#### **Corrective Action**

The TEA reviews data collected from the dyslexia program evaluation to ensure compliance with federal and state regulatory requirements. In accordance with Senate Bill 2075 of the 86<sup>th</sup>. Legislature, TEC 38.003 (c-1), and 19 TAC 74.28 regarding noncompliance identified through the dyslexia program evaluation, a finding of noncompliance is identified by the citation (i.e., program or process) that is violated.

#### **Dyslexia Performance Plan (DPP)**

If noncompliance is identified, the LEA is required to demonstrate correction of all noncompliance in the Dyslexia Performance Plan (DPP). This tool guides LEAs through a continuous improvement process. It addresses areas of growth that will positively impact students with dyslexia or other related disorders. LEAs should complete the DPP no later than 120-days after receiving notification of noncompliance.
