INTRODUCTION

The Texas Education Agency (TEA) would like to extend appreciation to Cayuga ISD for their efforts, attention, and time committed to the completion of the review process.

The TEA has developed a monitoring approach that reviews compliance-based indicators while also looking for best practices. In commitment to the approach, the cyclical monitoring report will provide the results of the LEA's compliance review related to the Individuals with Disabilities Education Act (IDEA) and federal and state statutes, a summary of data related to Results-Driven Accountability (RDA), State Performance Plan (SPP), Significant Disproportionality (SD), and dyslexia program evaluation recommend targeted technical assistance and support for LEAs related to special education, and highlight best practices of LEAs that demonstrate success.

CYCLICAL MONITORING

The TEA conducts cyclical reviews of all LEAs statewide over six years. The purpose of cyclical monitoring is to support positive outcomes for students with disabilities and to determine compliance with special education regulations and dyslexia program regulations.

2020–2021 CYCLICAL REVIEW COMPLIANCE SUMMARY

On April 22, 2021, the TEA conducted a policy review of Cayuga ISD. On May 28, 2021, the TEA conducted a comprehensive desk review of Cayuga ISD. The total number of files reviewed for the

Cayuga ISD comprehensive desk review was 19 files. The review found overall that 18 files out of 19 files were compliant. An overview of the policy review and student file review for Cayuga ISD are organized in the chart below by indicating the number of compliant findings within the reviewed file submissions related to the compliance area. 2020–2021 DYSLEXIA COMPLIANCE SUMMARY

For the 2020-2021 school year, the Texas Education Agency (TEA) identified Cayuga Independent School District (ISD) for dyslexia monitoring based on the Differentiated Monitoring and Support Cyclical Schedule. The dyslexia monitoring process focuses on three-core elements: Early Intervention and Identification, Program of Instruction and Parent Notification. The TEA Department of Review and Support: Dyslexia Monitoring reviewed Cayuga ISD artifacts using the Dyslexia Program Evaluation Rubric which is aligned to Senate Bill 2075 of the 86th Legislature, Texas Education Code (TEC) 38.003 (c-1), and 19 Texas Administrative Code (TAC) Chapter 74.28. 2020-2021 COVID-19 IMPACT NARRATIVE

In the 2020-2021 academic year, Local Education Agencies (LEAs) were provided an opportunity to complete a COVID-19 impact narrative form documenting the practices incorporated to support Child Find and FAPE for students being served by special education programs during the COVID-19 pandemic.

2020-2021 CYCLICAL REVIEW PARENT, TEACHER, ADMINISTRATOR INTERVIEWS/SURVEY

Staff and Family Surveys

On June 30, 2021, the TEA Review and Support team received 17 surveys. The Review and Support surveys focused on the following review areas:

53% percent of participants felt they receive sufficient communication from their school. The best way the school/district provides information about (trainings, online pieces of training, support groups, and other available resources) concerning special education services is from notifications sent home, phone calls, and emails.

The majority of parent/family member participants felt they would be most comfortable attending special education information sessions at the school campus.

Approximately 40% of participants indicated they have a clear understanding of special education services.

The most selected areas of special education the participants would like to know about were Small and Rural Networks.

The obstacles concerning student's special education programming and services were reported as:

- Assuring students receive accommodations and/or modifications as outlined in the IEP.
- Scheduling ARD meetings
- Timely updates on student progress
- Knowledge of available services and programs

Almost 90% participants agree with the importance of including students' interests/life goals in the transition process, with nearly 45% strongly agreeing.

The majority of participants indicated they chose the in person learning model. Most participants also

reported that remote learning for students receiving special education was almost evenly split between effective and ineffective.

COVID

Slightly less than 50% of participants felt that during COVID school closure/remote learning, the Emergency Contingency Plan effectively improved student progress.

During COVID closures, the top three ways indicated that teachers provided support to students with moderate to severe disabilities were:

- Teachers provided supports needed for students to be successful.
- Teachers made regular contact with students and parents to meet academic and emotional needs.
- Teachers modified work and provided individualized support.

Participants indicated that during COVID school closure/remote learning, the district's top two supports that didn't work well for students with disabilities were shared devices for families and the online submission of assignments for students.

More than 50% of participants indicated that they agree the school staff worked with parents/guardians in addressing severe behavior and work refusal.

This survey was approved by the Texas Education Agency's data governance board. Participation in this survey was both voluntary and anonymous. No data was collected identifying a name so that individual responses cannot be linked to any respondent. Participants were given the option to stop the survey at any time.

Strengths

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following strengths for Cayuga ISD:

- Contingency plans related to COVID-19 were consistently present in the submitted IEPs.
- Consistent documentation of Extended School Year (ESY) considerations was present in all student folders.
- Evaluations are completed within the timeframes as expected and conducted with a multidisciplinary team approach...
- Intensive programs of instruction are identified for students who do not meet standards on the state assessment...
- The desk review summary shows that all policies and compliance areas meet the state and federal regulations...

Considerations

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following considerations for Cayuga

ISD:

- Consider developing a system to provide additional training on developing data-rich Present Levels of Academic Achievement and Functional Performance (PLAAFP) statements to reflect a holistic approach to reporting the student's current performance.
- Consider developing an internal review process to ensure clerical errors are caught and addressed before formally accepting an IEP.

FINDINGS OF NONCOMPLIANCE

A finding is made when noncompliance is identified with the Review and Support report findings, SPP notification, and/or individualized education program (IEP) requirements. Noncompliance that is systemic in nature must be included in a comprehensive corrective action plan (CAP) with action steps to address each of the noncompliance findings. When noncompliance has been identified as part of this cyclical review, Cayuga ISD will receive formal notification of noncompliance in addition to this report.

The TEA Department of Review and Support will further advise the LEA on the corrective action process, if applicable.

The TEA follows procedures for the correction of noncompliance consistent with federal guidelines (OSEP Memo 09-02.)

Before the TEA can report that noncompliance has been corrected, it must first verify the LEA:

- Has corrected each individual case of noncompliance (Prong 1); and
- Is correctly implementing the specific regulatory requirements (i.e., subsequently achieved

100% compliance) (Prong 2).

The TEA is required to monitor the completion of a corrective action plan if any noncompliance is discovered. The corrective action plan must be designed to correct any and all areas of noncompliance as soon as possible, but in no case later than one year from the date of notification.

Corrective Action Plan (CAP)

The LEA will develop a CAP to address any items identified as noncompliance in this summary report. An approved form for the CAP can be accessed on the Review and Support website or in the resources located in Ascend Texas.

The LEA must submit the CAP in Ascend within 30 school days from the date of this report and/or formal notification of noncompliance. The TEA will review the CAP submitted by the LEA for approval. If the TEA determines that a revision(s) is necessary, the LEA will be required to revise and resubmit. The Review and Support team will contact the LEA to provide notification when the CAP has been approved.

Individual Correction

The educational agency has **60 school days** from the date of this summary report to correct all identified findings of noncompliance for individual students, unless noted otherwise in the report.
