- <u>Governor Abbott's closure order</u> was extended to the end of the 2019-20 school year. Please do not send updates on districts closings to <u>disasterinfo@tea.texas.gov</u>.
- The TEA COVID-19 Superintendent Call have moved to Tuesday and Thursday at 3:00pm. The call-in information has changed. Please use the call-in information sent via TEA's Superintendent Listserv on June 25, 2020.

Recap of topics covered:

- Guidance Related to Governor Abbott's Executive Orders
  - Governor Abbott's <u>Executive Order-28</u> paused the state's reopening plan, and <u>Executive Order-29</u> issued a face covering mandate on Friday, July 3.
  - Under the current phase of re-opening (phase III), on-campus instruction is still allowed.
  - We are in the process of updating TEA's plan for reopening schools and will provide an update as soon as possible. We appreciate your patience.
- Remote Instruction Guidance for SY 2020-2021
  - <u>Guidance</u> was updated as it relates to attendance and remote instruction for the upcoming school year.

- Messages to Promote a Safe 4<sup>th</sup> of July Holiday
  - Social media sample <u>messages</u> were provided for districts that wanted to promote a safe 4<sup>th</sup> of July holiday with their communities.
- Summary of Student Engagement in Virtual Learning in 2019-2020
  - A new <u>Summary of Student Engagement</u> was posted as a result of district efforts to engage <u>uncontactable students</u>.
- Supporting English Learners
  - A new English Learning Guidance document was posted to provide districts information for the upcoming 20-21 school year.

- Operation Connectivity
  - Superintendents and Chief Technology Officers were reminded to submit a survey to collect information on the number of students who do not have internet access and/or home devices to inform the efforts of the Operation Connectivity Task Force.
- Texas Home Learning
  - A new website was launched to facilitate registration for <u>Digital Speech</u> <u>Language Therapy</u>.
  - Reminder to learn more about <u>Texas College Bridge</u> to get information and resources for the Texas Summer Bridge program and get started!
  - Texas Home Learning has organized a list of high-quality Reading Language Arts extension materials available in both print and digital formats. July 31 is the last date for districts to order extension materials.
  - The Texas Home Learning 3.0 survey closed July 5
- Child Nutrition
  - The Pandemic Electronic Benefits Transfer (P-EBT) online application is now open and will remain open until Friday, July 31.
  - As of July 2, the Health and Human Services Commission has received applications for nearly 1.6 million Texas children.
  - Additional communications resources will be posted on July 7 to support districts with encouraging their families to apply.
  - The Texas Department of Agriculture has launched a <u>Meal Services: Fall</u> <u>Planning Resources</u> website.
    - The USDA issued five waivers allowing for federal flexibilities around meal patterns, group-setting requirements, meal service times, and parent/guardian pick-up of meals for kids across all three programs to address anticipated changes for the coming school year. These waivers allow:
      - Flexibilities to serve meals via grab-and-go or home delivery;
      - Parents/guardians may pick up meals without children/adult participants present when providing sufficient proof of guardianship;
      - *High* schools may serve pre-plated meals in non-congregate or classroom setting;
      - flexibility around National School Lunch Program meal service times; and
      - Allows operators experiencing supply chain issues to request a meal pattern waiver authorizing specific meal pattern components.
