## SY 20-21 Courses with On-Campus Needs or Supply Needs for Remote Learning

The following courses have been identified either with need for student access to on-campus equipment and supplies or to pick-up supplies and equipment that can be used in a remote setting.

ART	Virtual Instruction Possible?	On-Campus Required
Art, Level I Photography I-III	Yes, assuming appropriate supplies and equipment are available to the student for use in a remote setting.	No, however, students may need to pick-up supplies and/or equipment to complete coursework requirements.
Printmaking I-III Fibers I-III Ceramics I-III Sculpture I-III Jewelry I-III AP Studio Arts courses	Unknown. Students in these courses may be able to complete some course work in a virtual setting; however, some campus access for certain courses will likely be needed.	Students in certain media courses (listed at left) will likely need access to on- campus supplies and equipment that the student would not have access to elsewhere and would be unlikely to use in a remote setting.
MUSIC	Virtual Instruction Possible?	On-Campus Required
Music, middle school – high school	Yes, assuming students have access to either personal or district-supplied instruments for use in a remote setting.	Some band and orchestra students may own or lease personal instruments. However, many districts loan instruments for the year, or students may share instruments across classes. Percussionists will likely not own personal equipment and would need access to school equipment.
Music Production I and II	Unknown. Students in these courses may be able to complete some course work in a virtual setting; however, some campus access for certain courses will likely be needed.	Students may require access to district-owned equipment or software unless the district was able to provide remote access to software.
THEATRE	Virtual Instruction Possible?	On-Campus Required
Technical Theatre I-IV	Students in these courses may be able to complete some coursework in a virtual setting; however, campus access for certain required activities may be needed.	Students in these courses, will likely need some access to the campus and campus equipment, such as scene or costume shop and auditorium, in order to demonstrate proficiency.

## SCIENCE

Secondary Science courses	Virtual Instruction Possible?	On-Campus Required
Science, Grades 6-8 Biology Chemistry Integrated Physics & Chemistry Physics Aquatic Science Earth and Space Science Environmental Systems AP and IB Biology AP and IB Chemistry AP and IB Physics	Yes. Students are expected to engage in investigations, and this may be accomplished remotely. However, there are limitations on what can be done due to equipment, safety, and supervision concerns.	None of the science courses would require a student to be physically present in a classroom or laboratory. However, all of the courses have some equipment that students are expected to engage with. Generally, the equipment needs are more specialized in the secondary grades, and include things that would not be found outside of a school laboratory (e.g., glassware, microscopes, scales, test equipment, chemicals).

## PHYSICAL EDUCATION

Course(s)	Virtual Instruction Possible?	On-Campus Required
Team Sports	Some, but not all, content could be provided in a virtual setting.	Does not require an on- campus environment, but would require settings which could make maintaining social distancing requirements difficult (e.g., participating in team sport).
Adventure/Outdoor Education	Some, but not all, content could be provided in a virtual setting.	Requires access to activities/environments that may not be feasible outside a school or public setting (e.g., fishing, disc golf, volleyball).
