Action Item #1: Improving Teacher Preparation Subgroup Interest Form

By August 10, complete this Improving Teacher Preparation breakout selection form.

Additional Context: During our Improving Teacher Preparation working group time on August 25, we will have 5 topic areas to explore more deeply via 2 rounds of breakout discussion. These topics were determined by our working group's June 2 discussions, a review of research (e.g., data presented by the Commissioner in past Task Force meetings, articles sent in advance of the June 2 meeting), and a review of online stakeholder input collected through TEA's Teacher Vacancy Task Force website. We will try to accommodate the first and second choices of working group members, but that is not guaranteed. If we do not receive your breakout selection form by August 10, we will assign you to a subgroup so that we can ensure to get subgroup assignments emailed out by August 15.

Topic 1: Strengthen EPP/LEA Partnerships

- Pre-reading: Renewing Educator Preparation: High Quality Standards for Every Preparation Pathway
- Objective: Discuss current state of teacher preparation; identify policy recommendations that will strengthen EPP/district collaboration, so preparation is more closely aligned to the needs of the district and the realities of the teaching profession.

Topic 2: Provide consistent supports for new teachers

- Pre-reading: Education First: Ensuring High-Quality Teacher Talent How Strong, Bold Partnerships between School Districts and Teacher Preparation Programs are Transforming the Teacher Pipeline
- Objective: Discuss the ways new teacher supports vary within districts and between districts; articulate need for consistent/across-the-state mentor teacher training and induction support and explore best practices for potential policy recommendations.

Topic 3: Increase quality of teacher preparation to support teacher readiness and retention

- Pre-reading: National Council for Teacher Quality: Digging Deeper on Teacher Diversity
- Objective: Share effective program design strategies that Texas EPPs have employed and consider
 policy recommendations for scaling those best practices, including differentiating preparation,
 increased focus on SpEd, ESL, and Bilingual, and increase high quality pre-service practice.

Topic 4: Improve alternative certification pathway, particularly for candidates in teacher-of-record roles

- Pre-reading: Teach Plus: Teacher Recommendations for Improving Clinical Experience
- Objective: Review the alternative certification teacher pathway and the range of alternative certification providers. Identify best practices in supporting intern candidates as teachers of record and consider policy recommendations to improve the alternative certification pathway.



Topic 5: Implement incentives and reduce barriers for EPPs, teacher candidates, and potential candidates

- Pre-reading: NCTQ: How Are States Making Licensure Test Free to Aspiring Educators
- Objective: Explore opportunities for financial support of teacher candidates and mentor teachers while streamlining requirements. Identify policy recommendations that reduce barriers for candidates seeking high quality preparation.
