# Discussion of Educator Preparation Program Complaints for 2021-2022

#### **DISCUSSION**

**SUMMARY:** This item provides the State Board for Educator Certification (SBEC) an update on formal complaints processed by Texas Education Agency (TEA) educator preparation staff regarding educator preparation programs (EPPs) during the 2021-2022 academic year.

**STATUTORY AUTHORITY:** The SBEC is required by Texas Education Code (TEC), §21.0455(a) to propose rules necessary to establish a process for a candidate for teacher certification to direct a complaint against an educator preparation program to the agency.

**FUTURE ACTION EXPECTED:** TEA staff intend to provide an annual update to the SBEC summarizing complaints against educator preparation programs (EPPs). Additionally, SBEC rules require TEA to recommend sanctions to the SBEC for EPPs that do not correct violations identified in complaints investigations.

**BACKGROUND INFORMATION AND JUSTIFICATION:** TEA staff process complaints through a formal process that is detailed in SBEC rule, 19 TAC §228.70. Complaints are routed through TEA Complaints Management. Once received, TEA educator preparation staff review the complaint, request additional information from the EPP and complainant as needed, and make a determination about the disposition of the complaint. This item provides the SBEC an opportunity to discuss the EPP complaint process and current status of complaints.

Complaints against EPPs typically fall into one or more of several general topics:

- Non-Responsive EPP: (EPP will not return phone calls, emails, etc.)
- Processing Issues: (EPP will not provide test approval, recommend a certificate, provide a Statement of Eligibility, provide a transfer form, EPP did not provide information about expiring tests/certificates, etc.)
- Lack of Support from EPP: (EPP has not provided the support during the preparation process that would allow the candidate to be successful-usually in internship).
- Ineffective EPP: (EPP has not effectively prepared the candidate for the classroom, for testing, etc.)
- Ethics Violations: (EPP has violated one or more of the Texas Educators' Code of Ethics).
- **Rights Violations:** (EPP has violated civil rights, disability rights, etc.) Note: TEA staff refer the complainant to the appropriate federal organization.

Per TEC §21.0455(d), and codified in SBEC rules, TEA staff and the SBEC do not have jurisdiction over complaints related to contractual arrangements with an EPP, commercial issues, obtaining a higher grade or credit for training, or seeking reinstatement to an EPP. Complaints of this nature are investigated but ultimately closed without action for lack of jurisdiction. For complaints that result in a determination of "No Jurisdiction" or "No Violation of TAC," TEA staff often provide guidance regarding suggested next steps to resolve the matter identified in the complaint.

If the EPP has violated one or more requirements in SBEC rules, located in the Texas Administrative Code (TAC), a resolution is required and timebound. If evidence of a resolution is provided to TEA staff per the agreed upon timeline the complaint is closed as resolved. Unresolved complaints would require SBEC consideration and action.

TEA staff track trends in complaints to initiate improvements in EPP and TEA processes. Additionally, SBEC rules require complaints to be a factor in the risk assessment used to determine the type of 5-Year Continuing Approval Review conducted for the EPP, whether a desk audit or an on-site review. The number of complaints against an EPP and the number of SBEC rule violations, located in TAC, found in the complaints against an EPP are considered in the risk assessment.

The table below provides a summary of the complaints received by the Educator Preparation team at TEA regarding EPPs and educator preparation requirements codified in SBEC rules. Attachment I reflects the EPPs that have received complaints during the 2021-2022 academic year, including the number, nature, and status of the complaint. Attachment II reflects the EPPs that did not receive any complaints on their programs.
