INTRODUCTION

The Texas Education Agency (TEA) would like to extend appreciation to Denton ISD for their efforts, attention, and time committed to the completion of the review process.

The TEA has developed a monitoring approach that reviews compliance-based indicators while also looking for best practices. In commitment to the approach, the cyclical monitoring report will provide the results of the LEA's compliance review related to the Individuals with Disabilities Education Act (IDEA) and federal and state statutes, a summary of data related to Results-Driven Accountability (RDA), State Performance Plan (SPP), Significant Disproportionality (SD), and dyslexia program evaluation will recommend targeted technical assistance and support for LEAs related to special education, and highlight best practices of LEAs that demonstrate success.

CYCLICAL MONITORING

The TEA conducts cyclical reviews of all LEAs statewide over six years. The purpose of cyclical monitoring is to support positive outcomes for students with disabilities and to determine compliance with special education regulations and dyslexia program regulations.

2020–2021 CYCLICAL REVIEW COMPLIANCE SUMMARY

On December 18, 2020, the TEA conducted a policy review of Denton ISD. On December 18, 2020, the TEA conducted a comprehensive desk review of Denton ISD. The total number of files reviewed for the Denton ISD comprehensive desk review was 24. The review found overall that 9 files out of 24 files were compliant. An overview of the policy review and student file review for Denton ISD are organized in the chart below by indicating the number of compliant findings within the reviewed file submissions related to the compliance area. 2020-2021 COVID-19 IMPACT NARRATIVE

In the 2020-2021 academic year, Local Education Agencies (LEAs) were provided an opportunity to complete a COVID-19 impact narrative form documenting the practices incorporated to support Child Find and FAPE for students being served by special education programs during the COVID-19 pandemic.

2020-2021 CYCLICAL REVIEW PARENT, TEACHER, ADMINISTRATOR INTERVIEWS/SURVEY

Staff and Family Surveys

On December 18, 2020 the TEA Review and Support team received 74 surveys during the comprehensive desk review. The Review and Support surveys focused on the following review areas:

Sixty-four percent of participants felt they received sufficient communication from their school. The best way the school/district provides information about trainings, online trainings, support groups and other available resources concerning special education services is via email followed by notices sent home, phone calls and social media.

The majority of parent/family member participants felt they would be most comfortable attending special education information sessions at the school campus.

The most selected areas of special education the participants would like to know about were the School, Family and Community Engagement Network, Texas State Leadership for Autism Training and the Texas Sensory Support Network (TxSSN).

The obstacles concerning student's special education programming and services were reported as:

- Assuring students receive accommodations and/or modifications as outlined in the IEP
- Timely updates on student progress
- Knowledge of available services and programming

The majority of participants agree with the importance of including students interests/life goals in the transition process with eighty percent of participants agreeing or strongly agreeing.

The majority of participants indicated they chose an In-Person learning model. Approximately fifty percent of those participating in remote learning indicated that the students did not interact with teachers consistently. They reported that remote learning for students receiving special education was somewhat effective or ineffective.

COVID

Almost fifty-four percent of participants felt that during COVID school closures/remote learning, the Emergency Contingency Plan was effective in student progress.

The majority of participants indicated that they agreed or strongly agreed that they worked with parents/guardians in addressing severe behavior and work refusal.

This survey was approved by the Texas Education Agency's data governance board. Participation in this survey was both voluntary and anonymous. No data was collected identifying a name so that individual responses cannot be linked to any respondent. Participants were given the option to stop the survey at any time.

Strengths

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following strengths for Denton ISD:

- Desk Review results showed evidence of strong practices for the accurate documentation of Transition Services.
- Desk Review results showed evidence of strong practices for IEP Development.

Considerations

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following considerations for Denton ISD:

- Review district wide procedures and provide professional development opportunities in the areas of State Assessment and Intensive Program of Instruction.
- Review self-monitoring process to ensure compliance with evaluation procedures.
- Provide professional development opportunities in the areas of School, Family and Community Engagement, Texas State Leadership for Autism Training and the Texas Sensory Support Network (TxSSN).

Findings of Noncompliance

A finding is made when noncompliance is identified with the Review and Support report findings, SPP notification, and/or individualized education program (IEP) requirements. each of the noncompliance findings. When noncompliance has been identified as part of this cyclical review, Denton ISD will receive formal notification of noncompliance in addition to this report.

The TEA Division of Special Education Monitoring will further advise the LEA on the corrective action process, if applicable.

The TEA follows procedures for the correction of noncompliance consistent with federal guidelines (OSEP Memo 09-02.)

Before the TEA can report that noncompliance has been corrected, it must first verify the LEA:

- Has corrected each individual case of noncompliance (Prong 1); and
- Is correctly implementing the specific regulatory requirements (i.e., subsequently achieved 100% compliance) (Prong 2).

The TEA is required to monitor the completion of a corrective action plan if any noncompliance is discovered. The corrective action plan must be designed to correct any and all areas of noncompliance as soon as possible, but in no case later than one year from the date of notification.

Corrective Action Plan (CAP)

The LEA will develop a CAP to address any items identified as noncompliance in this summary report. An approved form for the CAP can be accessed on the Review and Support website or in the resources located in Ascend Texas.

The LEA must submit the CAP in Ascend within 30 school days from the date of this report and/or formal notification of noncompliance. The TEA will review the CAP submitted by the LEA for approval. If the TEA determines that a revision(s) is necessary, the LEA will be required to revise and resubmit. The Review and Support team will contact the LEA to provide notification when the CAP has been approved.

Individual Correction

The educational agency has **60 school days** from the date of this summary report to correct all identified findings of noncompliance for individual students, unless noted otherwise in the report.
