3. Does a district need to go through both the district application process and the approved training provider application process?

No. Please reference the first two pages of this FAQ for more information.

4. When will the TEA release the MPA Approved Provider application?

TEA will release the MPA Approved Provider application on June 15, 2020 and will issue approvals in late August 2020.

5. Our district plans to deliver most of the mentor and induction training. However, we intend to use a third-party provider to deliver parts of the training. Is this permissible in Cycle 1 and, if so, how should we indicate this approach on our application?

In their application, districts applying for Cycle 1 may indicate that the training will be delivered by the district and a third-party provider. The training program will be reviewed in its entirety to ensure it meets the requirements in TEC §21.458 and TAC §153.1011. If districts choose this approach for Cycle 1, they should follow the application guidance below.

- Attachment A, Question 5: Check both boxes and include the third-party provider information.
- Attachment A, Question 7: Check each box if the training, in its entirety, meets all requirements.
- Attachment A, Question 8: The district may consult with the third-party provider to complete their response to question 8.
- Attachment B, Scope and Sequence: The district should indicate which entity will deliver the different parts of the training.

6. Will all district applications, provided they meet the requirements of TEC §21.458 and TAC §153.1011, receive MPA funding?

Due to funding limitations, it is not guaranteed that all applying districts will receive MPA funds. Please see pages 3-4 of the MPA Guidelines to review how priority points will be allocated.

- 7. Is it permissible to use MPA funds to support a subset of beginning teachers? Yes. Districts may designate how the MPA funding will support a subset of campuses and/or a subset of beginning teachers.
- 8. Will TEA publish guidance and recommendations on providing mentoring to beginning teachers during remote learning due to COVID-19?

We are reviewing the need for guidance on mentoring programs for school districts; TEA expects to provide information within the next month.

9. Will the 12-hour minimum requirement for mentoring activities per semester be reduced due to the COVID-19 pandemic and the remote learning taking place throughout the state?

No. Although we understand that mentoring of beginning teachers may look differently if campuses and classrooms are operating remotely in school year 2020-21 due to COVID-19, districts across the state will still need to ensure that mentors and beginning teachers meet the 12-hour requirements per semester for mentoring activities as stipulated in TEC §21.458 and TAC §153.1011.

10. Does the district need to add a contingency plan for implementing its mentoring program remotely due to COVID-19 on the MPA application?

No. Although a district is not required to include a contingency plan for remote mentor training or remote mentoring activities due to COVID-19 on the MPA application, a district still must meet the requirements of TEC §21.458 and TAC §153.1011 in order to be eligible for MPA funds.

11. Does Texas Teach Like a Champion Online (TLAC Online) meet the full requirements of an MPA mentor and induction training program?

No. While TLAC Online is a valuable and free resource that mentors may use as a coaching tool, it does not meet all the MPA mentor and induction training requirements in TEC §21.458 and TAC §153.1011.
