

# Question and Answer – November 2020

Below is a list of questions that were submitted during the Highly Mobile and At-Risk (HM&AR) presentation on November 5<sup>th</sup>, 2020. The questions have been sorted by topic.

### **Mental and Behavioral Health**

- Q1. How do we get to the STAT website?

### **Transition Assistance**

- Q3. What is the enrollment requirement for an unaccompanied youth under the age of 18 wanting to enroll without a parent? What documents are we allowed to ask for? What are we not allowed to ask for? Example: Living Separate and Apart form?
  - A. Students who are experiencing homelessness and who are an Unaccompanied Youth should be enrolled immediately. LEAs should work closely with unaccompanied youth who are experiencing homeless to remove any barriers to enrollment and assist in requesting records from the previous school.
- Q4. We have heard that private schools are refusing to give parents withdrawal and student records because they owe a fee. Is this allowed?
  - A. TEA has no authority over private schools. If a private school is refusing to provide student records due to a fee, we recommend that the McKinney-Vento Liaison of the receiving school works collaboratively with the private school and the student's family to assist in facilitating records whenever possible to support enrollment.
- Q5. Can you provide an updated Student Residency Form?
  - **A.** Yes. The most recent version of a sample <u>Student Residency Questionnaire</u> is located in the TEHCY website Resources page.

# **Utilizing Student Data and Engagement**

- Q6. Is it possible to receive the PEIMS report numbers that would assist us with student data reported for Homeless students and Foster Care Students as an ESC?
  - A. At this time, we are exploring what can be implemented to assist in providing data for students experiencing homelessness to ESC McKinney-Vento contacts.
