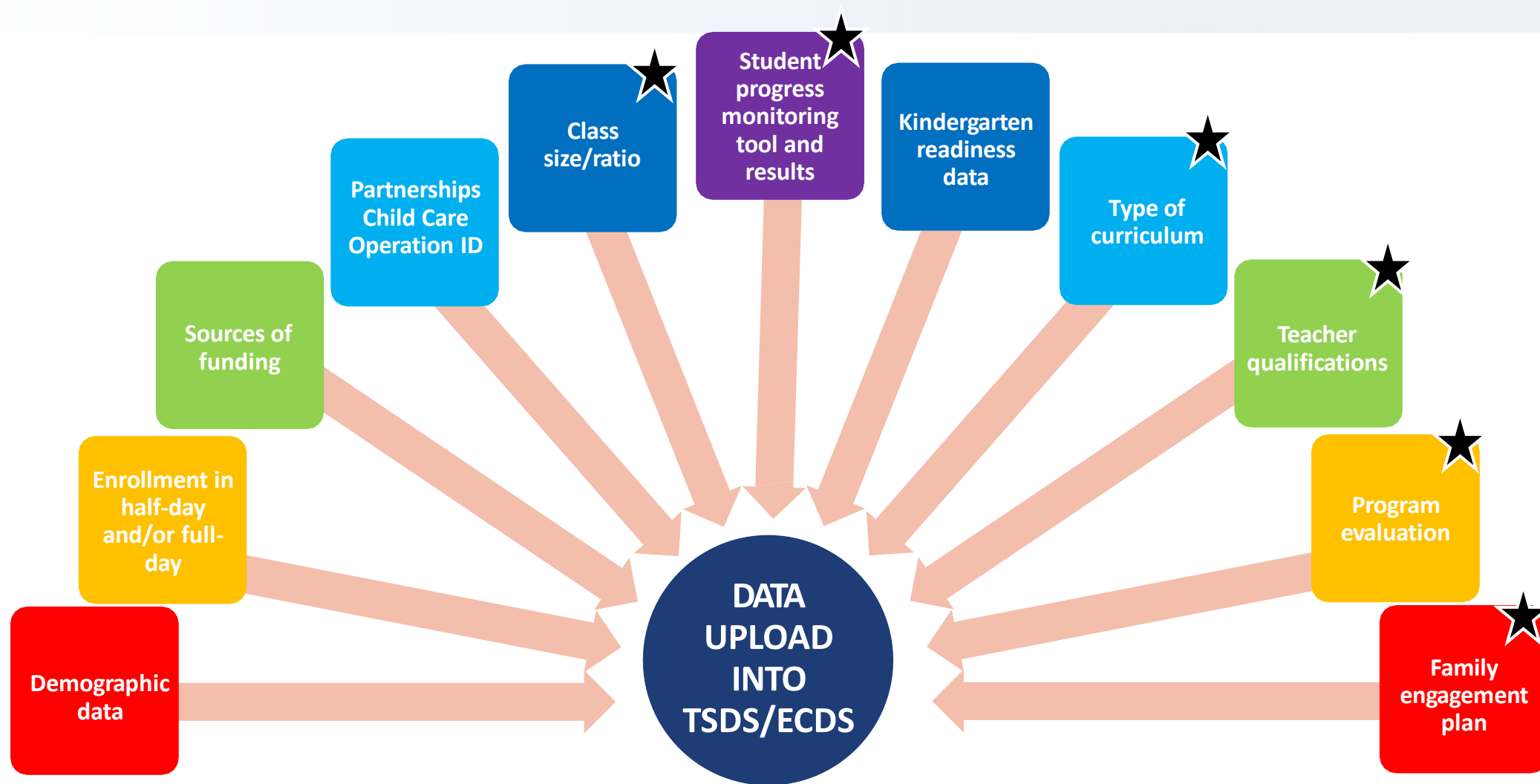

High-Quality Prekindergarten Requirements Overview

- The curriculum used in a prekindergarten classroom serving eligible four-year-old students must be aligned with the Texas Prekindergarten Guidelines

Curriculum



- Measure the 5 primary domains at BOY and EOY using a tool from the Commissioner's list

Student Progress Monitoring



- Select and implement appropriate methods for evaluating the district's or charter's high-quality prekindergarten program

Program Evaluation



- Each teacher of record for a prekindergarten class serving eligible four-year-old students must be appropriately certified **and** have an **additional qualification**

Add'l Teacher Qualifications



- Develop, implement, and make available a family engagement plan

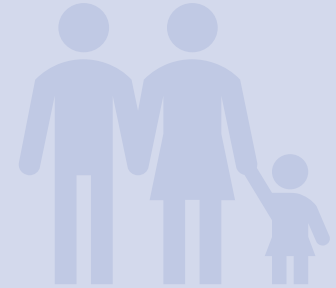

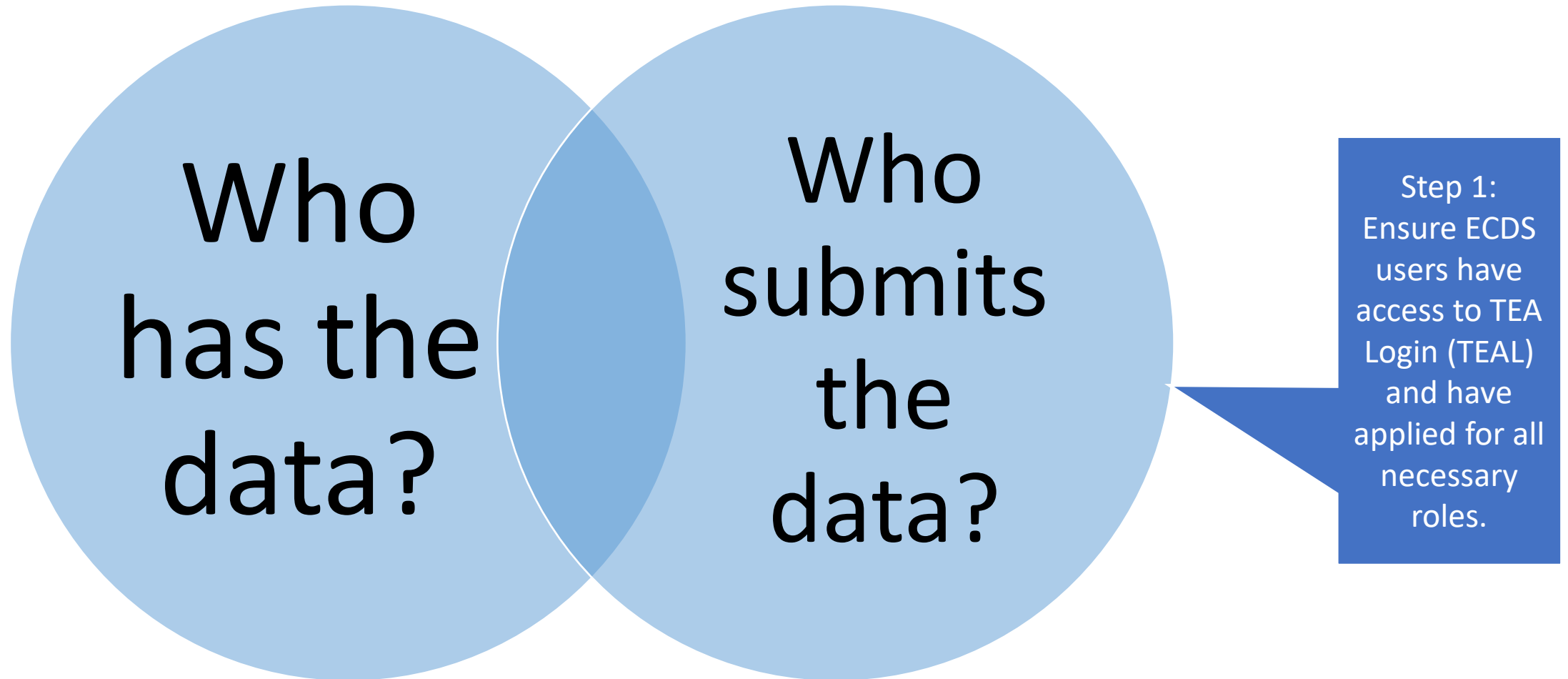

Q: How do we report classrooms that use both the English and Spanish curriculum?

- A: Only 1 curricula code can be selected per section. Choose the curriculum that is most used in that classroom.

Q: How do we report our curriculum if it is not listed in the code table?

- A: Code 99 "Other" should be used for any curriculum that is not listed in the code table.

Q: If we use a curriculum that is not on the SBOE Instructional Materials list, do we need to provide documentation of alignment to the TX PK Guidelines?

- A: Yes, it is recommended that you keep documentation on file that demonstrates alignment to the TX PK Guidelines. Documentation is not submitted to the TEA.

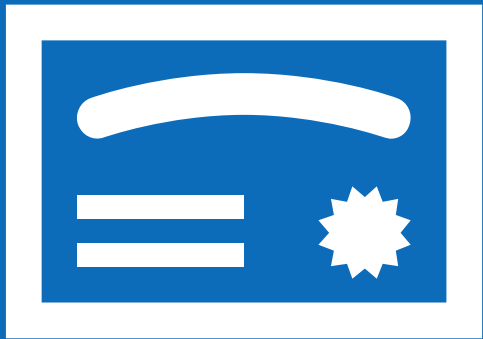
Program Evaluation FAQs

Q: Does completing the online version of the TEA self-assessment submit the data to the ECDS?

- A: No, the online version does not submit information in TSDS to the ECDS PK submission. The appropriate code must still be submitted in the ECDS PK submission to report the tool used.

Q: Do all of our campuses have to complete a program evaluation?

- A: No, the program evaluation is an evaluation of the LEA's overall prekindergarten program. Only one program evaluation is necessary to meet the requirement.

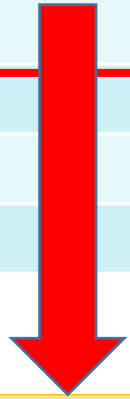

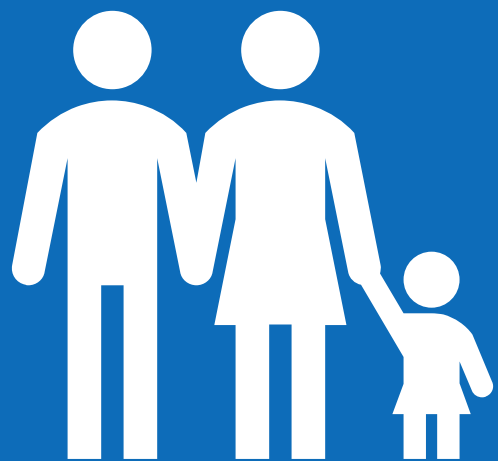

- b. Completes 30 hours of ECE-specific professional development annually with 15 of the 30 hours being in a mentoring/coaching relationship until 150 hours are documented

Q: I have a teacher completing PD hours over the summer. Can those hours count or do the hours have to be completed by the last day of school?

- A: Yes, PD hours taken in the summer can count towards the current school year up until the LEA submits the data.

Link goes to a webpage where the family engagement plan document is located or can be downloaded	Link goes to a main district webpage
Link goes to a family engagement plan webpage	Link goes to an outdated plan
Link goes directly to the family engagement plan document	Link is broken

Remember: plans must be updated annually and made available on the LEA's website by November 1st of each year.

Family Engagement Plan FAQs

Q: Can our Title I family engagement plan count for this plan?

- A: Yes, if all the required high-quality PK family engagement plan components are included in the plan, it can count. This also applies to LEA's who have a Head Start Family Engagement plan.

Q: Do all our campuses have to create a PK family engagement plan?

- A: No, for purposes of this high-quality prekindergarten indicator, only one family engagement plan is needed for the LEA's overall prekindergarten program.

Issues and errors can be caused by the following:

- Missing student unique ID's
- Incorrect format of student unique ID's
- Extra spaces in the data fields of the assessment xml files
 - Example: extra spaces in the assessment code or assessment title
- Student parent extension xml not loaded prior to loading the assessment metadata and student assessment data into the Operational Data Store (ODS)

Student Progress Monitoring FAQs

Q: A tool from the commissioner's list was not used. How do we submit data?

- A: A tool from the commissioner's list is required to be used for BOY and EOY student progress monitoring. Assessment data can only be submitted from the tools that are on the list. However, student data should still be submitted. The TEA EC programs team will be contacting LEAs who did not use an approved tool to provide support in meeting the requirement for the next school year.

Q: Not all 5 domains were assessed at BOY and/or EOY. Do we still submit the data?

- A: Yes, data should be submitted. TEA EC programs team will be contacting LEAs who did not assess in all domains to provide support in meeting the requirement for next school year.

Tips and Reminders

- LEAs should only be entering “0” if an assessment truly scored “0.”
 - If a '0' value is entered for a PK Assessment Academic Subject, it will be recorded as "Not Proficient" in the calculation based on the Lowest Proficiency score range in the Assessment specifications.
- If a student is exempt from the assessment, assessment data is not uploaded however, the student information would still need to be submitted.

Special Warnings



- Pay close attention to and review special warnings
 - Some of the HQPK elements will only generate a special warning (not a fatal error) when left blank.
 - Example: E1581 PK-TEACHER-REQUIREMENT
