2021 Accountability System



TEA 2021 Accountability Manual Texas Education Agency 2021 Accountability Manual

- The public comment period on the 2021 Accountability Manual closed. Performance Reporting received public comments from over 30 individuals and organizations.
- Responses to these comments, concerns, and questions are being drafted and will be released with the adopted version of the manual in the July 9th edition of the <u>Texas Register</u>.
- Appendices will be published throughout the summer.
- The finalized manual PDF with all chapters and appendices will be published late summer.



Texas Education Agency Campus Comparison Groups

- Although distinction designations are not awarded this year, campus comparison groups will be available at the end of the month on the 2021 Accountability Ratings webpage.
- Campus comparison group methodology will be published in Appendix E later this summer. (no changes from previous years)

2021 Campus Comparison Group

This page allows the user to see the campus comparison group for any campus in Texas that receives accountability ratings

Each campus in Texas is assigned to a unique comparison group comprised of schools that are most similar to it. To determine the campus comparison group, each campus is identified by school type (See the School Types chart in "Chapter 1-2021 Accountability Overview" of the 2021 Accountability Manual for more information.) then grouped with 40 other campuses from anywhere in Texas that are most similar in grade levels served, size, the percentage of students who are economically disadvantaged, mobility rate, the percentage of English learners, the percentage of students served by special education, and the percentage of students enrolled in an early college high school program. Each campus has only one unique campus comparison group. There is no limit to the number of comparison groups of which a school may be a member. It is possible for a school to be a member of no comparison group other than its own or a member of several comparison groups.

TEA 2021 Reporting

- Due to the extension of the TELPAS window, TEA will not receive the consolidated accountability file from the testing vendor until August 11.
- An Excel file indicating that all districts and campuses are Not Rated: Declared State of Disaster will be released on August 13.
- Unmasked accountability reports and confidential student listings will be released in TEAL to districts in late August.
- Masked accountability reports will be released on TXschools.gov and on TEA's 2021 accountability page in late August.



87th Legislative Session

- Not all have been signed by the governor yet.
- There is much work, including rulemaking, to be done before implementation.

HB 572—Effective

 Relating to the inclusion of students enrolled in a dropout recovery school as students at risk of dropping out of school for purposes of compensatory, intensive, and accelerated instruction and to a study by the Texas Education Agency on competency-based educational programs

HB 773—Effective

 Relating to indicators of achievement under the public school accountability system (CTE Program of Study)



HB 1147—Effective

 Relating to military readiness for purposes of the indicators of achievement under the public school accountability system and the college, career, or military readiness outcomes bonus under the Foundation School Program (Texas National Guard)

HB 1525—Effective

 Relating to the public school finance system and public education (Removes TSI criteria from associate degree for CCMR OB)



HB 4545—Effective

 Relating to the assessment of public school students, the establishment of a strong foundations grant program, and providing accelerated instruction for students who fail to achieve satisfactory performance on certain assessment instruments (TAPR reporting)

SB 879—Effective

 Relating to the qualifications for designation as a dropout recovery school (50% at 17+ updated to 60% at 16+ with application process added)



SB 1365—Sent to the Governor

- Relating to public school organization, accountability, and fiscal management
 - Multi-year unacceptable definition
 - 2020–21 special evaluation for consecutive years
 - 2021–22 ratings guidance

SB 1615—Effective

 Relating to the adult high school charter school (unique) framework)



TEAL Reports and Applications Update



- Districts can now access the following rates, lists of students, and summary reports under the Research & Analysis tab within the TEAL Accountability application:
 - Longitudinal graduation rates and longitudinal graduation, continuation, or TxCHSE rates
 - Longitudinal diploma program rates
 - Annual dropout rates
 - Underreported student rates



- Two sets of graduation rates are available for the Class of 2020 (four-year rates), Class of 2019 (five-year extended rates), and Class of 2018 (six-year extended rates):
 - rates calculated for federal accountability purposes
 - rates calculated with statutory exclusions applied for state accountability
- The report also shows the diploma program rate traditionally used for distinction designations (not applicable for 2021)
- A student listing is available for download by cohort.

Research and Analysis

The Division of Research and Analysis is responsible for analysis and development of policy on state and federal accountability measures, educational policy research, development of public school data and information systems, and reports on educational progress in Texas public schools. The Division of Research and Analysis develops indicators and measures for high school graduation, dropouts, grade-level retention, college entrance examinations, and advanced courses. The measures are used in the Texas Academic Performance Report (TAPR), state and federal accountability, performance-based monitoring, and numerous state and federal reports. Annual reports on secondary school graduation and dropouts; grade-level retention; enrollment trends; college entrance examinations (SAT and ACT); and Advanced Placement and International Baccalaureate examinations are published.



Students with a 'Yes' in the District Rate Only column are included only in district-level calculations.

Students identified by one of the following reasons were excluded from campus and district longitudinal rates used for state accountability in 2021: 1=court-ordered TxCHSE, TxCHSE not earned; 2-previous dropout; 3-ineligible for FSP funding; 4-refugee/asylee; 5-in a juvenile detention or residential treatment facility; 6-incarcerated as adult; 7-IEP continuer; and 8-medical injury. The combination variable, Foster/Homeless/Military, refers to students who were identified as living in foster care while attending Grades 9-12, homeless at any time while attending Grades 9-12, and/or military-connected in their last year of attendance.

CCMR Tracker

- Districts are given a student-level view of CCMR data that TEA has received from TSDS PEIMS submissions and non-PEIMS sources (SAT, ACT, TSIA, etc.). The data lags.
- The 2021 CCMR Tracker will be released in two stages this year.
 - March 31: CCMR outcomes as reported though TSDS PEIMS, for TSIA results, and for OnRamps course completion through the 2019–20 school year
 - July 2021: CCMR outcomes for SAT, ACT, AP, IB, and level I/II certificates through the 2019–20 school year.



CCMR Tracker

- No corrections will be submitted to TEA; this report is for informational purposes only.
- If districts find errors with assessment related indicators, they are encouraged to work with testing vendors to make corrections prior to the student's graduation. TSDS PEIMS data are final.
- A video walkthrough of the 2021 CCMR Tracker will be available in late June, along with additional resources on the <u>Performance</u> <u>Reporting Resources site</u>.



CCMR Verifier

- The CCMR Verifier was posted to TEAL yesterday and is the same online system as last year's which ran from August through October.
- The Verifier contains 2019–20 annual graduates plus non-graduating 12th graders.
- Corrections may be submitted electronically through the TEAL Accountability application for the listed students.
- The Verifier can only be used to correct non-PEIMS indicators. TSDS PEIMS data are final.
- Industry-based certifications SHOULD NOT be submitted via the level I/level II field.



CCMR Verifier

- Districts are encouraged to verify their CCMR data to ensure accurate data for
 - the CCMR Outcomes Bonus;
 - potential future small numbers analyses;
 - the 2020–21 Texas Academic Performance Report (TAPR); and
 - potential use in future accountability ratings.



CCMR Verifier

- If the district does not find any discrepancies or wish to request changes, no action is required.
- If discrepancies are found, districts must request changes with supporting documentation.
- Please note, CCMR indicators determined by TSDS PEIMS submissions are not eligible for corrections, and therefore, are not shown.
