INTRODUCTION

The Texas Education Agency (TEA) would like to extend appreciation to Kingsville ISD for their efforts, attention, and time committed to the completion of the review process.

The TEA has developed a monitoring approach that reviews compliance-based indicators while also looking for best practices. In commitment to the approach, the cyclical monitoring report will provide the results of the LEA’s compliance review related to the Individuals with Disabilities Education Act (IDEA) and federal and state statutes, a summary of data related to Results-Driven Accountability (RDA), State Performance Plan (SPP), and Significant Disproportionality (SD), recommend targeted technical assistance and support for LEAs related to special education, and highlight promising practices of LEAs that demonstrate success.

The TEA conducts cyclical reviews of all local education agencies (LEAs) statewide over six years. The purpose of cyclical monitoring is to support positive outcomes for students with disabilities and to determine compliance with special education regulations.

2019–2020 CYCLICAL REVIEW COMPLIANCE SUMMARY

On August 30, 2019 , the TEA conducted a policy review of Kingsville ISD. On December 20, 2019, the TEA conducted a comprehensive desk review of Kingsville ISD. The total number of files reviewed for the Kingsville ISD comprehensive desk review was 38. The review found overall that 38 files out of 38 files were compliant. An overview of the policy review and student file review for Kingsville ISD are organized in the chart below by indicating the number of compliant findings within the reviewed file submissions related to the compliance area. 2019–2020 CYCLICAL REVIEW PARENT, TEACHER, ADMINISTRATOR INTERVIEWS/SURVEY

Staff and Family Surveys

On December 7, 2019, the TEA Review and Support team conducted 17 interviews during the on-site visit. Respondents to the staff and family survey included parents/guardians, general education teachers, special education teachers, evaluation staff, and administration staff (district and campus). The Review and Support interviews focused on the following review areas:

- Special education program structure
- Implementation of the special education program
- Monitoring and evaluating effectiveness
- Training

Overall, families view the special education program structure as positive and appreciate the recent changes in communication. Those interviewed reported a close working relationship between special education and general education teachers in their efforts to plan together and ensure implementation of IEPs. Additionally, the district uses data driven instruction and as a result closely monitors the effectiveness of students' special education programming. Finally, the interview analysis found that administrators and teachers, feel that additional training related to differentiating instruction would improve outcomes for students with disabilities.

Strengths

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following strengths for Kingsville ISD:

One area of strength for Kingsville ISD is consistent ARD documentation ensures compliance and fidelity across the district.

Another area of strength for Kingsville ISD is the ARD committee gathers appropriate data and information from required ARDC members to write measure student goals and describe how the child's progress will be measured.

Considerations

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following considerations for Kingsville ISD:

- Consider the review of campus and district structures for analyzing data to inform instruction/intervention.
- Consider training staff on creating and implementing intensive program of instruction.
- Consider revisiting the district and campus-wide discipline practices and/or consider conducting training.

As a result of monitoring, the TEA has identified the following technical assistance resources to support Kingsville ISD engaging in **intensive** support as determined by the RDA performance level data and artifacts within the compliance review:

Findings of Noncompliance

A finding is made when noncompliance is identified with the Review and Support report findings, SPP notification, and/or individualized education program (IEP) requirements. Noncompliance that is systemic in nature must be included in a comprehensive corrective action plan (CAP) with action steps to address each of the noncompliance findings. ***When noncompliance has been identified as part of this cyclical review, Kingsville ISD will receive formal notification of noncompliance in addition to this report.***

The TEA Division of Special Education Monitoring will further advise the LEA on the corrective action process, if applicable.

The TEA follows procedures for the correction of noncompliance consistent with federal guidelines (OSEP Memo 09-02.)

Before the TEA can report that noncompliance has been corrected, it must first verify the LEA:

- Has corrected each individual case of noncompliance (Prong 1); and
- Is correctly implementing the specific regulatory requirements (i.e., subsequently achieved 100% compliance) (Prong 2).

The TEA is required to monitor the completion of a corrective action plan if any noncompliance is discovered. The corrective action plan must be designed to correct any and all areas of noncompliance ***as soon as possible, but in no case later than one year from the date of notification.***

Corrective Action Plan (CAP)

The LEA will develop a CAP to address any items identified as noncompliance in this summary report. An approved form for the CAP can be accessed on the Review and Support website or in the resources located in Intervention, Stage, and Activity Manager (ISAM).

The LEA must submit the CAP in ISAM within 30 school days from the date of this report and formal notification of noncompliance. The TEA will review the CAP submitted by the LEA for approval. If the

TEA determines that a revision(s) is necessary, the LEA will be required to revise and resubmit. The Review and Support team will contact the LEA to provide notification when the CAP has been approved.

Individual Correction

The educational agency has **60 school days** from the date of this summary report to correct all identified findings of noncompliance for individual students, unless noted otherwise in the report.
