### INTRODUCTION

The Texas Education Agency (TEA) would like to extend appreciation to Newcastle ISD for their efforts, attention, and time committed to the completion of the review process.

The TEA has developed a monitoring approach that reviews compliance-based indicators while also looking for best practices. ## 2019–2020 CYCLICAL REVIEW COMPLIANCE SUMMARY

On September 13, 2019, the TEA conducted a policy review of Newcastle ISD. On March 16, 2020, the TEA conducted a comprehensive desk review of Newcastle ISD. The total number of files reviewed for the Newcastle ISD comprehensive desk review was 18. The review found overall that 18 files out of 18 files were compliant. An overview of the policy review and student file review for Newcastle ISD are organized in the chart below by indicating the number of compliant findings within the **reviewed** file submissions related to the compliance area. ## Staff and Family Surveys

Minimum size requirements not met. Results not published within this report due to the limitation of the sample size.

This survey was approved by the Texas Education Agency’s data governance board. Participation in this survey was both voluntary and anonymous. No data was collected identifying a name so that individual responses cannot be linked to any respondent. Participants were given the option to stop the survey at any time.

## Strengths

Based on the results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following strengths for Newcastle ISD:

- All files reviewed indicate that a review of existing data was completed by the IEP team and other qualified professionals.
- All files reviewed indicate the least restrictive environment was determined based on the student's needs in the IEP.
- All FIEs were complete within 45 school days of the date the district received written consent for evaluation.

## Considerations

Based on the results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following considerations for Newcastle ISD:

- Continue to focus on the quality and alignment of the PLAAFP, annual goals, and accommodations or modifications.
