## Questions and Answers:

Q: Is there a date yet for the publication of the Spanish Proclamation and its breakouts? Thank you.

A: There is not a separate proclamation for Spanish. *Proclamation 2024* includes a call for K-6 Spanish science materials. We are still working on the Spanish translations, so I do not have an ETA for the Spanish version of the breakouts; however, I can share that they will be a direct translation of the English breakouts.

Q: When will the TEKS Guide be released?

A: The TEKS Guide will not be available until summer 2024; however, we may be able to release some of the components earlier.

Q: You provided a wonderful example of how the RTCs are integrated into the standards; will you provide something similar for the SEPS?

Q: Given the delayed release date of the Publisher Handbook, will you consider extending the July 31, 2022, questions deadline to get a more robust pool of related questions?

A: You can continue to submit questions, but we have been collecting them since the draft proclamation was posted in January. We will do our best to include what we receive but must prepare the document for the SBOE meeting in late August.

Q: For the certified editorial review - do we do that internally?

A: Yes, the editorial review is conducted internally by each publisher, and you will submit a document that certifies you have completed that work.

Q: Do you have any idea how the correlations will be entered into the dashboard? Would it be possible to upload a sort of spreadsheet?

A: In response to publisher feedback, we are working with the vendor to see if there is a way for publishers to upload correlations using a CSV file.

Q: Eventually, we'd prefer an API tool over a CSV file or an Excel spreadsheet.

A: We will explore that as well.
