### INTRODUCTION

The Texas Education Agency (TEA) would like to extend appreciation to Palestine Independent School District for their efforts, attention, and time committed to the completion of the review process.

The TEA has developed a monitoring approach that reviews compliance-based indicators while also looking for best practices. In commitment to the approach, the cyclical monitoring report will provide the results of the LEA's compliance review related to the Individuals with Disabilities Education Act (IDEA) and federal and state statutes, a summary of data related to Results-Driven Accountability (RDA), State Performance Plan (SPP), Significant Disproportionality (SD), and dyslexia program evaluation recommend targeted technical assistance and support for LEAs related to special education, and highlight best practices of LEAs that demonstrate success.

### CYCLICAL MONITORING

The TEA conducts cyclical reviews of all LEAs statewide over six years. The purpose of cyclical monitoring is to support positive outcomes for students with disabilities and to determine compliance with special education regulations and dyslexia program regulations.

### 2020–2021 CYCLICAL REVIEW COMPLIANCE SUMMARY

On April 22, 2021, the TEA conducted a policy review of Palestine Independent School District. On May 28, 2021, the TEA conducted a comprehensive desk review of Palestine Independent School

District. The total number of files reviewed for the Palestine Independent School District comprehensive desk review was 23. The review found overall that 23 files out of 23 files were compliant. An overview of the policy review and student file review for Palestine Independent School District are organized in the chart below by indicating the number of compliant findings within the reviewed file submissions related to the compliance area. **2020–2021 DYSLEXIA COMPLIANCE SUMMARY**

For the 2020-2021 school year, the Texas Education Agency (TEA) identified Palestine Independent School District (ISD) for dyslexia monitoring based on the Differentiated Monitoring and Support Cyclical Schedule. The dyslexia monitoring process focuses on three-core elements: Early Intervention and Identification, Program of Instruction and Parent Notification. The TEA Department of Review and Support: Dyslexia Monitoring reviewed Palestine ISD artifacts using the Dyslexia Program Evaluation Rubric which is aligned to Senate Bill 2075 of the 86<sup>th</sup> Legislature, Texas Education Code (TEC) 38.003 (c-1), and 19 Texas Administrative Code (TAC) Chapter 74.28. The 2020-2021 school year results for Palestine ISD are in the Dyslexia Compliance Summary table below.

## 2020-2021 COVID-19 IMPACT NARRATIVE

In the 2020-2021 academic year, Local Education Agencies (LEAs) were provided an opportunity to complete a COVID-19 impact narrative form documenting the practices incorporated to support Child Find and FAPE for students being served by special education programs during the COVID-19 pandemic.

## 2020-2021 CYCLICAL REVIEW PARENT, TEACHER, ADMINISTRATOR INTERVIEWS/SURVEY

### Staff and Family Surveys

On June 30, 2021, the TEA Review and Support team received 39 surveys during the comprehensive desk review. The Review and Support surveys focused on the following review areas:

The best way the school/district provides information (trainings, online trainings, support groups and other available resources) concerning special education services is via school website, followed by notices sent home, social media, and emails.

The majority of participants felt training in classroom management and Behavior RTI or MTSS was effective or somewhat effective to help meet the needs of students with disabilities.

Sixty-two percent of participants felt there were frequent opportunities to collaborate with related service providers and almost forty percent felt there were not frequent opportunities to collaborate with service providers.

All participants agree with the importance of including students’ interests/life goals in the transition process with 44% of those participants strongly agreeing.

### COVID

Almost 50% of participants felt that during COVID school closure/remote learning, the Emergency Contingency Plan was effective in student progress.

The majority of participants indicated that remote learning for students receiving special education was somewhat ineffective.

During COVID closures the top three methods teachers used to provide support to students with moderate to severe disabilities were:

- Teachers made regular contact with students and parents to meet academic and emotional needs.
- Teachers modified work.
- Teachers provided supports needed for students to be successful

Participants indicated that during current COVID school closure/remote learning they needed professional development in How to teach virtually and how to use virtual platforms.

Participants indicated that during COVID school closure/remote learning strategies the top two supports used by the district that didn't work well for students with disabilities were online submission of assignments and shared devices per family.

The majority of participants indicated they agreed or strongly agreed that they worked with parent/guardian in addressing severe behavior and work refusal.

This survey was approved by the Texas Education Agency's data governance board. Participation in this survey was both voluntary and anonymous. No data was collected identifying a name so that individual responses cannot be linked to any respondent. Participants were given the option to stop the survey at any time.

## **Strengths**

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following strengths for Palestine Independent School District:

- Present Levels of Academic Achievement and Functional Performance (PLAAFPs) were descriptive and provide detailed information along with supportive data that allows for individualization during IEP development to support student growth achievement.
- The ARD committee considered and documented the student's strengths, preferences, and interests for secondary transition which allows the committee to develop a plan that is individual and supports student growth and future beyond high school.
- Majority of staff who completed the survey agree that there are frequent opportunities for general education and special education teachers to collaborate and plan together. This allows for student specific collaboration in assuring accommodations and modifications are met for

individualized need and allows teachers to share effective strategies for meeting student needs and supporting student growth.

## Considerations

Based on results of the policy review and student file review, along with data collected from LEA staff and family surveys, the Review and Support team identified the following considerations for Palestine Independent School District:

- Consider developing a system to provide training, if applicable, on the topic of remote learning and how to effectively use virtual platforms to ensure continuity of instruction when a student is not able to attend in-person instruction.
- Consider developing a system to increase outreach strategies and opportunities to engage parents/families/caregivers of students with disabilities who receive special education services in the district allowing for collaboration and continued support for students.

## FINDINGS OF NONCOMPLIANCE

A finding is made when noncompliance is identified with the Review and Support report findings, SPP notification, and/or individualized education program (IEP) requirements. Noncompliance that is systemic in nature must be included in a comprehensive corrective action plan (CAP) with action steps to address each of the noncompliance findings. ***When noncompliance has been identified as part of this cyclical review, Palestine Independent School District will receive formal notification of noncompliance in addition to this report.***

The TEA Department of Review and Support will further advise the LEA on the corrective action process, if applicable.

The TEA follows procedures for the correction of noncompliance consistent with federal guidelines (OSEP Memo 09-02.)

Before the TEA can report that noncompliance has been corrected, it must first verify the LEA:

- Has corrected each individual case of noncompliance (Prong 1); and
- Is correctly implementing the specific regulatory requirements (i.e., subsequently achieved 100% compliance) (Prong 2).

The TEA is required to monitor the completion of a corrective action plan if any noncompliance is discovered. The corrective action plan must be designed to correct any and all areas of noncompliance ***as soon as possible, but in no case later than one year from the date of notification.***

### **Corrective Action Plan (CAP)**

The LEA will develop a CAP to address any items identified as noncompliance in this summary report. An approved form for the CAP can be accessed on the Review and Support website or in the resources located in Ascend Texas.

The LEA must submit the CAP in Ascend within 30 school days from the date of this report and/or formal notification of noncompliance. The TEA will review the CAP submitted by the LEA for approval. If the TEA determines that a revision(s) is necessary, the LEA will be required to revise and resubmit. The Review and Support team will contact the LEA to provide notification when the CAP has been approved.

### **Individual Correction**

The educational agency has **60 school days** from the date of this summary report to correct all identified findings of noncompliance for individual students, unless noted otherwise in the report.

## **2020–2021 DYSLEXIA PROGRAM EVALUATION FINDINGS**

### Corrective Action

The TEA reviews data collected from the dyslexia program evaluation to ensure compliance with federal and state regulatory requirements. ### Dyslexia Performance Plan (DPP)
