

# College Admissions Testing Participation Results for Graduating Seniors in Texas Public Schools, Class of 2012

This report presents SAT and ACT examination participation data for graduating seniors in Texas public schools. College admissions examination results are used by colleges and universities to make admissions decisions, to place students in appropriate freshman courses, and to award scholarships to students. In Texas, moreover, public school results are used in determining eligibility for student exemptions from Texas Success Initiative assessment requirements and to acknowledge districts and campuses for high levels of performance.

Under the new Texas public school accountability system, introduced in 2013, academic achievement distinction designations (AADDs) recognize school districts and campuses for outstanding achievement in specified academic areas (Texas Education Agency [TEA], 2013; Texas Education Code [TEC] Chapter 39, Subchapter G, 2011). For 2013, a campus that earned an accountability rating of *Met Standard* was eligible to receive AADDs based on results across a number of indicators, including SAT/ACT examination participation and performance, in relation to a comparison group of campuses.

There were five campus-level AADD indicators for SAT and ACT examinations in 2013:

(1) participation in SAT/ACT examinations; (2) performance in English language arts (ELA) on the SAT; (3) performance in ELA on the ACT; (4) performance in mathematics on the SAT; and (5) performance in mathematics on the ACT. The indicators were evaluated based on data for the class of 2012.

Results presented in this report are based only on the most recent examinations taken by students identified by the College Board and ACT, Inc., as expecting to graduate in the reporting year. For additional information about SAT and ACT examinations and results reported by the TEA Division of Research and Analysis, including definitions of terms and explanations of calculations, please see College Admissions Testing General Information, Class of 2012 (TEA, 2015a) and College Admissions Testing Glossary of Terms, Class of 2012 (TEA, 2015b). SAT and ACT performance results for Texas public schools are presented in the report College Admissions Testing Performance Results for Graduating Seniors in Texas Public Schools, Class of 2012 (TEA, 2015d). Results for Texas public and nonpublic schools combined are presented in the report College Admissions Testing of Graduating Seniors in Texas and the United States, Class of 2012 (TEA, 2015c).

# Participation Results for Texas Public Schools: SAT and ACT Combined

- A total of 195,682 Texas public high school graduates in the class of 2012 took the SAT, the ACT, or both examinations, an increase of 13,401 graduates from the previous class (Table 1). Despite the increase in number of test takers, the overall SAT/ACT participation rate for the class of 2012 (66.9%) was 2.0 percentage points lower than the rate for the class of 2011 (68.9%).
- Among graduates in the class of 2012, Asian students had the highest SAT/ACT participation rate, at 94.4 percent, followed by multiracial (73.7%), White (71.2%), African American (70.3%), Pacific Islander (66.2%), American Indian (62.6%), and Hispanic (59.6%) students (Table 2).
- Of the 131,106 graduates in the class of 2012 who identified their ethnicity as Hispanic, 84,896 (64.8%) identified White as their race, and 39,291 (30.0%) identified American Indian (Table 3 on page 4). Among Hispanic graduates, the SAT/ACT participation rates for White and American Indian students were 59.8 percent and 55.2 percent, respectively.
- Among graduates in all racial/ethnic groups except Hispanic students, SAT/ACT participation rates for the class of 2012 were lower than those for the class of 2011 (Figure 1 on page 4 and Table 4 on page 5).
- SAT/ACT participation rates among both female and male graduates were lower for the class of 2012 than for the class of 2011 (Table 4 on page 5).



## **Participation Results for Texas Public Schools: SAT**

- A total of 156,455 graduates in the class of 2012 took the SAT examination (Table 5). The SAT participation rate for the class of 2012 (53.5%) was 2.5 percentage points lower than the rate for the class of 2011 (56.0%).
- Among graduates in the class of 2012, Asian students had the highest SAT participation rate, at 87.1 percent, followed by multiracial (62.3%), African American (58.2%), White (57.5%), Pacific Islander (53.8%), American Indian (50.8%), and Hispanic (45.6%) students (Table 6).
- Of the 131,106 graduates in the class of 2012 who identified their ethnicity as Hispanic, 84,896 (64.8%) identified White as their race, and 39,291 (30.0%) identified American Indian (Table 7 on page 8). Among Hispanic graduates, the SAT participation rates for White and American Indian students were 44.6 percent and 45.3 percent, respectively.
- In the class 2012, African American, Asian, and White students accounted for larger proportions
  of the SAT examinee population than the graduate population (Figure 2 on page 8). By contrast,
  Hispanic students accounted for a larger proportion of the graduate population than the examinee
  population. American Indian, Pacific Islander, and multiracial students each accounted for similar
  proportions of the two populations.



## **Participation Results for Texas Public Schools: ACT**

- A total of 99,710 graduates in the class of 2012 took the ACT examination (Table 8). The ACT participation rate for the class of 2012 (34.1%) was 0.7 percentage points lower than the rate for the class of 2011 (34.8%).
- Among graduates in the class of 2012, Asian students had the highest ACT participation rate, at 41.9 percent, followed by White (38.8%), multiracial (37.3%), African American (34.6%), American Indian (29.5%), Hispanic (29.2%), and Pacific Islander (28.3%) students (Table 9 on page 10).
- Of the 131,106 graduates in the class of 2012 who identified their ethnicity as Hispanic, 84,896 (64.8%) identified White as their race, and 39,291 (30.0%) identified American Indian (Table 10 on page 10). Among Hispanic graduates, the ACT participation rates for White and American Indian students were 30.8 percent and 23.4 percent, respectively.
- In the class of 2012, Asian and White students accounted for larger proportions of the ACT examinee population than the graduate population (Figure 3 on page 11). By contrast, Hispanic students accounted for a larger proportion of the graduate population than the examinee population. African American, American Indian, Pacific Islander, and multiracial students each accounted for similar proportions of the two populations.


