
What STAAR Test Does a Student Take?

Title: "What STAAR Test Does a Student Take?"

The top of the chart begins with the question "What is the student's enrolled grade?"

- 1) If the student is enrolled in kindergarten through grade 2, the answer is "The student does not take STAAR."
- 2) If the student is enrolled in grades 3–8, the next question is "Is the student receiving on-grade-level instruction?"
- 3) If the student is receiving on-grade-level instruction, the answer is "The student takes the grade-level STAAR assessment."
- 4) If the student is not receiving on-grade-level instruction, the next question is "Is the student completing above- grade-level instruction?"
- 5) If the student is completing above-grade-level instruction, the next question is "Is the above-grade-level instruction in a high school course?"
- 6) If the student is not completing above-grade-level instruction, the answer is "The student takes the grade-level STAAR assessment."
- 7) If the above-grade-level instruction is in a high school course, the next question is "Is there a corresponding STAAR EOC assessment?"
- 8) If the above-grade-level instruction is not in a high school course, the next question is "Is there a corresponding above-grade-level STAAR 3–8 assessment?"
- 9) If there is a corresponding STAAR EOC assessment, the answer is "The student takes the corresponding STAAR EOC assessment."
- 10) If there is no corresponding STAAR EOC assessment, the answer is "The student takes the grade-level STAAR assessment."
- 11) If there is a corresponding above-grade-level STAAR 3–8 assessment, the answer is "The student takes the corresponding above-grade-level STAAR 3–8 assessment."
- 12) If there is no corresponding above-grade-level STAAR 3–8 assessment, the answer is "The student takes the grade-level STAAR assessment.*"
- 13) If the student is enrolled in grades 9–12, the next question is "Is the student enrolled in a course that has a corresponding STAAR EOC assessment?"
- 14) If the student is enrolled in a course with an EOC assessment, the next question is "Has the student already passed this STAAR EOC assessment?†"
- 15) If the student is not enrolled in a course with an EOC assessment, the answer is "The student does not take STAAR."
- 16) If the student has already passed this STAAR EOC assessment, the answer is "The student does not take STAAR."
- 17) If the student has not already passed this STAAR EOC assessment, the answer is "The student takes the corresponding STAAR EOC assessment."
