

# Reporting Student Data File Format

## Overview

All STAAR data for end-of-course (EOC) assessments will be reported in a unique data file for each EOC administration. There will be one record on the data file for each subject for which the student is assessed. Following is a list of the most significant changes being implemented in the 2023-2024 EOC administrations.

- 1. PEIMS ID Field name changed from 'Student ID'. First 5 numerals will be masked with an asterisk (Position 74).
- 2. **TSDS ID** Field name changed from 'TX Unique Student ID' (Position 191).
- 3. **WORD-PREDICTION** New accommodation applicable to Biology, English I, English II, and U.S. History (Position 257).
- 4. SPELL CHECK Accommodation name has been changed from 'Spelling Assistance' (Position 262).
- 5. **STAAR PROGRESS MEASURE (AND RELATED FIELDS)** –STAAR Progress Measure will be reported for Algebra I, English I and English II (Positions 400-412, 414-416).
- 6. **ON-TRACK TO MEET GRADE LEVEL** New field added (Position 401).
- 7. **PREVIOUS-YEAR APPROACHES GRADE LEVEL** This field is not required to calculate STAAR Progress Measure or On Track To Meet Grade Level and has been changed to a blank (Position 413).
- 8. **PREVIOUS-YEAR MEETS GRADE LEVEL** This field is not required to calculate STAAR Progress Measure or On Track To Meet Grade Level and has been changed to a blank (Position 417).
- 9. EL PERFORMANCE MEASURE New value of 4 added (Positions 418, 1051, 1151, 1251, 1351, 1451).
- 10. ENGLISH I STAAR PROGRESS MEASURE New field in the Cumulative History section (Position 1249).
- 11. ON TRACK TO MEET GRADE LEVEL New field in the Cumulative History section (Position 1250).
- 12. **CURRENT YEAR TELPAS UNSCHOOLED ASYLEE/REFUGEE** This field is not required for ELPM calculation and has been changed to a blank (Position 1621).
- 13. **CURRENT YEAR TELPAS STUDENTS WITH INTERRUPTED FORMAL EDUCATION (SIFE)** This field is not required for ELPM calculation and has been changed to a blank (Position 1622).
- 14. FALL 2023 TSDS PEIMS CRISIS CODE 2 This field has been changed to a blank (Positions 1626-1628).
- 15. FALL 2023 TSDS PEIMS CRISIS CODE 3 This field has been changed to a blank (Positions 1629-1631).
