

Visiting International Teacher

Instructions Guide for ISD Staff

Texas Administrative Code

§230.41. Visiting International Teacher Certificates.

(a) For purposes of this subsection, Visiting International Teacher Program is defined as a J-1 Visa Exchange Visitor Program officially approved by the United States Department of State.

(b) The State Board for Educator Certification will issue a visiting international teacher certificate to an individual who meets the conditions and requirements specified in this subsection. The individual must:

(1) meet appropriate requirements prescribed in §230.11(b)(1)-(4) of this title (relating to General Requirements);

(2) be recommended for certification by a school district participating in a Visiting International Teacher Program;

(3) hold valid teaching credentials from the country of origin based, at a minimum, on the equivalent of a bachelor's degree issued by an institution of higher education in the United States accredited or otherwise approved by an accrediting organization recognized by the Texas Higher Education Coordinating Board or by the U.S. Department of Education;

(4) demonstrate English language proficiency and subject matter competence in subject area(s) taught, as verified by the Visiting International Teacher Program sponsor and the employing school district;

(5) have criminal activity clearance from country of origin;

(6) pay appropriate fee prescribed by §230.101 of this title (relating to Schedule of Fees for Certification Services); and

(7) submit fingerprints in accordance with §232.35(c) of this title (relating to Submission of Required Information) and the Texas Education Code, §22.0831.

(c) School districts that recommend educators for visiting international teacher certificates agree to provide the visiting international teachers with intensive supervision consisting of structured guidance and regular ongoing support through a mentoring program.

(d) The Texas Education Agency (TEA) staff shall establish reasonable procedures to implement this section.

(e) The visiting international teacher certificate is valid for three years and may be extended two additional years, for a maximum total of five years, for all candidates actively enrolled in and in good standing with a Visiting International Teacher Program as verified by the employing school district.


(f) Issuance of a visiting international teacher certificate does not prohibit issuance of a one-year certificate following a successful review of credentials, as specified in Chapter 245 of this title (relating to Certification of Educators from Other Countries).

Who is eligible for a VIT certificate?

J-1 Visa Visiting International Teachers

- Who are actively enrolled with a J-1 Visa Exchange Visitor Program
- The J-1 Visa Exchange Visitor Program must be officially approved by the United States Department of State and TEA office of Educator Preparation and Certification.

*Out-of-Country certified educators who are **not** actively participating in a J-1 Visa Exchange Visitor Program are <u>**not**</u> eligible for the VIT certificate. J-1 Visa Visiting International Teachers

- Who have been issued an initial visiting international teacher certificate valid for three years.
- Who are actively enrolled and in good standing with a Visiting International Teacher Program as verified by the employing school district.






How to request a new user (TEAL) account

VIT applications are submitted online via the Educator Certification Online System for Entities (Green Screen).

School district personnel will need ECOS Entities access to submit the VIT application.



VIT initial and extension applications are submitted on behalf of the educator by the employing school district. Only approved partnering school districts have access to the VIT application. If you do not have access to view the VIT options, please submit a help desk ticket to <u>Educator Certification</u>.




Visiting International Teachers are expected to upload a copy of their DS-2019 or Good standing letter directly to their educator account.







Application Process Overview






Frequently Asked Questions

TEAL Account set up?	• Educators are encouraged to create their own TEA Login account. Educators must first obtain their social security number before setting up their TEA Login.
Educator process?	• Educators are expected to pay the application and fingerprinting fees via their online account. The educator will be able to pay application fees and schedule their fingerprinting appointment as soon as the VIT application is submitted online.
School Districts process?	 School district staff is responsible for submitting the VIT application online. VIT Applications should be submitted as soon as possible to avoid late issuance of the educators VIT certificate.
Extension process?	 VIT extensions are also submitted online. To be issued the VIT extension, educators must upload a current copy of their DS-2019 or Letter of Good standing provided to them by their program sponsor.
Eligible for a VIT extension?	• The maximum limit on a VIT certificate is 5 years. The VIT certificate is effective once issued and will expire, used or not. The applicant must be actively enrolled in the visiting teacher program
Out-of-Country Review of Credentials process?	 Out-of-country applicants who are applying for a review of credentials independently of a teacher exchange program should follow the application process outlined for <u>Out-of-Country certified</u> <u>educators</u>.
Name Corrections?	• Educators may upload a copy of their current passport or state ID directly to their account. TEA Staff will correct the educators name at the time the VIT application is processed.
