


Accountability System Updates

The A–F system remains the same for 5 years.



We don't keep changing the bar. The design remains unchanged in most years to allow year-over-year comparison. But we continuously receive feedback on how to improve the model, so we make design

each of the A-F domains remain the same.

In **2025**, the *A–F* Accountability System remains the same and a re-adoption of the manual from 2024 ratings is proposed.



As announced in the <u>January 9th To the Administrator Addressed</u> correspondence:

There are no proposed changes to cut points, domain, or indicator methodology for 2025 accountability ratings

- 2025 Accountability Ratings will use the manual as adopted in May 2024
- The Public Comment period for a re-adoption is open until February 10

■ The manual will be effective in Spring 2025

Previously adopted upgrades go into effect in 2025



There are <u>previously adopted</u> ongoing updates in effect in 2025 Accountability for the Class of 2024:

- Lists of Approved IBCs for CCMR (same lists as 2024)
 - Earning* an approved IBC from v2 (2019-2022) or v3 (2022-2025) list receives CCMR credit on 2025 accountability. This is the last year to report v2 IBCs. v2 IBCs are subject to a sunsetting limit.
- Phase-In of Aligned Programs of Study Requirements for CCMR
 - The earning of an approved IBC also requires earning credit in at least one level
 2 course in the career and technical education program of study aligned with that IBC.

A–F Accountability rule adoption for **2026** is occurring earlier than for previous accountability rule adoptions



As announced in the <u>January 9th To the Administrator Addressed</u> correspondence:

■ The proposed rules for 2026 Accountability Ratings will feature minimal changes, as part of the 5-year A-F refresh schedule commitment.

The Public Comment period for the rule will begin in April 2025

■ The manual will be effective in mid 2025

Previously adopted upgrades go into effect in 2026



There are <u>previously adopted</u> updates going into effect in 2026 Accountability for the Class of 2025:

- List of Approved IBCs for CCMR
 - Earning* an approved IBC from only list v3
 (2022-2025) receives CCMR credit on 2026
 accountability.
- Phase-In of Aligned Programs of Study Requirements for CCMR
 - The earning of an approved IBC also requires earning <u>Concentrator</u> in aligned program of study in the career and technical education program of study aligned with that IBC.

Previously adopted upgrades go into effect in 2026



There are <u>previously adopted</u> updates going into effect in 2026 Accountability for the Class of 2025:

- Phase-In of College Preparatory Courses taken in 12th grade only for CCMR
 - Only courses taken in 11th grade or 12th grade receives CCMR credit on 2026 accountability. This is the last year before courses must come from a TEA approved course list.

Completion of an interest form indicates that a provider is aware of the need to apply by January 31st, 2025.

A list of institutions, ESCs, programs and partnerships that have completed an interest form to apply for TEA's CCMR accountability consideration is now available on the TEA College Preparatory Course website.

Deadline for College Preparatory Courses for CCMR Accountability Provider Applications is due January 31, 2025.

Minor adjustments to be implemented in 2026



For 2026 Accountability, the following minimal changes will be proposed. Both changes were planned-for and announced during the 2023 refresh:

- Measuring Progress to Achieving EL Proficiency: Return to Composite Scores
 - The methodology adopted in 2024 remains the same for 2025. New methodology with new composite-based targets are proposed for adoption in 2026, providing 1 year's advanced notice.
 - The methodology and targets are open for Public Comment on the Every Student Succeeds Act (ESSA) webpage.
- Military Enlistment: Sourced from Department of Defense
 - The data source (DD Form 4) adopted in 2024 remains the same for 2025. A new data source is proposed for 2026, with no proposed changes to cut points.
 - A December 2024 To The Administrator Correspondence announced this data agreement.

Future IBC Rule Updates

Not all Programs of Study and not all IBCs are equal:

We must ensure we are supporting more students to reach the highest value career preparation



For the upcoming A-F refresh, we are exploring differential weighting for pathways, based on these three possible criteria:

In-Demand

- Greater than statewide median growth (17%) or greater than 10k jobs
- More than 500 annual openings

High-Wage

 Greater than median annual salary (\$46,909)

High-Skill

 Bachelor's degree or industry core certification For the upcoming A-F refresh, we are exploring differential weighting for IBCs, based on their usefulness in industry. An example:

Narrow welding skill



AWS D1.1 Structural Steel Student will demonstrate ability to weld carbon and low-alloy metals

(Core skill: Straight Line Weld)

Broad-based welding skills







AWS Certified Welder

Includes performing welding procedures such as fit-up, assembly and positioning; following safety protocols; identifying proper welding materials; and discerning the right welding position.

IBC Evaluation Criteria



- The agency has recently posted for public comment proposed updates to 19 TAC §74.1003 which is the rule governing how IBCs are evaluated.
- The proposal includes establishing tiers for IBCs.
- The proposal sets a cadence for the IBC list to be reviewed and updated every five years beginning in 2028, to coincide with the A-F refresh schedule.
- The proposal updates IBC evaluation criteria; must be a certification or license, industry recognized and valued, attainable by a high school student, portable, and offered as a capstone or at the end of a program.
- If adopted, tiering would not begin impacting A-F ratings before the next refresh.
- More communication will be released to support planning this fall.
