What is the CCMR Tracker?

The CCMR Tracker provides districts with a means to track CCMR indicator completion throughout high school for students reported as enrolled in grades 9–12 on the TSDS PEIMS October snapshot date.

The CCMR Tracker has 2 parts:

Part I: Released March 29, 2024

CCMR outcomes reported though TSDS PEIMS, TSIA results, and OnRamps course completion through the 2022–23 school year; SAT, ACT, AP, IB and level I/II certificate results though the 2021–22 school year

Part II: Released July 26, 2024:

CCMR outcomes for SAT, ACT, AP, IB, and level I/II certificates through the 2022–23 school year

Background

The CCMR Tracker is a tracking tool within the <u>TEA Login (TEAL)</u> Accountability application. This tool provides districts with an early preview of CCMR status for students who are in grades 9–12 during the 2023–24 school year. The CCMR Tracker contains lagging data as is detailed in the chart below. While the Tracker contains students who were in grades 9–12 on the 2023–24 PEIMS snapshot, the 2024 version does not contain results from school year 2023–24 as those data have yet to be reported.

Indicators are credited if earned within date ranges provided below for students beginning with grade 9 enrollment. TSI assessments are the only CCMR indicator that may be earned prior to grade 9. Indicators reported upon graduation (IEP and workforce readiness graduates and special education graduates with advanced diploma plan) do not appear in the Tracker.

The CCMR Tracker is for informational purposes only and as such corrections cannot be submitted to TEA. If districts find errors, they are encouraged to work with testing vendors to make corrections prior to the student's graduation. When TSDS PEIMS data are submitted they are considered final.
